The government has targeted buying six lakh tonnes of Boro rice from the domestic market at Tk 29 a kg from June 5 to September 30.

But unlike in the previous years, it will not buy paddy from the farmers due to lack of adequate storage facilities required for this.

Food Secretary Barun Dev Mitra said this while talking to journalists at his office yesterday.

Production cost of Boro paddy this season is Tk 14.65 a kg as estimated by the agriculture ministry. Procurement price of rice has been fixed taking into consideration milling cost and 25 percent benefit, he said.

Public procurement of Boro rice used to start in mid-April in the past, but this time the government delayed the process

Weather cycle goes normal

Favourable climate contributes to bumper food production, pleasant summer

With the southwest monsoon blowing in, the mercury has significantly dropped giving people a break from summer heat and boosting hope for the country's agriculture, say meteorologists.

The southwest monsoon, also known as wet monsoon, lasts from early June to mid-August, influenced by a seasonal wind that blows from the Indian Ocean over the country causing a lot of rain.

The summer is usually hot coupled by intense humidity. But in this April and May, the temperature was much tolerable, to some extent soothing. The mercury has so far shot up to 37.5 degrees Celsius once in Iswardi where it generally goes as high as 39 degrees Celsius.

Citing the dry spells of the last two years, the met office said this year the number of rainy days across the country was normal.

In May, the rainfall was only 4.5 percent less than that is normal for the month. The silver lining is that the rainfalls SEE PAGE 19 COL 5
