Justice delayed is justice denied

No charge sheet yet a year into Sylhet CBA leader murder

Police could not file charge sheet nearly one year into the killing of Abu Taher, president of the ruling Awami League-backed CBA of Jalalabad Gas Transmission and Distribution Ltd.

There are allegations that investigators could not proceed much in fixing the charges due to alleged involvement of the ruling party backed men with the murder.

Police officials claimed the investigation is going on rightly while a source requesting anonymity said the case may be shifted to the Criminal Investigation Department (CID) from the Detective Branch as the


only by two votes. Taher was hacked to death when he was on the way to his office on a motorbike in the morning on June 10 last year. Joint secretary of the CBA-Fazlul Bari Didar was also on

"Two motorbike riders stopped us at Rainagar while another bike was following, minutes after our start from the Jalalabad Gas staff quarters. They hit Taher with iron rods and stabbed him severely. I could not identify the attackers," Didar, who was also injured during the incident, told the police and newsmen at the hospital that day.

After the killing, Taher's wife and daughter told the newsmen that people in the CBA were involved with the killing as Taher did not agree with some of the wrongdoings at the office and in the CBA. Things were clear from telephonic conversations days before the killing, they said.

"Weeks before the murder,

Taher had played a role in transferring several employees and taking some important decisions at the office, much to the dissatisfaction of a section of staff," said Taher's wife Afroza.

But the woman, now visibly frustrated, is reluctant to say anything over the gruesome killing of her husband. "We do not want to say

anything about the murder. Let Allah see everything," Afroza told this correspondent a few days ago. Taher started working to

make things well against the backdrop of huge irregularities in the gas office by the previous regime's CBA, said a few people close to him.

Just after Taher's murder, police got some clues to it, but they are in great trouble due to pressure from ruling party men, sources claimed.

Contacted, the Deputy Commissioner of Sylhet Metropolitan Police Rezaul Karim said a few days ago, "The investigation is in progress. On the basis of confessional statement before the magistrate's court by one of the four people arrested earlier, four others are wanted as yet. We are considering the case as very important and dealing it carefully."

"Clique over the CBA election and internal feuds had led to the murder. Taher also faced the wrath of some of his colleagues and officials, as he was against some activities at the office. We are trying to unearth the mystery and arrest the rest of the killer suspects, before filing the charge sheet. It may take some more time," said the investigation officer Inspector Abdul Awa Chowdhury of the Detective Branch.

9 chairman, 15 member candidates fined

Mobile courts fined nine chairman and 15 member candidates and sentenced three others to jail in Kishoreganj and Joypurhat districts yesterday and on Sunday night for violating

election code of conduct. Our Kishoreganj correspondent reported that a mobile court led by Nikli Upazila Nirbahi Officer (UNO) Md Fazlur Rahman, on Sunday night fined eight UP chairman aspirants Tk 2,000 each and 15 member candidates Tk 1,000 each for

pasting posters on walls. All the eight chairmen candidates are in the election race in Nikli Sadar Union. They are Md Sajedul Islam, Md Asmat Ali, Amirul Ali Mamun, Dr Kafil Uddin, Md Akter Hossain, Borhan Uddin, Md Iftekher Ahmed Arif and Sultana Kamal.

In Joypurhat, a candidate contesting for the post of chairman of Puranpoil Union Parishad under Sadar upazila was fined and three of his supporters were sentenced to jail for violation election rules, reports our Dinajpur correspondent.

Acting on a tip-off, a mobile court led Executive Magistrate Ramendra Nath Biswas went to Bankhur village under the union yesterday morning and arrested three supporters of chairman candidate Nikhil Chandra Mondol while they were distributing money among the voters.

The court sentenced the three--Nahid Hossain, Shafiqul Islam and Al Helal-to 15 days imprisonment

The mobile court also fined Nikhil Chandra Mondol Tk10,000 as he engaged the three in such illegal act, police said.

MMCH interns continue strike

Interns at Mymensingh Medical College and Hospital (MMCH) continued their indefinite strike for the third day yester-

The interns went on strike on Saturday morning protesting alleged attack on their colleagues by the relatives of a patient on Friday.

Sources said, Divya Joyati Saha, 13, a class seven student of Baro Bazar area in the district town was admitted to the hospital's ward 14 on June 1 with bronco pneumonia.

But the relatives of the patient took him to a paying bed at ward 19 defying the instruction of the on-duty doctors, sources said. The patient's condition was not well and at around 5:30pm,

Divya Joyati Saha died of his complications at ward 19.

After sometime, relatives of the patient with the help of outsiders swooped on the interns and assaulted a few of them.

Meanwhile, handling of huge rush of patients at the hospital yesterday turned into a hard task for the doctors and

About 180 interns used to work at different wards of the hospital with senior doctors. But the absence of interns is now putting a huge pressure on them, said a nurse at medicine ward of the hospital.

Patients at medicine, labour and paediatric wards suffer a lot during any stirke, said a nurse at labour ward. A Friday's attackers and tightening of doctor at paediatric ward admitted to

this correspondent that ethically doctors should not announce such a tough programme. Meanwhile, the striking interns

under the banner of Interns' Chikitshak Parishad (Ichip) yesterday held a press confernece at the doctors club.

At the press conference, they alleged that at least five doctors were assualted by the outsiders and patient's relatives.

They also vowed that they would not join duties until their five-point demand is met.

Later, they formed a human chain and brought out a silent procession yesterday to press home their demands.

The demands include punsihment to security of interns at the hospital.

Scores more injured in post-UP poll violence

At least 85 people, including 12 members of law enforcement agencies, were injured in post-UP poll violence in Sirajganj, Gaibandha and Thakurgaon districts on Sunday night.

Our Sirajganj correspondent reported that three separate incidents of violence in Sadar upazila left at least 50 people, including the officer-in-charge of Ullapara Police Station and four Rab members, injured. Of the injured, 20 includ-

ing Ullapara OC Tajul Huda and four Rab men, were admitted to Sirajganj General Hospital.

Police said the first incident occurred at Harina Hata polling centre in Bohuli Union where the supporters of two defeated member candidates clashed after counting of votes. At least 15 people from both sides were injured during the clash. Police fired 22 rounds of rubber bullets to bring the situation under control. Later, the unruly mob

attacked the law enforcers who were carrying ballot boxes to upazila headquarters, leaving at least 20 people, including four Rab members, injured. Another incident took

place at Golami Dumur polling centre in the same union where the supporters of two chairman candidates locked in a clash after counting of votes. The clash left at least 15 people from both sides injured. In Gaibandha, post-

election clashes left at least 20 people, including two cops, injured in Sunderganj upazila. After counting of ballot

papers at Bazra Kanchibari Govt Primary School centre in Kanchibari Union, the presiding officer of the centre along with police was

going to Sunderganj upazila headquarters in a microbus to deposit the ballot boxes.

When they reached Char Masjid area of Bazra village, thousands of supporters of a defeated candidate waylaid the microbus, swooped on the presiding officers and law enforcers and snatched a Chinese rifle from a cop.

As they tried to snatch ballot boxes, police fired 40 rounds of blank shots and four rounds of tear gas sells to disperse the unruly people. During the clash, seven people, including a constable, sustained injuries.

Police and arrested five people but could not recover the rifle as of 6:00pm yesterday.

At Gopal Charan Govt Primary School centre in Dahabandh Union, the supporters of defeated member candidate Yunus Ali attacked polling officers and policemen soon after the announcement of election results. presiding and polling officers. Police arrested defeated member Rafiqul Islam and his three supporters, Jewel, Enamul and Kajol on the spot.

In Khagrachhari, five policemen were injured in post-UP poll violence at Birshrestha Munshi Abdur Rouf High School centre of Maischhari Union under Mohalchhari upazila on Sunday.

The injured cops are Sub-Inspector Abdullah Al Harun, Nayek Ashraf Ali, and constables Ismail Hossain, Ripon Mia and Suhrawardy . They are undergoing treatment at Khagrachhari Adhunik Sadar Hospital.

Officer-in-charge (OC) of entered the centre and Mohalchhari Police Station said the criminals attacked the policemen in a bid to snatch ballot boxes from the centre. Later, police arrested six

For all other certificates equivalence will be determined by the Equivalence Committee of IBA. Foreign applicants with a score of 650 or more in GMAT (with minimum 30 percentile in verbal and 50 percentile in quantitative) may be exempted from the Written Test. However, they will be required to appear for an interview.
