Police-student clash in Barisal: 20 hurt

Textile engineering college closed till June 18; 350 students sued; 13 arrested

Twenty people including a teacher, four policemen and 15 students were injured in clashes between students and police on the campus of Barisal Shaheed Abdur Rob Serniabat Textile Engineering College yesterday morning.

The college authority closed the institution till June 18 and asked the students to vacate the hostel by afternoon, said Abdus Salam Shikdar, principal of the college.

against 350 students and arrested 13 as of filing this report, said Zahangir Hossain, officer in charge of Barisal Kotwali police station.

Students of the textile engineering college in Barisal city organised agitation programmes on the campus to press home their demand for continuation of diploma engineering course at the college, arrangement for adequate appointment in government services and 30 percent quota for the diploma holders in BSc engineering course.

They held a peaceful rally on the campus and formed a human chain beside the adjacent road at about 8:00am. But some of the students suddenly started ransacking rooms of the college and vehicles on the road in front of the campus and tried to lock the academic and administrative sections of the college and block the road by felling logs,

said police and witnesses. Police interfered and brought the situation under control by charging baton, firing three rounds of rubber bullets and nine rounds of tear gas cells at around 9:00am, said Syed Taufiquddin Ahmed, commissioner of Barisal Metropolitan Police.

At least 15 students, a teacher named Shahidul Islam and four policemen including Assistant Sub Police lodged a case Inspector Mohiuddin and Saidul Islam and Sree Sajal

Post-UP poll violence leaves 30 injured in 3 districts

Post-UP poll violence in Thakurgaon, Natore and Chapainawabganj districts left at least 30 people injured yesterday and on Wednesday night.

Our Thakurgaon correspondent reported that at least 10 people, including a presiding officer and two Ansars, were injured as the supporters of a defeated member candidate attacked election officials and on-duty Ansars after announcement of results at Vedail Primary School polling centre in Rator union under Ranishankoil upazila on Wednesday night.

After announcement of results by Presiding Officer Moniruzzaman at around 9:00pm, the supporters of defeated member candidate Nasirul Islam,45, rejected the results and demanded recounting of votes.

As the presiding officer refused to accept the demand, the supporters of Nasirul swooped on him, polling officers and Ansars, leaving 10 people, including the presiding officer, two Ansars, injured.

On information, striking force went to the spot and arrested defeated member candidate Nasirul, Kamal Hossain and Khairul Islam.

Later, Judicial Magistrate Fahim Faisal sentenced Nasirul Islam, 45, son of late Akhter Uddin of Vedail village, to one year's imprisonment, and Kamal Hossain, 25, son of late Yunus Ali of the same village, to three years imprisonment for violating election code of conduct. They were sent to Thakurgaon jail.

Another arrestee, Khairul Islam, 25, son of Abu Bakkar of the village, was sued for assaulting the presiding officer. A regular case was filed against him. He was sent to jail hajat.

In Natore, the supporters of two defeated chairman candidate--Akram and Noyez Uddin--clashed in Paka Union under Bagatipara upazila at around 2:00pm yesterday, leaving at least 12 people from both sides injured.

Police went to the spot, dispersed the clashing groups and brought the

situation under control.

Of the injured, Mozam Ali, Joy Mia, Ramjan Ali, Hannan, Saiful Isalm, Aloka, Mukti, Fazlul Haque and Nizam Uddin were admitted to Lalpur Upazila Health Complex. Fazlul Haque was later shifted to Rajshahi Medical College and Hospital as his condition deteriorated.

In C'nawabganj, four people were injured and three shops ransacked during post poll clashes in Gomostapur upazila on Wednesday night, reports

Police said supporters of chairman--elect Shahidul Islam of Bangabari Union Parishad and defeated chairman candidate Sadirul Islam clashed, leaving three people injured from both

Being informed, upazila nirbahi officer (UNO) along with BGB members went to the spot and brought the situation under control.

In another incident, a supporter of a defeated chairman candidate was injured by his rivals at Boalia Union.

DEATH THREAT TO CARMICHAEL COLLEGE PRINCIPAL

27 Shibir men picked up, 16 shown arrested

Police picked up 27 leaders and activists of Chhatra Shibir from different places of the district town early yesterday in connection with a case filed for alleged death threat to the principal of Carmichael College

Prof Dipkendra Nath Das. Police said 16 of them including Shibir district unit president Abu Taher and city unit secretary Moshtaque Hossain were shown arrested in the case lodged by the principal.

Police picked up the shibir men, raiding different parts of the town after two unidentified people fired two blank shots behind the principal's residence on the college campus on Tuesday night.

Contacted, the principal said Shibir cadres might have fired the blank shots to create panic. "They wanted me to withdraw the "We are quizzing the rest case I lodged against 80

of the Shibir men. If we find Shibir leaders and activists a few days ago."

A number of Shibir leaders and activists threatened the principal with death as he refused to reopen the college hostels which have remained closed for the last three months.

The academic council and Employees Association of Carmichael College formed a human chain on the campus at around 11:00 am yesterday demanding arrest of the Shibir cadres who had threatened the principal with death.

9 get life for killing schoolboy

Nine people were yesterday sentenced to life imprisonment for killing a schoolboy in Muktagachha upazila in 2006.

The lifers are Saiful Islam, Anisur Rahman, Piyash Pal, Razib Chandra, Shariful Islam, Jamal Uddin, Delwar Hossain, Pankaj Kumar and Shariful Islam alias Shohag. The court also fined the

tion, the convicts killed Ratan Kumar Saha, 14, a class nine student of a local school, at Muktagachha upazila headquaters at around 8:00pm on September 9, 2006 as a sequel to previous enmity.
