More power by August

6 rental plants ready to roll; defaulting Cos pay Tk 210cr fine

The electricity shortfall is likely to reduce dramatically by August as six rental plants move to operate commercially.



"By August, we expect to achieve a new benchmark of power generation -- 5,000 megawatts," said a top official.

Presently, the Power Development Board (PDB) is generating around 4,500 MW leaving a shortfall of minimum 1,000 MW.

Of the six rental plants with generation capacity of 371 MW, three will start contributing to the national grid this month. All the rental plants will operate for three to five years.

Rental plants apart, three public sector peaking power projects, with production capacity of 150 MW, will start to deliver within three months. These plants in Daudkandi, Baghabari and Faridpur are expected to run for 15 years.

AL open to remodelled caretaker system

Insists on talks with opposition for next two polls

Ruling Awami League stands open to holding next one or two parliamentary elections under non-partisan caretaker governments, but insists that the parliament has to devise a new formula in line with the Supreme Court verdict.

To AL the current constitutional provision of the caretaker government system has been dead since it was voided by the country's highest

court in May.

At the same time the party is ready to accept a new model of election-time caretaker administration, and wants its main rival Bangladesh Nationalist Party to debate the issue in parliament to reach a consensus.

"Both the government and our party are soft on dialogue with the opposition on this issue," said AL Presidium Member Obaidul Quader adding that nothing one-sided will be done in the next election.

"A political consensus is a must to hold the next two elections under a new caretaker government system," he said. The current system will not be there as AL stands by the SC verdict that declared it unconstitutional, Quader told The Daily Star.

He said if BNP gives any proposal, AL will also reciprocate with its own idea. "If their [BNP's] proposal proves more logical than ours, we may even accept their idea," added

Hartal ends 2-day agitation to follow

Law enforcers arrested dozens of opposition men and mobile courts jailed several persons on charges of attacking vehicles and disrupting public life on the last day yesterday of the 36-hour countrywide hartal called by the BNP-led opposition.

The nationwide hartal or general strike enforced by BNP and its key ally Jamaat-e-Islami to press for continuation of the constitutional provision of holding parliamentary elections under a caretaker government passed off without any major violence.

Both the parties yesterday simultaneously announced a two-day demonstration from tomorrow protesting arrest and punishment of party workers in summary trials by mobile courts, and demanding release of the arrested.

BUMPER HARVEST Slight drop in food inflation

Inflation edged down 0.47 percentage points to 10.20 percent in May thanks to a dip in rice prices following bumper boro harvest.

Food inflation declined to 13.16 percent in May from 14.36 percent in April, when the overall inflation hit at 10.67 on point to point basis, the highest in more than two years since the food price hike in 2007-08.

Meanwhile, non-food inflation rose to 4.78 percent in May from 3.97 percent in April due to hike in fuel prices by the government early last

Fish, vegetables get pricier

Traders blame it on supply disruption during hartal

Consumers had to pay more for fish and vegetables in the last two days for a disruption in supply in the capital during the opposition-enforced 36-hour shutdown, retailers said yesterday.

Prices of hilsha soared to Tk 600-700 a kilogram from Tk 500-600, and ruhi to Tk 200-250 from 180-220 a kilogram over the last two days, said the Trading Corporation of Bangladesh.

"There has been a shortfall in



supply. Many trucks could not reach the market from the fish hubs for the hartal," said Gautam Das, a fish trader at Karwan Bazar.

Gautam yesterday sold a 700-

gram hilsha for Tk 400 that was Tk 350 last week. He bought four hilshas for Tk 1,400, upped by Tk 200 from the previous week, said the trader.

He said a fall in supply caused

prices of ruhi and katla to go up.

Gautam this week bought a kg of ruhi at Tk 240, which was Tk 220 last week.

Shrimp also became costlier in the last two days. However, prices of cheap fish such as pangash remained unchanged.

The strike from early Sunday also contributed to a hike in vegetable prices.

Launch fares to rise up to 20pc

Rate to be re-fixed today amid fuel price hike

According to proposed fares, launches will charge each passenger Tk 1.30 per kilometre instead of Tk 1.18 for the first 100 km. If anyone travels more, the passenger will have to pay Tk 1.00 per km, which was Tk 0.88 previously.

The shipping ministry will finalise the new fares today after scrutinising the fares proposed by an eleven-member committee. The body was formed on June 2 to re-fix the fares of passenger vessels plying different inland river routes.

The minimum fare has been increased from Tk 10 to Tk 12, said an official of the Bangladesh Inland Water Transport Authority (BIWTA).

The government decided to raise the
