## Relocate generator, boiler to save lives

HC asks Gazipur garment factory

The High Court yesterday directed the authorities concerned to relocate the generator and boiler of a garment factory at Baniarchala in Gazipur within three months to save lives of people and environment.

In response to a writ petition, the court also directed the director general of the Department of Environment not to issue environmental clearance certificate to the garments factory --AMC Knit Composite -- until further order.

An HC bench also issued a rule upon the authorities concerned of the government and the garments factory to explain within four weeks why they should not be directed to shut operations of the garments factory without having the environmental clearance certificate.

The bench of Justice AHM Shamsuddin Chowdhury Manik and Justice Gobinda Chandra Tagore passed the order and issued the rule following the writ petition filed by Bangladesh National Woman Lawyers Association (BNWLA).

BNWLA recently filed the petition as public interest litigation saying that the generator and boiler of AMC Knit Composite are polluting sounds and air at Baniarchala, where a shelter home for the people with disabilities is situated.

The challenged people are suffering from the pollution caused by the generator and boiler of the factory, it said.

Advocate Iqbal Kabir Lytton appeared for the petitioner, while Deputy Attorney General ABM Altaf Hossain represented the government.

## Stop Jugitala hill cutting : HC

The High Court yesterday directed the government to take steps to stop cutting Jugitala Hill at Amborkhana in Sylhet.

Delivering a verdict on a writ petition, the court also ordered the authorities concerned to take necessary steps to protect the hill from cutting and encroachment.

The HC bench of Justice AHM Shamsuddin Chowdhury Manik and Justice Gobinda Chandra Tagore delivered the verdict after hearing a writ petition filed by Bangladesh Environmental Lawyers Association (Bela).

The organisation filed the petition as public interest litigation on June 29, 2009 stating that one Abdul Awal has initiated to cut Jugitala Hill damaging the environment.

The petitioner sought HC directive on the authorities to stop cutting of the hill and protect it.

The HC on the same day issued a rule upon the government and Abdul Awal to explain why they should not be directed to stop cutting the hill and to take steps to protect it.

Advocate Iqbal Kabir Lytton appeared for Bela, while Deputy Attorney General ABM Altaf Hossain stood for the government.

## Three commit suicide in city

A housewife, a rickshaw puller and a schoolgirl allegedly committed suicide in separate incidents in the city yesterday.

Police said housewife Nusrat Jahan Pinki, 36, committed suicide by drinking poison at her house in the city's Dhanmondi.

Her husband Akbar Hossain said Pinki locked herself in her room and took poison following an altercation with him.

They broke open the door and rushed her to Dhaka Medical College Hospital (DMCH) where doctors declared her dead around 1:15am.

The rickshaw puller Saiful Islam, 25, committed suicide by hanging from ceiling with a scarf in the city's Rayerbazar area.

His wife Rahima Begum said Saiful locked her out of their house at Zafarabad following a row with her. In the morning, neighbours broke open the main door and discovered him hanging.

Police sent the bodies to DMCH morgue for autopsy.

Meanwhile, a schoolgirl allegedly committed suicide by hanging from a ceiling fan in the city's Green Road yesterday afternoon.

The deceased Rabeya Akther Pinki, 14, was a class XI student of Rajdhani Girl's High School.

Police said Pinki hung herself from a ceiling fan in her room at their house at Mostafa Goli around 4:00pm following a row with her mother.

Police broke open the door and rushed her to DMCH where doctors declared her dead.

## BNP must sit in JS to place its demand

Says AL leader on caretaker issue

Ruling Awami League (AL) yesterday said opposition BNP would not be able to achieve anything on the caretaker government issue unless it sits for discussion in parliament with AL to realise its demand.

"Please join parliament for discussion. There will be all out support from us," AL Joint General Secretary Mahbubul Alam Hanif said at a press conference at AL President Sheikh Hasina's political office in Dhanmondi.

## 'Portray Gaziul Haque's struggle in textbooks'

Speakers at a discussion urged the government to include the lifelong struggle and ideology of Language Movement veteran Gaziul Haque in school textbooks.

They said Gaziul Haque struggled throughout his life against injustice and repression of autocratic rulers to establish the nation's rights.

They were speaking at a memorial discussion organised by Amra Surjomukhi, a pro-liberation organisation, in the city's National Museum auditorium marking the language movement's second death anniversary on Sunday.

Addressing the programme as the chief guest, lawmaker Suranjit Sengupta said Gaziul Haque was "heroic and innovative".

Replying to a query, he said no violation of human rights occurred due to punishments given by the mobile court during the hartal.

On BNP's threat to enforce more hartal, he said no such situation has been created in the country for which the opposition should go for longer-period hartal.

On Home Minister Shahara Khatun's comment that AL would not call hartal if it becomes the opposition in future, Hanif, also a special assistant to prime minister, said it was Shahara's own view, not the party's.
