lished a circular in a local newspaper asking the Bangladeshi migrants not to pay any money to the brokers. He said some companies

would be commissioned to do the registration work but the Malaysian government has yet to announce their names. There are an estimated 5 lakh Bangladeshis in Malaysia

and over 3 lakh are believed to be irregular who have been facing threats of arrest and deportation. They have long been waiting for the chance of amnesty or regularisation, said the councillor.

Malaysia on June 22 officially announced that the government will do registration of the irregular foreign workers in two weeks' time from July 11. The migrants, who get registered in the period, will be regularised or repatriated as per their wish within next six months.

For not getting registered within the deadline, workers will face punishment, said Mahmood Adam, secretary general of Malaysia's home ministry, on June 23 as reported online newspaper malaysiakini.com.

He said the registration will be free and it would be unlawful for any agents or employers to charge the immigrants. He, however, said employ-

ers have to pay for work permits of their workers. To ensure that the immigrants are not made to pay the money the government would pursue various engagement processes with employers.

Hope for talks

avert a possible political turmoil in the coming days but they cannot raise their voices within their parties fearing they might be misunderstood by others as paranoia has grown in the parties during the last emergency period.

The leaders strongly believe that the chiefs of Awami League and BNP are not well advised by leaders they rely on. "Negotiations should

immediately start between the two camps behind the scenes, if it is not possible to hold formal talks right now. The nation will be gripped by another political turmoil if things go unbridled like this," a senior Awami League leader told The Daily Star last week.

Echoing the same, a BNP policy maker said the door for talks should never be closed. If the door is closed, politics will be on the streets hampering people's lives, he said. Amid such a situation,

Law Minister Shafique Ahmed is scheduled to place in parliament today the much-talked-about constitutional amendment bill proposing changes in the country's charter including scrapping of the provisions for the caretaker government system, sources in the Parliament Secretariat said. After the bill is placed, it

will be sent to the parliamentary standing committee on the law ministry for scrutiny, opening a window for holding talks between treasury and opposition bench lawmakers at the committee level.

However, BNP's representative to the committee Salauddin Quader Chowdhury is behind bars on charge of war crimes and the party has not namedasubstitute.

"If they write to the leader of the House proposing the name of a party MP to be included in the committee in place of Salauddin, it is possible to reconstitute the committee without any difficulty since the House is now in session," committee chief Suranjit Sengupta said.

On proposing an MP for the standing committee on the law ministry, BNP policy maker Moudud Ahmed, however, said they will not choose another MP. "Who will listen to the opposition's voice? They will not pay any heed to our proposals. So we are not considering it," Moudud said.

Parliamentary affairs experts said it is possible to forge a consensus on a new model of the caretaker gov- 22, Paglee, 30, Momtaj, 40, ernment system, if they want it, and changes could be brought to the bill. The experts said the ruling and the opposition MPs often reach a consensus on various issues at committee level discussions.

But for this both sides should reach a political understanding outside of the committee, they observed.

BNP lawmakers regularly join different committee meetings even though they remain absent from House proceedings. But if the ongoing political situation remains unchanged, possibility of the opposition's return to the House is very slim.

"Yes, the committee can work as a platform to reach a consensus between the ruling and opposition parties. In that case, the opposition should come to the House or the committee with an open mind to discuss the bill," Suranjit Sengupta told The Daily Star Wednesday.

Suranjit said political consensus is necessary to reintroduce the caretaker government system after its nullification by the Supreme Court.

Asked whether the committee will invite BNP for its opinion on the proposed changes to the constitution, Suranjit said the committee may discuss it at the meeting. If its members want, they may invite the BNP to send a delegation to the committee to express their opinion on the bill, he said.

Talking to The Daily Star over the telephone Thursday, Moudud Ahmed brushed aside any possibility of joining the committee meeting during scrutiny of the bill or the House during passage of the proposed legislation.

"We don't want to be part of the process of legalising the amendment to the constitution. Is there any instance of changing a bill which was approved by the cabinet at the committee?" asked Moudud, also former law minister.

"We see the demise o democracy in the country,"

he said. Talking to The Daily Star on condition of anonymity, a senior BNP leader said the BNP chief may take a more tough stance against the government after her son's conviction in a money laundering case. The Supreme Court on

May 10 prospectively declared the caretaker government system unconstitutional and void, but observed that the system might be used for holding two more general elections for the sake of "safety of the state and its people"--provided parliament approves it. Despite the court's ruling,

the parliamentary special committee on constitutional amendment was actually in favour of keeping the caretaker government system by bringing some changes to the provision. But the prime minister did not agree with the special committee's proposals.

In defence of the proposal for scrapping the provision, the government is depending on the Supreme Court verdict. The government seems to have started using the caretaker government issue to keep the opposition under pressure. The BNP seems to have

opted for waging street agitation against the government instead of trying to find a solution through talks. Prime Minister Sheikh

Hasina in June urged BNP to return to parliament to discuss any new formula for the caretaker government.

In response, Opposition Leader and BNP chief Khaleda Zia a few days later in a press conference said her party will sit with the government to discuss who will lead the next caretaker government if the government announces that the system will continue and the provision will be kept in the constitution as it is.
