Drug Addiction Law enforcers' failure blamed DBBL scholarships DRUG ADDICTION

Speakers at a discussion yesterday said drug addiction is slowly gripping the young generation of our country and the problem is becoming acute due to failure of law enforcers to eliminate illegal drugtrade. They emphasised the need to raise

awareness among parents and amend Drug Control Act to ensure highest punishment for illegal drug traders. The discussion titled "Our duty to

prevent crime and drug" was organised by Association for Law Research and Human Rights (ALERT) in the city's Cirdap auditorium. Addressing the programme, Rapid

Action Battalion (Rab)-3 Director Lt Colonel Rafiqul Islam said law enforcers could not stop spread of illegal drugs due

to some loopholes in Drug Control Act. "We arrest drug traders every month

but they get bail from court and start the business again," he said.

He also pointed out that law enforcers could not continue drives in full swing due lack of funding for informants. In many cases, law enforcers pay infor-

mants with a portion of the confiscated illegal drugs instead of money, which the informants ultimately sell, he added. The speakers stressed the need for

increasing manpower, modern equipment for Narcotics Control Department and campaign against illegal drugs to create awareness among adults.

Deputy Inspector General (Dhaka Range) of Police Asaduzzaman Miah said police often could not bring illegal drug traders under trial for their political

He said every anti-illegal drug organisation should come under a banner to build a strong platform against such influential drug traders.

He claimed that introduction of mobile courts for drives against illegal drug trade proved effective in stopping the trade.

Inspector General of Police Hassan Mahmood Khandker said police are trying to stop the trade and hopes that the government would take steps to provide police with modern equipment for such drives.

Home Minister Advocate Shahara Khatun said the government would hopefully be able to stop illegal drug trade soon.

ALERT Chairman Advocate Mohammad Jahangir Alam chaired the programme.

Bill placed in JS to scrap CG provision

tion lawmakers abstaining, Law Minister Shafique Ahmed yesterday piloted the 15th constitutional amendment bill but had to face the objection of independent lawmaker Fazlul Azim. Azim suggested that the

law minister withholds the bill and place it after getting the consent of all political parties. Mentioning the proposal for scrapping the provision for caretaker government system, the independent MP said if the bill is placed now, all the doors for talks with the main opposition will be closed.

In response, the law minister said Azim's demand was not based on facts. He said the 13th amendment to the

constitution that introduced the system, was scrapped by the Supreme Court.

The lone independent lawmaker's objection was rejected in voice vote and the bill was placed amid desk thumping of treasury With the BNP-led opposibench lawmakers.

The law minister, however, placed the bill in short notice after the speaker suspended the rules of procedure for placing the bill. The rules say that a lawmaker desiring to place a bill has to give seven days' notice so that all procedures could be completed.

The law minister sent the notice only Thursday noon.

The Parliament Secretariat could not complete printing the bill that is why it could not be placed Thursday night, officials in the Parliament Secretariat said.

Former BNP law minister Jamir Uddin Sircar also in a short notice piloted the 13th amendment bill that introduced the caretaker government system in 1996. He placed the bill the very day he sent the notice.

Meanwhile, the BNP-led opposition parties seem to have opted for street agitations instead of trying to negotiate with the government to resolve the dispute tary approval. while the ruling Awami League seem to be using the issue to keep the opposition parties busy and under pressure.

It is almost clear that the BNP-led opposition lawmakers will wash their hands of the passage of the 15th constitution amendment bill.

All this signals political unrest in the coming days if the bill is passed without the consent of the opposition. In defence of the proposal

tem unconstitutional and void, but observed that the system might be retained to hold two more general elections for the sake of "safety of the state and its people" --

BNP is saying that the constitutional provision for installing a non-partisan caretaker government to oversee general elections remains legal in spite of the recent Supreme Court verdict. It claims that the system will become illegal after the 10th and 11th parliamentary elections are held.

A special parliamentary body for constitutional amendment was formed on July 21 last year to aid the constitutional amendments. The 15-member committee, headed by Deputy Leader of Parliament Syeda Sajeda Chowdhury, has only Awami League-led ruling alliance lawmakers as BNP declined to nominate a representative.

After holding a series of meetings and consultations with political parties representing the current parliament and eminent jurists, personalities and editors of different national dailies, the special committee placed its report in parliament on June 8 with a 51point recommendation for changes to the constitution.


