## Karzai angered by Pak border attacks


Afghan President Hamid Karzai met the head of Pakistan's army yesterday and said he had demanded a halt to a series of crossborder rocket attacks that have caused a row between the two countries.

Relations between Afghanistan and Pakistan have long been strained over

mutual accusations of responsibility over Islamist militants fighting against both governments, particularly in the porous border area.

Karzai met General Ashfaq Kayani at his palace in Kabul shortly after a top Pakistani army spokesman admitted gunfire may have crossed the border, alleging that five "major attacks" launched from Afghanistan have killed 55 security personnel in a month.

A statement issued by Karzai's palace after the meeting said he "expressed concerns over the continuation of rocket attacks on the Afghan border region from Pakistan soil and demanded an immediate halt to



The palace claimed that Kayani had agreed to launch an investigation, but that could not be immediately confirmed.

Afghanistan last week said Pakistani artillery shelling killed four children on Thursday and warned that attacks from Pakistan could harm "improving trust and

cooperation".

Pakistani army spokesman Major General Athar Abbas earlier said he could not rule out that a "few accidental rounds" had been fired across the border by security forces targeting fleeing militants, but he cited his own casualties.

"In the last month, there have been five major attacks from Afghan side of the border where 250-300 terrorists crossed over and assaulted our border posts in Dir, Mohmand and Bajaur," he said.

The attacks resulted in the deaths of 55 paramilitary and pro-government tribal militiamen and wounded 80 others, according to Abbas.

## Bomb attack kills 25 in Nigeria

A bomb attack in the northeastern Nigerian town of Maiduguri has killed at least 25 people and wounded dozens, security sources

They say the attack, which occurred in a beer garden, was carried out by the Islamist sect Boko Haram.

The group wants to establish an Islamic government in Nigeria.

It has carried out a number of bombings in northeastern Nigeria earlier this month.

Gunmen on two motorcycles attacked a packed beer garden late on Sunday, officials said.

"The attackers believed to be Boko Haram members threw bombs and fired indiscriminate gun shots on a packed tavern at Dala Kabompi neighbourhood," a police officer told the AFP.

# indictments soon

Lebanese officials said yesterday they expected a UN-backed tribunal investigating the assassination of former prime minister Rafik al-Hariri to issue indictments soon.

The long-awaited indictments are expected to accuse members of Shi'ite group Hezbollah of involvement in the killing and have already triggered a political crisis which brought down the government of Hariri's son, Saad al-Hariri, in

January. Hezbollah, which denies any role in the 2005 assassination, and its allies resigned from Hariri's unity government just days before the tribunal prosecutor filed his indictments to a pre-trial judge on January 17.

The indictments, twice amended since then, have remained secret while the pre-trial judge assessed whether there was enough evidence to proceed with a trial.

A spokesman for the Special Tribunal for Lebanon declined to comment on reports in two pan-Arab newspapers that the indictments would be issued within two days. One of them, Asharq al-Awsat, said five Hezbollah members would be indicted.

Canadian Senator denies his role in the Niko graft

Harb, the focus of a breachof-trust investigation in his country, has denied using public office to influence the Bangladeshi government on behalf of Niko Resources.

The long-time Ottawa

politician issued a statement on the weekend saying he has never used his Senate post "for personal gain," following a Globe and Mail report on allegations that Harb improperly used his seat in the Senate to lobby Bangladeshi ministers on behalf of Niko in a dispute over natural gas.

"As a city councillor, a member of Parliament and as a senator, I have always put the public interest first." Harb, who was paid \$65,000 by Niko, said in his statement. "I am confident that there will be no finding of wrongdoing."

Corporal Kevin Duggan of

Royal Canadian Mounted Police (RCMP), Canada's national police service, alleged in a sworn affidavit that Harb travelled to Bangladesh four times using a special passport reserved for MPs, senators and retired ambassadors to help steer

Niko out of a crisis. Experts in parliamentary procedure suggest that the outcome of the probe will depend on how Harb represented himself during his trips. For instance, in April of 2006, when he walked into the home of then Bangladeshi foreign affairs minister Morshed Khan, did he present himself as a Canadian senator or an employee of Niko?

The Criminal Code of Canada dictates that for a public official to be in breach of trust, they must be acting "in connection with the duties of his or her office."

## WFP cuts Afghan food assistance

The UN World Food Program announced yesterday it will cut food assistance to more than 3 million Afghans in about half the country's 34 provinces because of a shortage of money from donor nations. The UN agency said it had planned to help feed more than

7 million people in Afghanistan this year, but a shortage of donor funds means 3.8 million people will be helped through meals provided at schools and training and work programs. The program said it needed an additional \$220 million to continue its work in Afghanistan at the level originally planned.


