

Recount of votes in 2 unions of Narail, Natore demanded

63 chairman, member aspirants fined

Voters blocked road in Lohagara upazila of Narail and formed a human chain in Bagatipara upazila of Natore yesterday demanding recounting of votes cast in the recently held union parishad elections in two unions of the upazilas.

Meanwhile, mobile courts fined 63 chairman and member aspirants in Karimganj and Pakundia upazilas of Kishoreganj districts on Monday for violating election code of conduct.

According to our Narail correspondent, around 3,000 villagers of Etna union blocked Lohagara-Narail Road for two hours from 12:30 pm demanding recounting of votes cast at Etna High School centre during June 26 election in the union.

They also submitted a memorandum to Upazila Nirbahi Officer (UNO) Arun Kumar Mondol, also the returning officer, and held a rally in front of his office.

Addressing the rally, the speakers, including defeated chairman candidate Nazmul Hasan Togor, alleged that Executive Magistrate Tobibur Rahman

along with BGB personnel reached Etna High School

centre where polling was going on peacefully.

Suddenly, the executive magistrate ordered law enforcers to charge batons on the people who came to cast their votes, they said, adding that at least 80 to 90 people, including ex-chairman of the same union Montu Sikdar, were injured in the attack and around 900 supporters of chairman Candidate Nazmul Hasan could not cast their votes.

They demanded action against the executive magistrate and a recount of votes of Etna High School polling centre immediately.

In Natore, a human chain was formed at Bagatipara upazila headquarters demanding a recount of votes cast at Nizpara Government Primary School centre in Jamnagar Union on June 8.

Around 1,000 voters joined the human chain in front of the UNO office at noon.

They alleged that elected chairman Hafiz Uddin manipulated the election results with the connivance of presiding and polling officers and snatched the victory of his rival candidate Abdul Quddus.

Refuting the allegation, Upazila Election Officer Fatema Khatun said the

polling at the centre was held peacefully.

Our Kishoreganj correspondent adds: At least 63 UP candidates in Karimganj and Pakundia upazila were fined Tk 2.10 lakh on Monday for violating election code of conduct.

Two mobile courts led by Md Abdullah Hakkani, upazila nirbahi officer (UNO) of Karimganj, and Lutfunnahar, upazila nirbahi officer (UNO) of Pakundia fined the candidates for pasting posters on walls.

The mobile court led by Karimganj UNO Abdullah Hakkani fined 15 chairman aspirants, 16 member candidates and eight candidates for women reserved seats for violating election rules in different unions of the upazila and realised Tk 1.32 lakh from them.

The court also sentenced five people to five days imprisonment each for the same offence. The convicts are Mosharraf Hossain, 47, Md Siddique Mia, 50, Md Jalal Uddin, 52, Abul Kashem, 40 and Mozammel Haque, 33.

The court led by Pakundia UNO Lutfunnahar fined three chairman and 21 member candidates in Chandipasha Union of the upazila and realised Tk 78,000 from them.

KCC announces Tk 180 cr budget for 2011-12 fiscal

Mayor Talukder Abdul Khaleque yesterday announced a budget of Tk 179 crore 64 lakh and 51,000 for Khulna City Corporation (KCC) for 2011-12 financial year.

The budget was presented at a press conference in the morning at Nagar Bhaban conference room with ward councillor and head of the KCC standing committee for finance Sufia Rahman Shunu in the chair.

In the budget, no new tax has been imposed on the city dwellers.

The revenue collection target of the city corporation has been fixed at Tk 54 crore and 83 lakh while development expenditure at Tk 124 crore and 81 lakh.

Terming the new annual budget development oriented, mayor Khaleque said that he had sanctioned Tk 16 crore from KCC fund for different development heads reducing the daily expenditure of all sections of the corporation.

The major heads of expenditure are water supply development project Tk 2 crore, infrastructure development Tk 19 crore 60 lakh, public health Tk 3 crore 40 lakh and conservancy Tk 5 crore 5 lakh.

The mayor said that Tk 77 crore and 26 lakh had been sanctioned for seven approved projects of KCC for the next fiscal.

The projects include development of roads and footpaths, infrastructural development of Khulna City Corporation, construction of sanitary landfill, construction of linear park and urban public and environmental health

sector development.

The mayor vowed to continue development work of the city as before.

Refuting the allegation of tender manipulation in city corporation, the mayor urged the aggrieved men to help identify the manipulators. Stern action would be taken against them

irrespective of political affiliation, he said.

I am committed to root out corruption from the city corporation and sack corrupt officials for establishing a transparent administration, he said while assuring the city dwellers of providing with better civic facilities.

her dead on the spot.

Police recovered the body and sent it to Sunamganj Sadar Hospital for autopsy.

In Satkhira, a housewife was beaten to death allegedly by her husband at Bhadriali village in Kalaroa upazila for dowry on Sunday afternoon, reports our correspondent.

She was identified as Rehena Khatun, 21, wife of Osman Ali of the village.

Quoting local people police said, Rehena was married with Osman Ali, son of Afsar Ali of the village, two years ago.

Recently Osman demanded Tk 25,000 dowry from Rehena's parents and started to torture her as she failed to bring the money, locals alleged.

Over the issue, Osman on Sunday beat her mercilessly, leaving her dead on the spot.

Later, in a bid to turn it into a case of suicide, he hung the body from the ceiling of the house.

Police recovered the body with several marks of injuries on her person and sent it to Satkhira morgue for postmortem, hospital sources said.

Two housewives killed for dowry

They were beaten to death in Sunamganj, Satkhira

Two housewives were beaten to death allegedly by their husbands on Monday and the day before for dowry in Sunamganj and Satkhira districts.

A pregnant housewife was killed allegedly by her husband for dowry in Choror Bon area under Chhatak municipal area in Sunamganj on Monday, reports our correspondent.

Police with the help of local people arrested the husband.

Family sources said, Jamila Begum, 20, daughter of Sirajul Islam of Choror Bon area was married to Abul Kalam, son of late Abdur Rahman of Gang Bazar village of Doara Bazar upazila two years ago.

Since then Kalam has been living at his father-in-law's house.

Recently Kalam demanded Tk 20 thousand as dowry and started to torture Jamila for it.

Locals said, on Monday noon, Kalam locked in an altercation with Jamila over the issue and at one stage beat her mercilessly leaving
