War crimes: Probe against SQ Chowdhury begins

A team of International Crimes Tribunal (ICT) yesterday started investigating the involvement of detained BNP standing Committee member Salahuddin Quader Chowdhury in crimes against humanity in Chittagong during the 1971 Liberation War.

Led by former Additional Deputy Inspector General of Police (IGP) and Chief Coordinator of the war crimes investigation agency Abdul Hannan Khan, the 13-member investigation team arrived on Tuesday night.

Since September last year, ICT investigation teams visited various areas of the district to collect information.

Assistant Superintendent of Police (ASP) Nurul Islam said they have gathered ample evidence during their previous visits which led them to the crimes committed by SQ Chowdhury and others in 1971.

He termed the current weeklong visit as continuation of the ongoing probe.

Army man's wife found dead

Police recovered the body of the wife of an army soldier from his cantonment residence in the city yesterday.

The deceased is identified as Rabeya Sultana Tota, 25, wife of Jagangir Hossain Sajib.

The family members of Rabeya alleged that Sajib killed her being failed to get dowry. However, police suspected that she committed suicide.

Mahbubur Rahman, sub-inspector of Cantonment Police Station, said they recovered Rabeya's body from her residence at Zia Colony at about 7:30am and sent it to Dhaka Medical College morgue for autopsy.

Azim protests Sahara's remarks

Independent lawmaker Fazlul Azim yesterday in parliament said if Home Minister Sahara Khatun made "defamatory comment" on him outside the House, he would have filed a case against her.

"I would have filed defamatory case against the home minister if she attacked me personally using defamatory words outside parliament," a lamented Azim told parliament.

During cut motion on the grants demand in the proposed budget for 2011-12, the home ministersaid, "When you [Azim] were an MP in the past BNP government, you were involved in different types of crimes and terrorism activities, you had wounded many people of your constituencyduringthattime."

According to the constitution, no case can be filed against any member of parliament for his/her

speech in the House. Earlier Azim told the parliament that the country's law and order situation is

worsening. Speaker Abdul Hamid who was presiding over the sitting at that time called upon both the minister and Azim not to use "attacking languages" in the House.

TK 12,134CR DFENCE BUDGET

Judicious expenditure emphasised

The defence budget expenditures, especially in procurements, should be transparent and efficient, as a huge amount of hard-earned public money is being allocated for the country's armed forces, speakers at a dialogue said yesterday.

The defence budget will have to be judicious, and since defence is a strategic issue of a country its budget should be discussed to such an extent it deserves, they said.

The government has allocated for armed forces Tk 12,134 crore for the fiscal year 2011-12, which is higher than the budget for the last fiscal (2010-11) by Tk 1, 216 crore. The speakers said the concept and

objectives of defence is changing day by day worldwide and stressed the need for rationalising the forces' objective and structure, and designing the forces with the state-of-the-art equipment and technologies.

Brac Business School of Brac University organised the dialogue on "Bangladesh Defence Budget" at the university in the city yesterday.

Dr Shamsul Alam, member of Planning Commission, said the coun-

cow" as the issues of the armed forces is not discussed openly, which should not happen in an independent country and in the era of free-flow of information. "As our resources are limited and we

have a great urge for development, the spending of the armed forces should be judicious." The strategy of military expenditure

should not be for conventional warfare; rather they should be prepared for addressing domestic disturbance, natural calamities, and other internal contingency issues. **BNP Standing Committee Member**

Lt Gen (retd) Mahbubur Rahman termed the defence budget too inadequate, saying around 80 percent of the budget will be used for maintenance of the armed forces, their ration, and sometimes construction.

There will hardly be any money available for arming the forces, he said.

Brig Gen Mohammad Abdul Halim, director (budget) of Bangladesh Army, said there is nothing secret about the budget of the armed forces.

Of the total defence budget this year, Bangladesh Army takes about 52 percent, Air Force 13.52 percent, and Navy 11.5 percent, he said.

ance, 17 percent for supply and service, 1.08 percent for maintenance, and .03 percent for welfare, he added. AK Azad, president of the Federation

of Bangladesh Chambers of Commerce Industries (FBCCI), said army is an independent force and it should be given the opportunity to function independently.

The politicians will have to have the commitment that the armed forces will not be used politically, he said.

As the leader in the United Nations (UN) peacekeeping missions, Bangladesh army needs equipment of state-of-the-art as the demand for quality in peacekeeping force is increasing day by day, said Lt Gen (retd) Zahir.

Commerce Minister Faruk Khan said the defence budget has been well spent since the independence of the country, as the country has been well secured for the last 40 years. Even the internal insurgency was also well tackled, he added. Everybody should know about

defence budget, he said, adding, "We will not raise any such demand, which is not practiced anywhere of the world." In a democratic country there should be discussion about every institution as per requirement, he said.

He was due to go for Leave Preparatory to Retirement (LPR) yesterday (June 29) from Bangladesh Army.

told The Daily Star yesterday that the prime minister yesterday signed the contract on service extension for Gen Masud following his application. Earlier on June 15, the

government called back Gen Masud and placed him in his former position in Bangladesh Army.

A key player in the 1/11 incident, Masud was placed in the foreign ministry and appointed to Bangladesh High Commission in Canberra on June 8, 2008.

The government after considering overall aspects of Masud's application extended his service till September 29. Meanwhile, the govern-

ment is searching for a suitable person as next high commissioner in Canberra prior to visit of Prime Minister Sheikh Hasina.

Hasina is expected to attend Commonwealth Heads of Government Meeting (CHOGM) to be held in Perth, Australia on October 28-30 this year.

Journo sues 10 Sangram bosses

A former senior reporter of The Daily Sangram yesterday filed a case against ten bosses of the daily, including its Chairman and Jamaat-e-Islami Secretary General Ali Ahsan Mohammad Mojahid and Managing Director Sharif Hussain.

Other accused are Jamaat's acting Ameer and Vice Chairman of Sangram Publications Ltd Makbul Ahmed, directors of the company--Jamaat acting Secretary General ATM Azharul Islam, advocate Nazrul Islam, Rafigul Islam Khan, Mohammad Shahidul Islam, AHM Hamidur Rahman Azad, MP, Mominul Islam Patwary and Mohammad Abul Hussain Chowdhury.

AB Siddique filed the case with Chief Metropolitan Magistrate's Court of Dhaka

against the accused. In his complaint, Siddique said he had been working as a

senior reporter in Sangram since 2008. But he was sacked from his service on June 4 this year as he demanded his dues about Tk 9 lakh. The accused also threatened him.

After the hearing, Metropolitan Magistrate Mohammad Mizanur Rahman recorded statement of the complainant and directed the officer-incharge of Ramna Police Station to submit report by July 31 after an investigation into the matter.

Fakhrul visits Rumana at hospital

BNP acting Secretary General Mirza Fakhrul Islam Alamgir yesterday said his party does not believe in the concept of interim government, which the ruling party leaders have proposed instead of caretaker government system. "BNP will not accept interim government [system]. We

want the next parliament election to be hold under thirteenth amendment [that introduces caretaker government system] of the constitution," he said while talking to reporters after visiting Dhaka university teacher Rumana Manzur at a city hospital. The BNP leader demanded exemplary punishment to

Rumana's husband who brutally tortured and blinded her. Replying to a query, he termed the government's call to sit

for discussion to settle the dispute regarding caretaker government as "a strategy of cheating." "I hope the government will refrain from doing it [scrapping caretaker system] and their good sense will prevail," he said.

Meanwhile, party standing committee member Khandaker Mosharraf Hossain warned the government of dire consequences if the constitution amendment bill is passed in the parliament.
