BIWTA officials said the boundary pillars will go far into the existing waterway of the Shitalakkhya. They feared this move would make way for permanent private ownership of the foreshore and invite the encroachers to the

vacantland. In the latest land recordbased survey of the river in 2001, Narayanganj district administration had narrowed the river from what it is in the foreshore maps prepared jointly with BIWTA as per Cadastral Survey (CS) records.

The survey identified a total of 3,010 structures along the Shitalakkhya as per CS record compared to only 302

according to RS record. The High Court in June 2009 came up with a judgment and directions about demarcation of rivers with pillars, building walkways and plantation of trees.

The court ordered the

deputy commissioners of Dhaka, Narayanganj, Gazipur and Munshiganj to demarcate the Buriganga, Shitalakkhya, Turag, Balu and Dhaleswari rivers as per CS and RS records and retain the eroded and reformed land as part of rivers.

The judgement defined foreshore in light of The Port Rules, 1966. It said foreshore is the soil lying between lowwater mark of dry season (spring) and high-water mark of monsoon during normal tides.

A river primarily includes bed, foreshores and banks, clarified the judgement. The district administration, however, in its survey

did not consider foreshores as part of rivers. The port rules are outdated and the present reality

is quite different with many changes over the years, noted M Shamsur Rahman, DC of Narayanganj.

1982. While continuing as a full-timer, he obtained a regular graduation degree (third class) in 1985 although service rules permit full-timers taking private degrees only.

However, rules mattered little for Aliuzzaman, and he was promoted to SA-I in 1988. Four years later, he got promoted to sub-assistant engineer despite service rules do not allow promotion to the post without a first class in diploma engineering.

He has no diploma degree, let alone a first class.

Between 1999 and 2005, he became an assistant engineer and a senior engineer. More was to follow: on May 26 this year, he was promoted to the post of principal engineer (equivalent to the rank of an associate professor) of BAEC.

Established in 1973, the BAEC works to develop nuclear technology for health, industry and environment. Its vision is to promote nuclear science and technology for peaceful uses of atomic energy for overall socio-economic and scientists. development.

The father went to the local bazaar and begged for help. He collected Tk 2,400 from several people and went to Chittagong on April 25 taking with them another person to help on

The following day, they arrived at the BR office around 10:30am and waited for over two hours before Sharif was examined by three "men".

"After the checkup was complete at about 3:00pm they told us to go home. And we haven't heard anything from anybody ever since," tells Awal.

Abul Kashem, the BR official, told The Daily Star that every victim must undergo a medical examination by a BR-appointed medical team for compensation.

He said that the victims would be compensated as per the Railway Act of 1890 which allows Tk 10,000 for an A-category victim.

If someone dies or loses a limb or becomes paralysed, he falls under category-A, said Kashem terming the amount ridiculous "Nobody has ever tried to amend this 120-year-old law and make it up-todate."

He added that there are cases where the government announced reasonable compensation for the victims following accidents, but nothing like that happened in case of the tragedy in Narsingdi.

As for Sharif, "He will qualify for Tk 10,000," Kashem said.

The CEC added that the commission will again place its proposal for limiting the number to three in the Chief **Election Commissioner and** Election Commissioner (Appointment Procedure) Act, 2011. The draft of the act is complete and the commission is now scrutinising it.

On spending crores of taka in election, Huda said it is difficult to prove anomalies in poll expenditures, as the costs are often invisible.

An 11-member team of NPP led by its Chairman Sheikh Shawkat Hossain Nilu attended the talks at 3:00pm.

12-member delegation of Bangladesh Muslim League led by its President Nurul Haque Mojumder joined the dialogue. Both the parties recom-

mended introduction of electronic voting machine (EVM) in phases in different local government elections before the parliamentary election. They also suggested that

A moderate 5.6-magnitude earthquake hit off Indonesia's Sumatra island yesterday, the local geophysics agency said, but there were no initial reports of damage or casualties. The quake struck at a

depth of 30 kilometres around 175 kilometres southwest of the city of Bengkulu at 11:19am. "So far we haven't received any information if

there is an impact or damages from the quake. The quake is located quite far from Bengkulu," National Quake Centre official Bayu Pranata said. Indonesia sits on the

Pacific "Ring of Fire", where the meeting of continental plates causes high seismic activity, and Sumatra is particularly prone to earthquakes.
