#### Islamic inheritance laws

The PCP article by Zeeshan Hasan (21 June) is a correct summarisation of the position on Islamic inheritance laws as stated in the Quran. The making of a will with two male witnesses was the customary practice and whatever was in the will, the estate of the deceased was distributed accordingly. However, in those days scribes were difficult to find to put the will in writing, so most

wills were verbal in front of disinterested witnesses. However, there were enormous pressure on witnesses from inheritors to change the terms of the verbal will and hence the various admonitions in Quran against this. The formal law of two shares for male and one for female and other distribution guidance came soon after the battle of Ohud, when many Muslims lost their lives without being able to make a will. These provisions do not cancel or supersede the earlier provisions of making a will in

the Quran. However, the verbal will and pressurised witnesses remained a problem in society. So, some Muslim ruler (I do not know whether it was the prophet himself or there was any hadith on this) adopted the post-Ohud version as Sharia Law to avoid any witness problems and the verbal will.

A will was still allowed to be made in favour of someone who is not a legal inheritor under Sharia Law, but only up to one third of the value of the estate and no more (I do not know the basis of this). So according to the Quran, making of a will and distribution of all property by its terms as was allowed before the battle of Ohud is not abolished, and nowadays with a written will and formal attestation by witnesses, enforcement of this is no problem.

The standard Sharia provision appears applicable only to someone dying without having made a valid will. The modern educated Ulema needs to rethink and perhaps allow this Quranic practice unless there is clear disbanding of this practice mentioned somewhere in the Quran or Hadith.

# High prices of essentials

The parliamentary standing committee of commerce ministry visited three kitchen markets of the city on June 15 this year. It also prepared a report that said it was satisfied that prices of daily essentials were "stable" and "did not increase" after the budget proposal on June 9. "The committee hopes it will remain stable during the month of Ramadan (in August)," a report said. In a stark contrast, however, a number of the ruling alliance lawmakers including Jatiya Samajtantrik Dal MP Hasanul Haq Inu and Jatiya Party MP Fazle Rabbi Chowdhury expressed concern over the price hike of essentials in parliament on June 26.

At the time of the committee's visits to Karwan Bazar, Mohammadpur Town Hall Super Market and Mohammadpur wholesale market, there were no price lists there. The chief of the House body told the reporters on that day that prices of essentials were under control, but customers said shopkeepers misled the committee members by lying about the prices.

On that day, a customer bought 1 kg of sugar for Tk. 64/- from a shop, but the shopkeeper told the House delegation that he was selling sugar at Tk. 60/-. So, the committee in its report said sugar was selling at Tk 60 a kg. In this way the House committee visited the kitchen markets and accordingly prepared a report. How could the chief of the house committee tell the reporters that prices of essentials were stable? The real picture is totally different.

Government should look into the matter seriously without any plea because the holy Ramadan is knocking at the door.
