DR Congo plane crashes at airport

More than 50 feared to be dead

A plane carrying 112 people crashed as it attempted to land in stormy weather in eastern Democratic Republic of Congo yesterday, but at least 53 people have survived, the air company said.

The plane, operated by Hewa Bora Airways, crashed at Kisangani airport in the northeast of the country.

"We don't know how many people are dead but there are at least 53 survivors from a total 112 passengers and personnel crew," the airline's director Stavros Papaioannou,

told AFP. "The crew members of the Boeing 727 are the first (confirmed) dead," Papaioannou

said. "They arrived at Kisangani, there was bad weather, they tried to land without reaching the runway," he continued, adding that heavy rains at the time had hampered the rescue operation.

The plane was on its regular commercial

route from Kinshasa to Kisangani and Goma when it was hit by the storm as it approached the airport, Lambert Mende, a spokesman for the local administration said.

A plume of black smoke could be seen at the end of the runway, an AFP journalist reported. But flights, which had been suspended after the crash, resumed a short time later. Plane accidents frequently occur in DR

Congo which are often blamed on ageing and poorly maintained aircraft, the flouting of safety rules and bad weather.

Each of its 50 or so airlines has been blacklisted by the European Union which has banned them from its airspace.

A UN aircraft crashed as it tried to land in a storm in Kinshasa in April, killing 32. One person survived in one of the worst disasters ever involving UN transport.

In August last year 20 people were killed after a plane flown by the head of a local airline crashed during landing in the west of the country.

Hillary to visit India in July

US Secretary of State Hillary Clinton is to visit India this month for strategic talks with Indian leaders, a spokesman for the Indian foreign ministry said yesterday.

Hillary will be the most senior US official to visit India since a state visit by US President Barack Obama last November.

She will travel to New Delhi to attend the second India-US Strategic Dialogue on July 19 after presiding over the first such meeting between the world's two largest democracies last year in Washington.

"We are working on a programme" for Clinton's visit, foreign ministry spokesman Vishnu Prakash told AFP.

Prakash did not elaborate on the topics up for discussion during Clinton's talks with Indian foreign minister S.M. Krishna but regional security was expected to be high on the agenda.

Syrian security forces opened fire on antiregime protests yesterday, killing at least thirteen people, activists said, while nearly half a million people demonstrated in the protest hub of Hama.

The continuing crackdown on opponents of Bashar al-Assad came as the president's regime accused US Ambassador Robert Ford, who had visited the city, of inciting violence.

The casualties included two protesters killed in a central commercial neighbourhood of Damascus, Abdel Karim Rihawi, who heads the Syrian League for Human Rights, told AFP.

Both US envoy Ford and French Ambassador Eric Chevallier visited Hama on Thursday.

On Friday, the regime accused Ford of meeting "saboteurs" there and inciting anti-Assad protests.

"The ambassador incited these saboteurs to violence, to demonstrate and to refuse dialogue" with the government, it added.

The foreign ministry called Ford's presence in Hama "obvious proof of the implication of the United States in the ongoing events, and of their attempts to increase (tensions), which damage Syria's security and stability."

Pakistan air strikes kill 42 militants

Pakistan officials said yesterday that a four-day air and ground offensive against militants in a key tribal district had left 42 enemy fighters and eight soldiers dead on the Afghan border.

There was no independent confirmation of the death toll because journalists and aid workers do not have free access to the district of Kurram.

The military announced the operation on Monday, under pressure from Washington to do more to destroy militant sanctuaries since US Navy SEALs killed Osama bin Laden north of the capital Islamabad on May 2.

Minister urges PM to resolve impasse

Union Petroleum Minister S Jaipal Reddy met Prime Minister Manmohan Singh Friday and called for steps to resolve the impasse over creation of a new state of Telangana from Andhra

Pradesh. Sources said Reddy, who was with the prime minister for over 30 minutes, apprised him of political developments in Andhra Pradesh in the wake of resignation of about 100 legislators and 15 MPs from Telangana region in support of their demand for a sepa-

rate state. Reddy, who is an MP from Chelvella Lok Sabha seat in Telangana region, pressed for an early decision to resolve the impasse and said there was a groundswell of support in the region for creation of a new state.

Kashmir violence at lowest level ever

Causalities drops by 50pc since last year

The number of violent incidents in Indian Kashmir fell below 100 in the first half of the year, the lowest level since the start of an insurgency more than 20 years ago, according to police.

Official records showed that the number of incidents in the first half of 2011 fell by 50 percent to 97 compared with last year's figure of 196. Seventy-nine people were killed in violence between

January 1 and June 30 -- 42 militants, 12 Indian security personnel and 25 civilians, a police officer told AFP. At the peak of the unrest in Indian-administered

Kashmir in 1996, 13 people were dying on average per day.

In 2001, about 10 a day were killed on average. A total of 375 insurgency-related deaths were recorded in 2010, the same as 2009, when the figures were the lowest for any single year since the start of the insurgency

The figures for 2010 do not include the estimated 117 fatalities during a summer of public protests against Indian rule, with most deaths caused by security forces firing live ammunition on demonstrators.


