# Fierce fighting with spears and shields

50 injured in Gopalganj

At least 50 people were injured in a fierce clash between the residents of two areas under Gopalganj municipality yesterday.

Police quoted locals as saying that some youths of Gatpara hacked Aminul Haque Jhantu of Miapara with sharp weapons while he was passing the Gatpara riding his motorbike at around 9:00pm on Sunday.

As the influential people of Miapara went to Betgram the same night to settle the matter through an arbitration, they also came under attack.

At around 9:00am yesterday, people of Gatpara, Betgram and Golabaria areas equipped with lethal

weapons, including spears and shields, attacked the houses of Miapara, prompting the residents of the area to retaliate.

Firearms were also used during the clash as three of the injured--Khairul, 32, Afzal, 18, and Rubel, 17-received bullets and are undergoing treatment Gopalganj General Hospital. Most of the injured are receiving treatment at private clinics to escape arrest.

Injured New Age Correspondent Nitish Chandra Biswas and constable Ebadul were given first aid at the hospital. Police arrested three people on the spot. They are Anik, 18, Mofizur Rahman, 22, and

### No progress in Daspara cop killing case

A year into the killing of three policemen at Daspara under Bera upazila, police could not submit charge sheet against the accused in the case.

Pabna Police Superintendent Md Jahangir Hossain Matobbar said the investigation into the case has already been completed. "We have got the names of the criminals involved in the incident. We are waiting for a forensic report on a firearm used by the gang during the attack on the cops", he said.

Names of the criminals, who took part in the operation, are now available to the police, the police superintendent said, adding that they will submit the charge sheet as soon as they receive the forensic report.

Sub-Inspector Md Zohir Uddin, also the investigation officer (IO) of the case, said charge sheet against 20 outlaws involved in the incident will be submitted to the court. Of the underground operatives, 11 are now in jail, seven still at large while the rest two have been killed in intra-party clash during the year-long investigation, the IO added.

Outlaws shot dead subinspector Md Kafil Uddin, nayek Abdul Wahed and constable Shafique Ahmed of Dhalarchar police camp at Daspara on July 20, 2010. The policemen came under attack when they went to Rajdhardiar village to buy woods for the camp.

## Statement of one more PW taken

PATRADUT EDITOR MURDER CASE

Trial of the daily Patradut editor S M Ala Uddin murder case continued with recording of the statement of another prosecution witness of the case on Sunday.

The statement of Md Anisur Rahim, one of the 38 prosecution witnesses was recorded while all the accused were present in the dock.

Judge of Satkhira district and sessions judge's court Obaidus Sobhan recorded the statement and fixed July 24 for recording the statement of other PWs.

Earlier the court on Thursday recorded the statement of prosecution witness Abdur Razzak resuming the case after 15 years into the

gruesome murder. The daily Patradut editor SM Ala Uddin was shot dead by the assailants while he was discharging his professional duties at the newspaper office in Pransayer area in the

town on June 19 in 1996. Police arrested an Awami Jubo League activist and member of the killing squad Saiful Islam after five days of the incident. Saiful disclosed the names of the other accused.

The investigation officer (IO) submitted charge sheet with a magistrate's court here against 10 accused on May 5 in 1997.

The charge sheeted accused are Abdus Sabur, Khalilullah Jharu, Saifullah Kislu, Momin Ullah Mohon, Abdur Rouf, Abul Kalam, Eskandar Mirza, Atiar Rahman, Saiful Islam and Safiur Rahman.

The trial was delayed as five accused submitted a petition to the High Court seeking quashment. The High Court accepted the petitioners' prayer and quashed the case in 1998.

On appeal from the government, the Supreme Court rejected the quashment order of the HC and asked the lower court to resume the trial on March 11 in 1999.

Later accused Khalilullah Jharu and Abdus Sabur filed an appeal petition before a bench of the High Court Division of the Supreme Court with a prayer to shift the trial court from Satkhira at any other place in the country. After hearing, the High Court's Division bench rejected the prayer on November 7 in 2007.

Later they submitted a leave to appeal petition with the Appellate Division of the Supreme Court against the HC order.

On July 26 in 2009, the Appellate Division of the Supreme Court rejected the prayer and the copy of the order reached the judge's court on September 30 in 2010.

## Abducted fish trader rescued

5 held in Manikganj

Police rescued abducted fish trader Abdul Hannan, 32, of Rampura in Dhaka from Begun Narchi village under Ghior upazila yesterday and arrested five people in this connection.

Hannan was kidnapped from from Rampura wholesale fish market on July 13. The arrestees are Habib,

26, Matin, 22, Liton, 22, Arobindo, 22 and Badal, 24 of Bharra village under Nagarpur upazila in Tangail.

Officer-in-charge of Ghior police station Azizur Rahman said the kidnapers took Abdul Hannan to the home of Habib of Bharra village under Nagarpur upazila in Tangail.

Confining him to a house, they demanded ransom Tk15 lakh from the victim's wife Shima Begum over cell phone.


The criminals also had threatened over phone that they will kill her husband if their demand is not met.

Hannan's family sent Tk 3 lakh to an address given by the kidnappers through S A Paribahan. But they stuck to their full demand of Tk15lakh.

Abdul Hannan was later moved to the house of Mohor Ali of Begun Narchi village in Manikganj from Tangail on July 15. Getting a scope, Hannan called his wife over cell phone. He told her that the kidnapers confined him to a house beside a school on the bank of a river of Ghior.

Hannan's family informed it to Ghior police station and police raided the Begun Narchi areas. The kidnapers fled into a jute field with Hannan.

Police however held the four abductors and rescued the fish trader.



## Dried turtle seized on Dinajpur border again

Border Guard Bangladesh (BGB) seized 110kg of dried turtle in bordering Birampur upazila on Sunday morning, 22 days after a similar incident in Nawabganj upazila of the same district.

Tipped off, a BGB team led by Subedar Shafiuddin Howladar of Birampur camp raided Chandipur village in Birampur upazila on Sunday morning and seized 110kg of dried turtle worth Tk 13 lakh, said sources of Phulbari 40 Battalion under Dinajpur Sector of BGB.

"Dried turtle is used for preparing soups and also medicine in different countries. In some countries it is also used as nutrient for animals," Mostafa Ali Reza Hossain. director of the fish museum of Bangladesh Agriculture Universality at Mymensigh, told this correspondent a few
