# China, US spar over South China Sea

China warned the United States yesterday not to interfere in territorial disputes with its Asian neighbours over the South China Sea, during talks with US Secretary of State Hillary Clinton.

Hillary said ahead of a meeting with Chinese Foreign Minister Yang Jiechi on the Indonesian island of Bali that Washington welcomed a deal between China and Southeast Asia on guidelines meant to reduce tension in the strategic sea.

"I want to commend China and Asean for working so closely together to include implementation guidelines for the declaration of conduct in the South China Sea," she told reporters.

But in a meeting characterised by both sides as positive, Yang reminded Clinton that China's territorial claims in the South China Sea or anywhere else were none of Washington's concern.

The Chinese side raised its own concerns, which is that it is important to respect the sovereignty and territorial integrity of China," Chinese delegation spokesman Liu Weiming told reporters, summarising Yang's comments to Hillary.

Liu said Yang and Clinton specifically discussed the South China Sea, a potentially resource-rich waterway stretching from China's southern coast deep into Southeast Asia.

But in a note of conciliation, he said the United States seemed to understand the "sensitivity of these issues" and the two sides had "agreed to further promote dialogue and mutual understanding".

A US official travelling with Hillary said the tone of the meeting was "productive" and "professional". The Chinese side showed a "clear determination that they want to ease anxieties," he added.

The bilateral talks came a day ahead of the Asean Regional Forum, Asia's main security dialogue involving Southeast Asian nations as well as China, Japan, the United States, Russia and the Koreas.

In their bilateral meeting, Clinton pressed Yang about recent tensions with littoral states such as Vietnam and the Philippines and asked for assurances about freedom of navigation in the vital trade route, the US official said.

China lays historical claim to the South China Sea in its entirety, while the Philippines, Vietnam, Malaysia, Brunei and Taiwan also have overlapping claims to islands and maritime territory in the area.

The Philippines and Vietnam have expressed anger in recent months over what they call China's increasingly aggressive actions in the area, such as harassment of fishermen and oil exploration vessels.

### Ulfa talks to begin soon

The first round of peace talks between Indian government and insurgent group Ulfa will be held soon, Assam state Chief Minister Tarun Gogoi said yesterday.

The Indian government has given the green signal to Assam government to work out modalities to facilitate the parleys and "the talks will be held soon but I cannot give a date now," Gogoi told reporters in Guwahati.

So far only preliminary rounds of talks between Ulfa and interlocutor had been held here. "But now direct talks will start. They will be held at different levels", he added.

ULFA pro-talk faction chairman Arabinda Rajkhowa had introductory talks with Prime Minister Manmohan Singh and Union Home Minister F Chidamabarm in February.

A long-awaited anti corruption bill aimed at tackling endemic graft in India will be introduced in the next session of the parliament beginning August 1 a top minister said yesterday.

Kapil Sibal, the telecom minister who has overseen the drafting of the new legislation, said the so-called Lokpal bill was ready after changes suggested by other political parties were incorporated.

"The government is committed to placing it in the monsoon session of the parliament. The prime minister had made a promise and we will ensure that it is delivered," Sibal told report-

"Changes have been made to reflect the concern of other parties. We are hopeful that the bill given to the parliament will be passed with unanimity," he added. Sibal said he and other

ministers were against bringing the prime minister under the purview of the independent ombudsman who will be created by the law and will have powers to investigate corruption.

## Clashes kill 11 in Karachi

At least 11 people were killed and 15 others were wounded in a fresh wave of violence in Karachi, Pakistan's biggest city, officials said yesterday.

Last week Pakistan ordered hundreds of extra paramilitary policemen onto the streets of the Arabian Sea port to try to quell the violence.

Political and ethnic violence in Karachi is blamed on supporters of the Muttahida Qaumi Movement (MQM), based among the Urdu-speaking majority, and the rival Awami National Party (ANP), which represents based migrant Pashtuns from the northwest.

"At least 11 people were killed and 15 others were wounded since last night," home ministry official Sharafuddin Memon told AFP, but declined to comment whether they were ethnically-motivated killings.

Local police officials confirmed the death toll but did not give details.

The MQM last month quit the coalitions led by the main ruling Pakistan People's Party (PPP) that govern the country and the southern province of Sindh, of which Karachi is the capital. The ANP remains part of both coalitions.

The previous wave of violence erupted after provincial minister Zulfiqar Mirza, from the PPP, criticised the MQM and its exiled leader Altaf Hussain.

Mirza later apologised for remarks that he said were his "personal opinion" and from London, Hussain asked his supporters to "end their peaceful protest and go back to their homes".

The Human Rights Commission of Pakistan says 490 people were killed in targeted killings in Karachi in the first half of the year, compared to 748 for the whole of 2010, which was the worst since 1995.

## Australia, Malaysia Afghan blast kills five to sign asylum deal

Australia and Malaysia are set to finalise a deal next week under which hundreds of asylum seekers will be sent to the Asian country in exchange for thousands of refugees, an official said yesterday.

The pact has come under heavy criticism because Malaysia is not a signatory to the United Nations convention on refugees, raising questions about the treatment of the 800 asylum seekers it has agreed to accept.

But Canberra, which is battling to reduce the numbers of boatpeople arriving on its shores, hopes the policy will hurt people smugglers and stop asylum seekers from making the long and dangerous sea journey to Australia.

A Malaysian Home Ministry official confirmed the two countries would put pen to paper next week. Asked whether they would sign the agreement in Kuala Lumpur on Monday, he replied: "Yes".

The source could not immediately give further details, and other officials familiar with the agreement, which involves Australia taking 4,000 of Malaysia's registered refugees, could not be reached.

as their vehicle was hit by a roadside mine in the Shakh area of Qaysar district," Yaqoubi said.
