FROM PAGE 20 The mass transport will carry some 60,000 passengers in an hour during peak time, found a Jica study. It also estimated \$12 million for each kilometre of the elevated part while \$48 million for the underground segment.

Commuters will have to pay Tk 2.50 for travelling each kilometre.

An international prequalification tender will be floated by the end of this year to select prospective firms for the first ever metro rail in the country, sources in communications ministry

The environmental study and setting up of a depot are now in final stage while some other small issues will be resolved soon, he added.

The government will enter a deal with the suc-

cessful bidder in the first quarter of the next year to ensure the construction work of the mass transport network starts by June or July next year, maintained the minister.

The Japanese agency has almost completed the feasibility study on the modified part of the 21.5-kilometrelong metro route stretching from Uttara Third Phase to Sayedabad, also known as Mass Rapid Transit (MRT) Line-6.

The communications ministry on February 1 modified the route as it conflicted with the underconstruction Gulistan-Things are now moving Jatrabari flyover. The move cast uncertainty on the

The adjustment was made after Jica finished its study on the original route starting from Uttara Third Phase to Sayedabad via Pallabi, Farmgate, Sonargaon Hotel, TSC of Dhaka University, Central

Shaheed Minar, Fulbaria, Gulistan and Tikatuli.

As per the modification, the route from TSC has been diverted towards Curzon Hall, Jatiya Press Club, Bangladesh Bank and up to the Kamalapur Railway Station.

An earlier study of Jica chalked out three routes for the project and suggested to implement the first one (Uttara Third Phase to Sayedabad).

According to project officials, the first phase of the metro will be built mainly on government land and some existing roads. The 1.8 kilometre of the route between Bangladesh Bank and Kamalapur Railway Station might be built underground as it has several high-rises.

The project will be implemented in three phases under the Strategic Transport Plan (STP) to ease the perennial traffic gridlock in the capital.

Tarique asked to appear in court

Earlier, two other courts issued arrest warrants against Tarique, elder son of BNP Chairperson Khaleda Zia, in connection with the August 21 grenade attack cases.

The court yesterday adjourned the hearing on charge framing against Tarique's business partner Giasuddin Al Mamun, another accused in the case, till August 8 after his lawyer filed a prayer seeking time.

The counsel pleaded for the deferment mentioning that a writ petition was earlier submitted with the High Court on behalf of Mamun seeking to quash the case, but hearing on the prayer is still pending.

Tarique's attorney also submitted a petition seeking adjournment of the hearing on the ground that the Supreme Court has rejected a review petition submitted on behalf of Tarique and

they are yet to receive the certified copy of the judgment.

Prosecution lawyer Anisul Huq told the court that such ground will not be accepted for seeking adjournment of the hearing and appealed to the court to issue an arrest warrant against Tarique.

The judge, however, did not pass any order on the petition.

Since Mamun's lawyer could not get any stay order from the higher court, there is no legal bar to frame charges against him, noted Anisul. Mamun was present

while Tarique, accused in 14 other cases, went abroad earlier for medical treat-

during the hearing yesterday

Meanwhile, pro-BNP lawyers brought out a procession on the court premises demanding withdrawal of the court order.

The Metropolitan Sessions Judge's Court on May 5 took into cognisance the charges against Tarique and Mamun and transferred the money laundering case to the Special Judge's Court-3 for its quick disposal.

According to the February 9 verdict of the SC, proceedings of the case against Tarique cannot run under the Money Laundering Prevention Act, 2009 as the alleged offence took place before its enact-

The SC gave go-ahead for the trial under the 2002 act.

The Anti-Corruption Commission (ACC) pressed charges against the duo on July 6 last year for laundering Tk 20.41 crore between 2003 and 2007.

ACC Assistant Director Mohammad Ibrahim filed the case with Cantonment Police Station on October 26 in 2009.

What tipped the scales for you?What particular things pushed you to plan the attack?

For me personally it was our government's involvement (engagement) with/in the attack on Serbia (Nato bombing in 1999) several years ago. It was completely unacceptable the way the U.S. and Western European regimes bombed our Serbian brothers. There have been many other cases that have strengthened my resolve. Among them, my government's cowardly handling of the Muhammed cartoons, and their decision to award the Nobel Peace Prize to an Islamic terrorist (Arafat). There have been dozens of other questions. My government and our media capitulated to Islam years ago, after the Rushdie incident. Since

then it has snowballed.

Thousands of Muslims stream in each year through the asylum, institutions, or family connections in Norway.

What would you say to your European brothers and sisters?

Know that you are not alone in this fight. We have tens of millions of European sympathizers and tens of thousands of brothers and sisters who support us fully and are willing to fight beside us. Hopefully I will be able to help and inspire others. Build your network on Facebook. Follow the guidelines in this book and you will succeed!

If you were to use a word for the ideology or movement that you represent, what would it be?

Cultural conservatism, or a nationalist/conservative

orientation known as the Vienna school of thought. As for the political movement, I would describe it as a National Resistance Movement, an Indigenous

Rights Movement or even a Right-revolutionary move-Areyou optimistic?

I am very optimistic. ultural Marxism/multiculturalism , especially in combination with Islam, will defeat itself. The justification for this claim is that the cultural Marxist and Islamic alliance will not last. When the window of opportunity comes, we must be ready to seize the political and mili-

tary control of all funds. When the time comes, we must not hesitate. We must risk everything for the chance to get our freedom and secure freedom for our

relatives again. I have prepared myself mentally for a very long time and I would like to sacrifice my life for the benefit of my European brothers and sisters.

You said you have pure genealogy?

am very proud of my Viking heritage. My name, Breivik, is a place name from Northern Norway, dating back to before the Viking era. Behring is a pre-Christian Germanic name derived from Behr, the Germanic word for Bear (or "those who are protected by the bear").

I suppose you wanted to tell your friends about this. Has it been difficult to live a "double life"?

First it was extremely difficult to avoid the temptation to tell your closest friends. I decided however to retain all relevant infor-

mation. Revealing sensitive information to any of them would put them in a difficult spot, because they would be required by law to report this information to the authorities. It would also pose a serious threat to me if they decided to tell

anyone. What motivates you? How have you managed to stay focused and motivated for more than 8 years? Is it bitterness and hatred against the so-called "cultural Marxist/the multiculturalism wonderful elites,' or maybe towards Islam? No, not at all. If they (the

cultural Marxists) against all odds, gave up on multiculturalism tomorrow, if they stopped all Muslim immigration and started the deportation of all Muslims, I would forgive them for their past crimes.

If they refuse to surrender until 2020, there will be no turning back. We will eventually wipe out every single one of them. I do not hate Muslims at all. I acknowledge that there are magnificent Muslim individuals in Europe. In fact, I have had several Muslim friends over the years, some who I still respect. This does not mean that I will accept an Islamic presence in Europe. Muslim individuals, who are not assimilated 100% by 2020, will be deported as soon as we manage to seize power. Although I admit that I am sick of the current development, I would say I'm driven by my love for Europe, European culture and Europeans. This does not mean I'm against diversity. But valuing diversity does not mean you support

the genocide of your own culture and people.

How did you first involved in your current activities? When I was around 16-17 years old, I joined the Progressive Party's youth organization (FPU), which was anti-immigration and pro-free market. Every journalist in the country considered the party's members to be racist because of their antiimmigration platform. The Progress Party was under constant attack from every media organization, from NGOs and all other political parties. They were called racists and Nazis, and were generally labelled "fascist pigs." The Progress Party appealed to me because I had seen the hypocrisy in society, and I knew even then that they were the only party that

opposed multiculturalism. Around 2000, I realized that the democratic struggle against the Islamization of Europe, and European multiculturalism, was lost. It is simply not possible to compete with democratic regimes that import millions of voters. 40 years of dialogue with the cultural Marxists / multiculturalists had ended up as a disaster. It would now only take 50-70 years before we, Europeans, were the minority. So I decided to explore alternative forms of opposition. But the biggest problem then was that there were no options for me at all. There was no known armed culturally conservative, or Christian, anti-Jihad movement.
