# Commuters left to suffer

Gridlocks go from bad to worse as traffic regulated for VVIP movement

Zihan Saba was sobbing as she entered her school at 2:18pm yesterday. A student of class two, she was 18 minutes late for her second-term exam.

Saba's mother, who accompanied her to Siddheswari Girls High School on Bailey Road in the capital, said their rickshaw got stuck in apparently a never-ending traffic gridlock at Malibagh intersection.

They waited there for half an hour before starting to walk fast down the road. The kid had already been suffering from nerves.

Cab driver Elias at Sonargaon intersection of Karwan Bazar said it took him around four hours from Hazrat Shahjalal International Airport to Dholaipar in Old Dhaka.

"I started at 9:30am and reached Dholaipar at about 2:00pm--usually a trip of around one and a half hours," he said.

# Metro rail project ready to roll

Loan negotiations, detailed design next month

After a hiccup over a partial change in the route, the \$1.7 billion metro rail project has gained momentum as its major financier Japan International Cooperation Agency (Jica) is set to start loan negotiations with the government next month.

Experts will begin an exercise

next month to prepare a detailed design for the project. It will be completed before signing of the loan agreement in December, Jica officials in Dhaka said.

A three-member team of Jica visited the capital recently to see the progress of the project and prepare grounds for loan negotiations. They held meetings with the officials of

communications ministry and External Resources Division.

The Japanese governmental agency is ready to finance 80 percent of the project cost as soft loan to construct the metro rail, considered the most viable option for transporting thousands of passengers in a densely populated city like Dhaka.

## HOARDING 339 sacks of sugar seized, later released

A government market monitoring team yesterday gave approval to sell 339 sacks of sugar which it had seized earlier from godowns of three traders at Thakurgaon Station Road on charges of illegal hoarding.

The team led by Additional District Magistrate Abdul Khaleq seized 146 sacks from the godown of Shajahan Khan, 159 sacks from Mokbul Hossain's godown and 34 sacks from Yakub Ali's godown on Sunday.

Magistrate Khaleq told The Daily Star the three sugar traders failed to show any valid document of approval for stocking the sugar.

# Fanatic answers his questions

After Friday's dual attacks in Norway, more than 1,500 pages of the writings of the shooter Anders Behring Breivik have emerged -- a manifesto of madness if ever there was one.

The 32-year-old gunman is a Nordic ideal, and for at least nine years, he meticulously crafted his plan to root out anyone different. Breivik's rambling writings, grandly titled 2083: A European Declaration of Independence,

present him as a right-wing nationalist fueled by a combined hatred of Muslims, Marxists and multiculturalists.

As part of the manifesto, Breivik interviews himself, offering a highly personal Q&A in which he throws himself admiring questions and answers them with disturbing calm. This abridged version of Breivik's interview is translated from Norwegian newspaper Bergens Tidende.
