Boy found dead in city ditch

The body was sent to Dhaka Medical College morgue for autopsy.

'Women being empowered but slowly'

Women are being empowered through education and economic activities, yet the pace at which it is happening remains slow, says a study.

"Though more women are becoming educated and economically self-independent and women lead the two main political parties, men still dominate our society", said Naila Kabeer, a professor of the University of London, presenting her keynote paper on the study.

She said, "Programmes such as micro-finance have helped women a lot to earn, but whether they are empowered is still questionable".

The research was carried out under Pathways of Women's Empowerment Research Programme, a five-year programme of Brac Development Institute (BDI), launched in 2006. The study findings were made public in the opening ceremony of a three-day conference titled "Revisioning women's empowerment: New horizons" organised by BDI in Brac Centre auditorium in the city's Mohakhali.

The conference's opening, which also marks closing of the research, was attended by BDI Director Prof Syed M Hashemi, Brac University Pro-Vice-chancellor Dr Golam Samdani Fakir, and Pathways Programme South Asia Coordinator Maheen Sultan, among others.

ment organisations are mainly responsible for environment pollution and degradation though the government can control these bad practices. The industries are polluting water, air and soils, which

Foreign Minister Dr Dipu Moni said yesterday the government would further amend the constitution, if required, for the reality and circumstances in future. "The government put its all-out effort to

present the nation an excellent constitution. If necessary in future, the constitution will be amended further ", she said. Dipu Moni was speaking as the chief guest at a discussion styled "Fifteenth amendment

to the constitution and anti-state politics of opposition" organised by Ekatturer Ghatak Dalal Nirmul Committee in the city's Women's Voluntary Association (WVA) auditorium. The discussion was arranged to mark the

17th anniversary of the killing of five youths by Jamaat-Shibir cadres in Chittagong for protesting against a Jamaat rally. Dipu Moni also brushed aside the opposi-

tion party's allegation that the government amended the constitution hastily. The special committee took 11 months and held 27 meetings for the amendment, she said. She also said it is not possible to imple-

ment all the election pledges within five-

year tenure when the government has to

remove anomalies of the past 40 years. Dipu Moni viewed that BNP and its allies are afraid as the government plugs all the loopholes to stop undemocratic power takeover.

Tuku said BNP is trying to create anarchy in the country to protect the party chief's family interests and the war criminals. BNP launches movement not over the caretaker government system but to make the country unstable and destroy democracy, he added. At the discussion, noted jurist Barrister



Teacher arrested for violating student

A coaching centre teacher of Bagerhat was arrested from the Supreme Court premises yesterday on charge of violating a student.

He appeared before the High Court for bail in a criminal case filed against him.

Police arrested Miskat Sikder, a teacher of Asha Coaching Centre at Gourasta Bazar of Rampal in Bagerhat, around 3:00pm as per a directive of an HC bench of Justice Siddiqur Rahman Miah and Justice Naima Haider.

Assistant Attorney General Md Ali Jinnah told The Daily Star that Miskat aged about 40 is an accused in the criminal case which was filed against him on charge of violating a 14year-old student of the coaching centre.

Victim's father Rafigul Islam filed the case with Rampal police station on June 1 under women and children repression prevention law, he said.

Jinnah said Miskat, who was on the run after the case was filed against him, submitted a petition with the HC through his lawyer seeking anticipatory bail in the case.

Miskat has to face the trial court now in the case, he added.
