# Obama attacks Republicans

President Barack Obama warned of a "deep economic crisis" if the United States fails to raise its debt limit and urged Americans to pressure Republican lawmakers to compromise to avert a default.

In a televised addresss late Monday only eight days before Washington begins to run out of money to pay its bills,

Obama called the weeks-long debt talks stalemate "a dangerous game" that the country "cannot afford to play." As the president spoke from the East Room of the White House, the dollar plunged to a four month low in Tokyo amid growing jitters as the impasse between Republicans and Democrats over the US debt crisis deepened.

Obama cast the blame for the stalemate on the Republicans' refusal to raise the \$14.3 trillion debt ceiling unless there is agreement to make deep spending cuts without increasing taxes on the wealthy.

If Congress fails to raise the ceiling by August 2, the resulting economic disaster could include higher interest rates for the US government as well as for consumers.

Failure to compromise, Obama said in his speech from the White House, "would risk sparking a deep economic crisis -- one caused almost entirely by Washington."

He rejected a Republican proposal for a temporary increase in the debt limit, arguing it would leave the underlying problem unresolved and lead to a repeat of the current crisis in just six months' time.

"That is no way to run the greatest country on Earth. It is a dangerous game we've never played before, and we can' afford to play it now," he said.

With a potential US default as of a week from yesterday, Obama appealed to Americans to "make your voice heard" to members of Congress.

Many Americans appeared to have heeded the president's call.

US media reported that various congressional websites -- including those for prominent Republicans like House Speaker John Boehner, House Majority Whip Kevin McCarthy, and congresswoman and presidential contender Michele Bachmann were inaccessible, after an apparent server crash following the speech.

Obama's primetime speech late Monday was only his seventh formal address to the nation, and the first since he unveiled a timeline for a US troop withdrawal from Afghanistan in June.

Boehner, the Republican leader of the US House of Representatives, responded with a late-night speech of his own, blaming Obama for the crisis and warning that while the US cannot default on its debt obligations, Americans nevertheless would demand deep spending cuts.

Boehner -- who has flatly rejected Obama's call to increase taxes on the rich and wealthy corporations -- is proposing a two-step plan with debt increases first to February or March 2012, and later to 2013.

Only three of the convicted -- Ayub, Russell and Rubel -- are now in custody. Most of the convicts are

accused in numerous criminal cases including murder.

The accused acquitted are Shakhawat Hossain, Killer Abbas, Zakir Hossain, Kamal Hossain, Ibrahim Khalil and Nazmul Hossain alias Benga Babu. They are now in jail. Deputy Attorney

General Bhishmadev Chakraborty told The Daily Star that the HC acquitted the six accused as the allegations brought against them were not proved beyond doubt.

The HC bench of Justice Md Fazlur Rahman and Justice Bhabani Prasad Singha yesterday delivered the verdict after holding hearing for eight working days on the death reference and appeals filed by the accused against their convictions.

Newton's widow Ferdousi Ahmed Mishty told The Daily Star that she is upset with the verdict and that life will be at stake if killers are acquitted.

Mishty, now a DCC ward commissioner, is sister of former BNP lawmaker Nasiruddin Ahmed Pintu, who is detained in jail in connection with Pilkhana headquarter carnage in 2009. She said her husband was also the assistant general secretary of BNP's youth front Jatiyatabadi Chhatra Dal.

On May 24, 2006, the Speedy Trial Tribunal-1 in Dhaka had awarded capital punishment to Khorshed, Shahadat, Kiran, Kala Jahangir, Abbas, Ibrahim, Ismail, Pial, Sagor and Zakir in connection with Newton murder case.

The tribunal had awarded Ayub, Russell, Rubel, Shawkat, Benga Babu and Kamal life term imprisonment and acquitted Ripon Khan and Raqibul Bari as the charges brought against them were not proved.

mobile phone companies and IT platforms offering card based financial service delivery," said Rahman.

He said authorities would use anti-money laundering regulations to check anomalies in the microfinance sector.

Rahman also said the country's microfinance institutions should go beyond their financial services and adopt more human and social visions for the greater benefit of society.

Prof David Hulme, head of Institute of Development Policy and Management at the University of Manchester, UK, said MFIs need to be more honest and humble about their products to overcome the current ingpoverty. impasse.

transparent about their charges, terms and conditions."

He urged the MFIs to introduce low cost systems to reduce the likelihood of client abuse and improve social performance.

He also said microfinance is one small part of a national strategy for poverty reduction. "So we need to get it into perspective and keep it working effectively."

Prof Syed M Hashemi, executive director of Brac Development Institute, said the MFIs in the country have both positive and negative sides. "But we should not look at it as a financial tool only."

He said both academics and politicians have labelled MFIs as bloodsuckers, without understanding the financial lives of the poor.

"It is quite difficult for

banks to go and operate in the rural areas with such a low interest rate," said Hashemi.

Prof MA Baqui Khalily of Dhaka University finance department said MFIs have to be efficient and competitive to survive.

He also ruled out claims that micro-loans are only used for unintended purposes. "We have found that two-thirds of the loans are used to expand economic activities."

He urged the government to sit with the MFIs regularly to sort out differences and fix anomalies.

Former Education Minister Osman Faruque said the government should conduct a study to know whether microcredit has any impact on alleviat-

He bashed the critics of "They should be more microcredit. "In Bangladesh, the critics were more ruthless and were driven by personal or political reasons. But they were among politicians not the real borrowers."

"There is also no scope to brand MFIs as bloodsuckers when the break even is 23 percent," said Faruque.

He called for effective regulation. "But we cannot forget that in Bangladesh, many regulatory bodies have killed the baby."

Lawmaker Hasanul Haque Inu urged political and social activists in Bangladesh not to say "no" to microcredit. "Rather, they should cheer them up to perform better."

Qazi Kholiquzzaman Ahmad, chairman of Palli Karma Sahayak Foundation, said: "We need to get answers on how do we can isolate the impacts of microcredit. What is the borrowers' employment status, although MFIs have created huge jobs within themselves? How long will the borrowers remain borrow-

"We need answers. Otherwise, the MFIs will not be sustainable, and we will not be able to measure the impact," he said.

The economist said there are many MFIs who are charging 40 to 60 percent as interest. "We have

to address it." **CPD Executive Director** Professor Mustafizur Rahman also spoke.

# Newton murder case Free Suchitra Sen's house

bigots had occupied the house for 24 years. Suchitra Sen along with her family left Pabna a few months before the partition of the sub-

continent in 1947.

Over the years successive governments extended the single-year lease Jamaat-e-Islami took of the house in 1987 in phases, ignoring demands from intellectuals and general people to reclaim the house from the clutch of religious fundamentalists, reports our Pabna correspondent.

Finally the HC directive came as a beckon of hope for the local people to have the house reinstituted in accordance with their longstanding demand of turning it into a museum, shedding lights on the life of the heartthrob actress and evolution of Bangla film as well.

"The entire Pabna is happy with the verdict. I believe it is news of joy and hope for every conscious and progressive individual of the country," said Saidul Haque Chunnu, convener of Suchitra Sen Smrity Shangrakkhan Parishad in Pabna, a forum comprising cultural activists and intellectuals to press home their demands.

The HC directive to take appropriate legal action against the grabbers holds great importance for the local people, who witnessed how the house on 21 decimal of land underwent a change in construction as the Imam Gazzali Trust run by Jamaate-Islami extended its business in education using the

Once accommodating only five brick-built rooms, the house now has extra five corrugated-iron-sheetmade rooms to accommodate about three hundred students of Imam Gazzali Institution, a kindergarten

run by the Gazzali trust. Earlier, the trust ran a high school and college on the compound. The institutions were relocated to their

own property at Raghabpur village after those were listed on the MPO.

"We are maintaining the school in Suchitra Sen's residence after taking lease of the land from the district administration," said Abid Hassan, secretary of the Gazzali trust and ameer of Jamaat's municipal unit.

"People labelled the institution as one of Jamaat's organisations, but this is only an educational institution, not an institution of a particular party," he claimed.

However, Jamaat even tried to have the house as its own property in 1991, immediately after the BNP-led alliance assumed power.

The then government could not hand over the house due to some technical difficulties over the land survey but suggested that the trust continue occupying it by renewing the lease every year until the matter is finally settled, Hassan informed.

demand of reclaiming the boost as the two countries house after the AL-led grand alliance assumed power, the district administration cancelled the lease last year. The kindergarten however challenged the cancellation with the HC, drawing a stay order on operation of the cancellation.

"On receipt of the court order we will take next decision after consulting our counsels," said Aiyub Ali, a teacher of the kindergarten who challenged the cancellation order.

The HC has made the deputy commissioner, superintendent of police and officer-in-charge of Pabna police to act in compliance with its directives and report back in 10 days.

A public interest litigation filed by Human Rights and Peace for Bangladesh (HRPB) drew a series of directives from the HC that ruled the government to explain in two weeks why its

inaction to take action against the grabbers should not be declared illegal.
