US 'almost out of time' for debt deal: Obama

President Barack Obama yesterday warned the US was almost of time to agree a debt ceiling deal as Republicans and Democrats scrambled to find a way out of an impasse and avoid a disastrous default.

With just days to go until the United States could be pushed into an unprecedented default, Obama insisted the warring sides could still reach an 11thhour compromise on raising the \$14.3 trillion debt ceiling.

"This is not a situation where the two parties are miles apart," Obama said despite a months-long bitter war of attrition now going down the wire to a Tuesday deadline when the US is set to run out of money to pay its bills.

Both sides were "in rough agreement" on how much spending can be cut "responsibly," and on the steps to take in the coming months on tax reforms as well as some kind of enforcement mechanism, Obama said.



"So there are plenty of ways out of this mess. But we are almost out of time. We need to reach a compromise by Tuesday so that our country will have the ability to pay its bills on time as we always have."

A key sticking point has been how much the debt ceiling should be raised by and over what period: Obama has called for it to last through the November 2012 elections with Republicans insisting on a much shorter time-frame.

Warnings have flooded that the political battles in Washington could

harm economies around the world, and threaten a fragile global recovery.

Chinese media attacked the United States over the debt wrangling, warning it could plunge the world into another recession.

China is the top holder of US debt with holdings at \$1.16 trillion in May, according to US data, and has raised concerns about its investments.

A default could hurt the US dollar and trigger a "torrential flood" of liquidity into the global economy, fueling inflation in emerging economies such as China, the Communist Party mouthpiece People's Daily said.

China's official Xinhua news agency also accused US lawmakers of being "dangerously irresponsible" and warned they risked "strangling the still fragile economic recovery."

A Republican initiative stalled Wednesday amid a revolt by unruly arch-conservative Tea Party members who refused to back Republican House Speaker John Boehner's plan.

Apple has more cash than USA

Apple has more cash to spend than the United States government, a report said yesterday.

Latest figures from the US Treasury Department show that the country has an operating cash balance of \$73.7bn. Apple's most recent financial results put its reserves at \$76.4bn.

The United States is currently spending around \$200bn more than it collects in revenue every month.

In the three months ending 25 June, Apple's net income was 125% higher than a year earlier at \$7.31bn.

With more than \$75bn either sitting in the bank or in easily accessible assets, there has been enormous speculation about what the companywill do with the money.

Mumbai attacks gunman appeals death sentence

The lone surviving gunman from the 2008 Mumbai attacks that left 166 dead has filed a case at the Indian Supreme Court asking for his death sentence to be overturned, a court source told AFP yesterday.

Aimal Amir Kasab The source said Mohammed Ajmal Amir Kasab had sent an appeal against his conviction and sentence via jail authorities in Mumbai, where he has been held since the attacks, which has been lodged with the court's secretary general.

"He filed the appeal through the Arthur Road jail authorities," the source said, asking not to be named.

Pakistani national Kasab, one of 10 Islamist gunmen who laid siege to Mumbai for nearly three days, was convicted by a trial court in the Indian commercial and entertainment capital in May 2010.

The first appeal by the 23-year-old school drop-out from a poor farming area in Pakistan's Punjab state failed in February, when the state high court confirmed his death sentence.

Lawyer Ujjwal Nikam, who prosecuted the Mumbai's main railway station.

case in Mumbai, confirmed to AFP that "he (Kasab) has made the appeal proposal to the Supreme Court" without giving further details.

No one was immediately available for comment at the high security Arthur Road jail in south Mumbai, where Kasab is being

held in solitary confinement. One of Kasab's legal team for his appeal to the Bombay High Court in February, Farhana Shah, said that it was likely that her former client would be appointed a lawyer from the legal aid bench in New Delhi.

India has the death sentence, which is carried out by hanging, for the "rarest of the rare" criminal offences.

Kasab was found guilty of a string of crimes including waging war against India, murder, attempted murder and terrorist acts after a trial at a maximum security prison court in Mumbai.

During the trial, the prosecution produced fingerprint, DNA, eye-witness, CCTV and other evidence showing him opening fire and throwing grenades in the bloodiest episode of the November 26 attacks at

Storm, landslides kill 59 in South Korea

South Korean city planners and developers were blamed yesterday for allegedly causing "man-made" disasters that killed at least 59 people and left thousands homeless after record rainfall this

Among the dead were 16 killed when mudslides hit southern parts of Seoul on Wednesday and 13 who perished in a landslide in the Chuncheon region, 100 kilometres (60 miles) east of the capital.

Three others died in a landslide at Paju north of Seoul.

Experts and news media attacked local authorities in Seoul, accusing them of making the situation worse through an allegedly reckless development of hills near residential areas in the south of the capital.

Some hillsides were redeveloped into public parks and hiking tracks, meaning rainwater could not be absorbed so easily, and natural waterways were changed to make artificial lakes, crit-

Indian cabinet approves new anti-corruption bill

The Indian cabinet on Thursday cleared a draft of legislation to set up an anticorruption ombudsman (Lokpal) that excludes from its purview the Prime Minister, the Chief Justice of India and members of Parliament for their actions inside the House.

The Bill, expected to be presented in the monsoon session of parliament beginning August 1, drew sharp reaction from the civil society led by Gandhian Anna Hazare which dismissed it as a "jokepal" and Hazare himself announced that he would again go on a fast from August 1 to protest a stronger anticorruption watchdog.

The Bill provides for inquiry into allegations of corruption against the Prime Minister only after he or she demits office.

The civil society had wanted the Prime Minister and the judiciary to come under the ambit of the Bill.

Briefing mediapersons, Information and Broadcasting Minister Ambika Soni said Prime Minister Manmohan Singh had insisted that his office be included within the ambit of the Bill but the cabinet decided otherwise, considering that such a step would affect the stability of the government of the day.

It envisages the setting up an anticorruption ombudsman to probe charge of graft against a federal minister or top officials starting from the rank of undersecretary and above without the need for any sanction.

The Bill also envisages a separate investi-

gation wing for the ombudsman but does not give it any power to prosecute anyone and it would instead recommend prosecution to the Supreme Court.

A 10-member committee, comprising five ministers and five civil rights leaders, was set up in April to draft the bill, but the two sides prepared separate versions following sharp divergences on key issues.

Terming the Bill approved by the cabinet as "unacceptable", Anna Hazare, who had launched a movement in April this year with a fast demanding a strong anti-corruption watchdog, said he would begin a hunger strike on August 16 for a revised bill that would be "effective and strong".

Arvind Kejriwal, another activist opposed to the current Lokpal Bill, said there was "nothing for a common man and added that the issue of corruption has been completely left out of it.

Lawyer Prashant Bhushan, another member of civil rights group, said none of the major scams of recent times like the Adarsh Housing scam, the Commonwealth Games scam, the illegal mining scam, cash-for-vote scam, fodder scam is covered by government's Lokpal.

A series of corruption scandals, including the biggest one relating to sale of telecom license to private operators, has hemmed the Congress-led UPA government since last year and saw the arrest of two leading politicians including India's former Telecom Minister A Raja belonging to Congress ally Dravida Munnetra Kazgagham.

Blast kills 18 civilians in Afghanistan

Eighteen civilians died when a roadside bomb destroyed their minivan in southern Afghanistan's Helmand province yesterday, a day after a Taliban attack in Uruzgan killed 21 people.

The latest bomb blast came as UN figures show civilian deaths are up 15 percent in the first half of this year, reaching record levels in the long war between insurgents and the Kabul government that is backed by Nato-led troops.

Afghan General Sayed Malook said the vehicle was in Nahri Sarraj district, travelling to the provincial capital Lashkar Gah 35 kilometres away, when it was hit.

In a separate incident in Helmand yesterday, one person was killed and four others wounded when their tractor hit an improvised bomb in the Garmser district, officials said.

Cheap and easy to make, improvised explosive devices or IEDs are the Taliban's favoured weapon, responsible for the majority of civilian and security forces' deaths in the nearly 10-year war.


