# NEWS IN brief Jewellery shop looted in N'ganj

Masked raiders looted gold, silver, and cash worth about Tk 40 lakh from a jewellery shop at Siddhirganj Bazar of the sadar upazila early yester-

Some 10-12 robbers entered the shop breaking the lock after holding security guard Abdul Motalib hostage at gunpoint, shop owner Sirajul Islam quoted Motalib as saying.

They looted 65 tolas of gold, 200 tolas of silver, and Tk 92,000 in cash and also took away the vault of the jewelleries on a pick-up van.

Siddhirganj Police Station Officer-in-charge Kamrul Alam confirmed the incident and said they are trying to recover the looted stuff.

### Traders stabbed in city

A gang of snatchers stabbed a trader and snatched Tk 84,000 from his possession in the city's Mirpur area yesterday.

The injured is Razu Sheikh, 40, an egg trader, of Bihari Camp of Mirpur, Section No-11.

Police said the 6-7 members gang of snatchers swooped on him with lethal weapons in front of Mohammadi Market of the area in broad daylight and hacked him on his head and neck.

He was rushed to Dhaka Medical College Hospital in a critical state.

### BMP condemns fatwa

Bangladesh Mahila Parishad (BMP) expressed resentment towards an incident in Thakurgaon where a housewife was imposed with the fatwa of 'hilla marriage' (marriage with a third person), said a press release yesterday.

BMP also demanded that the culprits be arrested and punished upon investigation into the incident.

Abdullah of Haragachpara village in the district's Sadar upazila divorced his wife Karuna Begum through an affidavit and evicted her from the house along with their child, the release said.

When she asked for help from the local UP chairman, he sent her back to her husband's house where some locals imposed the fatwa upon her, it added.

## HC questions ACC act provisions

The High Court yesterday questioned the legality of the Anti-Corruption Commission (ACC) rules that empower it to charge people with amassing wealth beyond known sources of income and concealing the information about it.

An HC bench issued rules on the government and the ACC asking to explain within four weeks why sections 26(2) and 27(1) of the ACC act should not be declared illegal and unconstitutional.

The ruling came in response to separate petitions by Abdul Mannan, an Awami League lawmaker from Bogra, and his wife Sahadara Mannan.

The ACC on July 4 filed two cases against the couple under the two sections.

During the immediate past caretaker government, the

commission sued many top politicians, government officials and businessmen under those provisions.

Abdul Mannan and his wife recently challenged the two provisions saying the income tax law allows an accused to get acquitted of the charge of dodging tax by paying 10 percent tax on the income. But the commission filed the cases against them without giving them an opportunity to seek remedy under the law.

In response to their petitions, the HC bench of Justice Bazlur Rahman and Justice M Enayetur Rahim asked the government and the commission to explain why the proceedings of the cases against them should not be declared illegal.

Advocate SM Zahurul Islam appeared for the petitioners and advocate Khurshid Alam Khan for the ACC. Deputy Attorney General Amit Talukder represented the government.

Manmohan will be accompanied by chief ministers of all the Northeast States neighbouring Bangladesh.

"This reflects our desire to have across the border engagement with Bangladesh, so that the fruits of our cooperation are available to people on both sides of the border," he tum." said.

Manmohan said Bangladesh and India are today witnessing an extraordinary period of cooperation and friendship.

The Transparency International Bangladesh yesterday differed on the communications minister's claim made on Sunday that he communicates all development-related decisions to TIB to ensure transparency in the ministry.

TIB Executive Director Dr Iftekharuzzaman said the documents sent by the ministry are inadequate to evaluate its transparency. TIB has not enough scope to conduct investigations required to evaluate and certify transparency of the ministry, he said in a statement.

TIB proposed an Integrity Pact to the communication ministry fearing possible corruption over the construction of the Padma Bridge and talked about it with Communications MinisterSyedAbulHossain, but hedidnotrespond, hesaid.

Iftekharuzzaman said the minister also pledged to implement the recommendations, made by TIB on March 2009, on preventing corruption in communication sector. TIB is yet to see any steps regarding the matter, he added.

## BNP blocked search for masterminds

Reveals Wikileaks

The four-party alliance led by Bangladesh Nationalist Party (BNP) blocked the investigation process of finding out the masterminds of the killing of AL leader Ahsanullah Master to protect BNP's top leaders.

On April 18, 2005, the then US ambassador to Bangladesh Harry K Thomas, quoting reliable sources, in a cable report, informed Washington about the incident that was published by whistleblower Wikileaks on August

Thomas said the then ruling government blocked police investigation about involvement of BNP's top lead- two died. ers into the gruesome murder.

On May 7, 2004, Ahsanullah Master, a sitting member of Bangladesh Jatiya Sangsad, was shot dead in broad daylight at a meeting at Gazipur district.

One year after the killing, a speedy tribunal court sentenced 22 people to death while handed over six others lifetime imprisonment on April 16, 2005 for the murder.

Charge to be

Charge will be framed on September 15 against Jamaat-e-Islami leader Delwar Hossain Sayedee in a tax evasion case. Judge Mohammad

Mozammel Hossain of the Special Judge's Court-3 fixed the date yesterday after hearing both the sides. Syedee, also an accused

for killing people during the War of Liberation in 1971, was produced before the court during the hearing.

Meantime, Sayedee's lawyer submitted a petition seeking an adjournment of the hearing saying that they had earlier filed a writ petition with the High Court (HC) challengingthelegality of the case.

After the hearing, the HC issued a rule upon the government to explain why the proceeding of the case should not be declared illegal. But the rule remained pending for hearing. So, Sayedee's lawyer prayed for an adjournment of the hearing.

But the court asked the prosecution to explain on what basis the charge would be framed against the accused.

The court also asked Sayedee's lawyer to submit by the scheduled date any order of the HC regarding quashing the proceeding of the case.

Masuma Kahtun, deputy tax commissioner of the National Board of Revenue (NBR), filed the case on August 19 last year against the Jamaat leader on charge of dodging income tax of Tk 56.45 lakh for the fiscal years from 2005-2006 to 2009-2010.
