AWFULLY SLOW, IRREGULAR SERVICE

Trains do not attract people of Kurigram anymore

Once popular among common people, train journey now repulses most of the passengers in Kurigram district as the cheap mode of transport has become awfully slow and irregular due to ramshackle rail lines.

More than one hundred shopkeepers and restaurant owners at eight railway stations in Kurigram district have changed their business during the last few years as their customers, mostly trains passengers, are much less due to irregular train service.

There are eight railway stations on 53-km railway line in the district. The stations are Singerdabri, Kurigram, Pachpir, Ulipur, Balabari and Ramna.

mail train from Parbatipur Railwar Junction in Dinajpur district and another local

train from Lalmonirhat Railway Junction plied the railway route two times everyday.

Then the railway stations remained busy as a large number of local passengers used train for movement while a good number of people ran restaurants, teastalls, groceries and dispensaries in the station areas.

About seven years ago, the earth under the railway lines got loose due to heavy rainfall and lack of proper care. Consequently, the train service on the route became irregular, prompting local passengers to opt for movement by bus, despite its much higher fares.

As the shopkeepers' sale drastically fell for want of Rajarhat, Tagraihat, customers, they changed their business. About 35 traders in Kurigram station About 15 years ago, one area, seven at Singerdabri station, 12 at Rajarhat station, five at Tagraihat station, six at Pachpir station,

15 at Ulipur station, eight at Balabari station and 25 at Ramna station stopped their business during the last few years.

"I sold my hotel here eight years ago as I had to incur losses in absence of customers, who were mainly train passengers. Due to irregular train service, the number of passengers has seriously fallen at the station," said Md Tamir Uddin, 57, who earlier ran a hotel at Kurigram Railway Station

Md Mojibur Rahman, 53, also closed his hotel business at Kurigram station seven years ago. He now works as an electric mechanic.

"Tk 6 is taken as fare for Ramna-Kurigram route, Tk 10 for Kurigram-Rangpur and Tk 15 for Ramna-Rangpur route from a train passenger whereas a bus passenger has to count Tk 35, Tk 65 and Tk 100 cover

the distances. But most passengers avoid train journey," said Kurigram Railway Station Master (in-charge) Md Kabir Hossain.

"About 20-km rail line from Pachpir station to Ramna station is not fit for proper movement of trains. And so, the schedule for train cannot be maintained. Besides, train service in Kurigram district is being hampered due to shortage of railway engines and drivers," he added.

Railway Divisional Traffic Superintendent in Lalmonirhat Division Md Mostafijur Rahman told this correspondent through cell phone, "Arrival of train is delayed as it has to run only 10km per hour on Pachpir-Ramna line. Repair work of the line is going on. The work is likely to be complete this year. Process is also on to appoint necessary staff."



demanding early solution to their problem through India-Bangladesh enclave exchange deal to be signed during Indian

Enclave people upbeat as two neighbours ink deal today

Thousands of people living in enclaves inside Bangladesh and India are eyeing a new life as the two countries are set to sign a bilateral deal to exchange the adversely possessed lands during Indian Prime Minister Manmohan Sing's two-day visit to Bangladesh starting today.

The enclave people expressed hope that the bilateral deal to be signed in line with the India-Bangladesh land boundary agreement of 1974, popularly known as Indira-Mujib Pact, will enable them to get all the rights and facilities as lawful citizens, reports our Thakurgaon correspondent.

During this correspondent's visit to Garati enclave adjacent to Hafizabad and Haribhasha union parishads under Panchagarh Sadar upazila on Sunday, the residents described their miserable life in absence of basic rights for decades.

The enclave people live in awful conditions amid lack of adequate employment opportunity, infrastructure, educational institutions, electricity and medical facilities. Most of the people are living below poverty level," said Abdul Latif Sarkar, chairman of Garati Enclave Sarbamongal Committee.

Freedom fighter Md Ayub Ali, Ansar Ali and others said they are hopeful of living a healthy life with basic amenities as citizens after exchange of the enclaves between two countries.

According to a recently conducted joint survey of the two countries Bangladesh has 51 enclaves comprising around 3,000 acres of adversely possessed land inside India while India has 111 enclaves comprising 3,500 acres of such land

inside Bangladesh. Indian enclaves inside Bangladesh are situated in Panchagarh, Lalmonirhat, Kurigram and Nilphamari four districts while all of the Bangladeshi enclaves are in Indian Cooch Behar district.

Around a thousand people living in Indian enclaves

inside Panchagarh district resident of Sreerampur Bangladesh. brought out a procession in enclave in Burimari union Panchagarh town and under Patgram upazila. placed a memorandum to Prime Minister Sheikh Hasina through the deputy commissioner of Panchagarh yesterday demanding immediate solution of the enclave issue.

Barisal University (BU), the only general public university of the division and 33rd public university in the country, Sunday evening announced its admission schedule for the first batch under 2011-12 academic

The schedule was announced after the meeting of the admission committee presided by vice chancellor of the university Prof Dr Harunor Rashid

According to the decision, 65 students in Mathematics department under Science faculty, 65 in English department under Humanities, 65 each in Economics and Sociology

each in Marketing and Business Management of Business Studies faculty, would

be admitted.

Application forms would be available from the website and office of the university from September 21. Those would be accepted till October 20 with Tk 300 for each form to appear at the admission test. GPA-7.5 in SSC and HSC

results without fourth subject for science (Ka-unit), GPA-6.5 for humanities and social science (Kha-unit) and GPA-7 for business (Gaunit) faculty subjects would be required to qualify for admission test while 80 marks would be counted for HSC and SSC results.

Those who passed SSC

before 2007 and 2009 are eligible to apply. A 100-mark written

admission test in MCQ system would be held on December 2 and selected candidates qualifying in written test would appear for a 20-mark viva.

The university authority also decided to take steps for appointing teachers as per BU Act and starting classes as per schedule of other public universities.

At least 24 teachers would be appointed in first phase following the BU Act and advertisement for appointing them would be published within this month, sources at BU said.

Classes would start on the temporary campus of the university at Barisal Zila

Eight children including two siblings drowned in ponds and rivers in Gazipur, Chuadanga, Kushtia and Moulvibazar districts yesterday, Sunday and the day before.

In Gazipur, three school children including two siblings drowned at Korihata village under Kapasia upazila yesterday, reports our correspondent.

The deceased are Roktim, 11, son of Momen Master and his younger sister Aysha Siddika, 9, and their cousin Ashik, 10, who came to visit their family recently. They were studying in classes six, four and five.

Abul Mohsin, uncle of the deceased said four children went missing around 12:30pm yesterday. After a hectic search for an hour, locals

found Jishan, one of the missing four. Later, as per Jishan's statement, locals started searching a ditch near Momen Master's house where they found the other missing children and took them to Kapasia health complex. However, the on-duty doctor declared them dead.

Eight kids drown in four districts

In Chuadanga, Class-III student Nayem and Class-I student Rizvi drowned. They were cousins. In another incident, Class-III student Ashik drowned in Kushtia.

Nayem, 11, son of Anwarul Islam and Rizvi, 7, son of Abdur Rashid of Sadar upazila in Chuadanga went to the Mathabhanga river with their uncle Zinarul at about 12:30pm. Zinarul went there to bathe his cows, reports our Kushtia correspondent.

After bathing the cattle, Zinarul could not find his nephews and thought that they had returned home.

When Zinarul told the matter to the family members, they launched a search in the area but
