Attempt on boy's life

A schoolboy escaped an alleged attempt on his life at Chameshwari village under Sadar upazila on Tuesday. Bappy Roy, 08, son of Atya Roy of the same village and a student of class-II at Chowdhuryhat Registered Primary School in Sadar upazila is now undergoing treatment at Thakurgaon Sadar Hospital. Mother of the boy Putul Roy told this correspondent that the boy was trying to ride his father's bicycle with his younger brother Sumon Roy on the road in front of their house. At one stage, they went in front of Shombhu Roy's house, about 100 yards away where his bicycle hit Kolim Roy, 30, son of Shombhu Roy. Kolim was returning home with his cattle. Agitated Kolim held Bappy with a piece of rope around his heck and started to drag him on the ground. Local people rescued the boy hearing his screams. The victim's mother claimed that it was not a joke, it was an attempt to murder.

Youth jailed for stalking

KAPTAI LAKE STRIKE CALLED OFF

Fresh charges on fishing won't be imposed now

Fishing in Kaptai Lake has resumed as fish traders, fishermen and workers withdrew their indefinite strike yesterday after assurance from the district administration not to impose the increased charges for now for catching different species of fish.

As per the decision of an emergency meeting, a seven-member committee headed by ADC (Revenue) Md Khalilur Rahman will re-fix the rates and sent it to the head office of Bangladesh Fisheries **Development Corporation** (BFDC) for approval, said Harunur Rashid, president of Kaptai Hrad Motsya Babosayee Samobay Samity.

stopped on September 1 as fish traders, fishermen and FY, said BFDC sources.

workers went on indefinite strike protesting new charges unilaterally fixed by the BFDC.

On Tuesday, they organised a protest rally on the premises of Rangamati deputy commissioner's office and sent a memorandum to the fisheries and livestock minister through the deputy commissioner.

Earlier the authority raised charges for catching different categories of fish through consultation with fishermen and traders but this time the rates were increased even without calling any meeting, the protesters said.

Authorities received about Tk 7 crore as revenue for 8900 tonnes of fish caught from Kaptai Lake in 2010-2011 fiscal year (FY) while the amount was Tk 6 Fishing in Kaptai Lake crore for around 7000 tonnes of fish in 2009-2010

TENDER SCAM

Bail prayers of 11 AL men turned down

A Rangpur court yesterday rejected bail prayers of 11 Awami League men including a minister's assistant personal secretary (APS), held on Tuesday on charge of involvement in a tenderdropping related violence in the district.

Earlier, bail prayers were moved before the court of the Chief Judicial Magistrate of Rangpur.

Twenty-two people were arrested after a clash over dropping of tender for construction of Lalmonirhat town protection dam. The AL activists allegedly chased the contractors and police out of the Rangpur WDB office.

While the rest were released, police produced the aforesaid 11 before the court which sent them to jail rejecting their bail prayers. The lawyers of the accused later told newsmen that they would move to higher court for seeking their bails.

Meanwhile, president of Rangpur district unit AL Abul Monsur Ahmed claimed that Sajjad Hosain, the APS to state minister for primary and mass education, went to the Water Development Board office in Rangpur for official work on Tuesday and he had no connection with the tenderrelated clash.

Superintendent of police Saleh Mohammad Tanvir, however, said that the complainant of the case identified Sajjad Hossain and 10 others as the people who stood on his way to submitting tender documents. After verifying the video footage police arrested them, added the SP.

Prisoner runs away from court area

An under trail prisoner ran away from the court area when he was being taken to Additional District and Sessions Judge court yesterday.

The prisoner was identified as Sirajul Islam, 35, son of Abdur Rahman of Torra village under Haripur upazila in Thakurgaon, an accused in an arms case.

Court sources said, at 11:30am, court police brought Sirajul to court. When they reached the veranda of the court the prisoner wanted to go to toilet to respond to nature's call.

Constable Rafiqul Islam took him to the toilet. When Sirajul came out constable Rafiqul entered the toilet asking Sirajul to wait a while. Taking this advantage, Sirajul ran away from the

Court sources said, people of Ranishankoil detained Sirajul with a pistol on 26 December 2010 at 9:30pm from Vandara village while attempting to mug and later handed over to police.

Sub-Inspector Syed Abu Taleb filed an arms case against Sirajul the next day.

After investigation, subinspector of Ranishankoil police station and also IO of the case Rabiul Islam submitted charge sheet against Sirajul on 13 January, 2011.

ALLEGED RAPE ATTEMPT

Kasba OC yet to be arrested

Law enforcers are yet to arrest Kasba Police Station officer-incharge (investigation) accused in an attempted rape case.

Inspector GM Mizanur Rahman, is the prime accused in the case for bid to rape a college girl in Chittagong one and half a months ago.

During his official tour of Chittagong on July 11 Mizanur and one of his friends picked up a college girl from Foy's Lake area and confined her to his rented room at Al-Akaba Hotel at Chawk Bazar in the port city.

He tortured the girl and tried to rape her. Relatives of the girl rescued her from the hotel room the same day in an unconscious state and filed a case against Mizanur with

Panchlaish Police Station. Immediately after filing of

the case, police arrested Al-Akaba Hotel Manager Md Shamsuddin and employee Md Tajul Islam on charge of helping Mizan to escape from the hotel.

On July 14, Chittagong Metropolitan Police (CMP) asked Brahmanbaria district police office and Kasba Police Station to arrest Mizanur in connection with the attempted rape case and produced him in a Chittagong court. But the law enforcers could not

arrest him as of yesterday. Police said Inspector GM Mizanur Rahman went to Chittagong to give his statement before a court in a case filed while he was working as sub-inspector of the Detective Branch of CMP.

Two women commit 'suicide'

took poison over a family feud at about 1:30pm. Family members rushed her to Thakurgaon Sadar Hospital but she died at Dholar on the way to hospital.
