2 JU students, 2 others arrested

Bidhan confesses link with SQ Chy

Arrested top criminal of the port city's Raozan upazila, Bidhan Barua, yesterday confessed to his political link with detained BNP leader Salahudin Quader Chowdhury.

"My involvement with his political party will keep me alive. If I quit that party I might be killed," said Bidhan, 46, while talking to the journalists at Chittagong Rapid Action Battalion (Rab-7) office at Patenga yesterday.

After remaining absconding abroad for last six years, Bidhan was arrested by a Rab-7 team led by Major Ashfaque from a house of one Yusuf Alam near Lemua Bridge at East Silonia village in Feni around 2:30am on Friday.

Rab-7 Commanding Officer (CO) Lt Col Abu Hena Mostafa Kamal yesterday said Bidhan was staying at the house in guise with changed appearance and a fake name of 'Yusuf Ali'.

Same day, Rab men took Bidhan to his native village Adharmanik at East Guzra union under Raozan upazila and recovereda9mm pistol, two bullets and a magazine from his house there.

According to Rab and police sources, Bidhan was accused in 18 criminal cases including five murder cases filed with Raozan Police Station. He is also an accused in several other cases filed with different police stations in Chittagong, sources added.

Rab-7 CO Kamal said they extracted important information from Bidhan during interrogation.

Rab was monitoring Bidhan's position for last three years, said Kamal adding that, Bidhan went to Qatar in 2005 to escape arrest, worked at a firm there and returned to the country three weeks later.

Bidhan said he came back to meet his family and denied any political instruction behind his return.

Bidhan denied his direct involvement with any murder, but he said to have accompanied others in crimes including murder.

Mentionable, Bidhan became a close aide of SQ Chowdhury after joining SQ's founded political party National Democratic Party as a cadre in 1990s and was involved in criminal activities at Raozan, Rangunia and other parts of Chittagong after forming his gang 'Bidhan Bahini'.



British national yet to be remanded

Police are yet to remand a British national arrested in Dhopadighirpar area of Sylhet city on September 6 on charge of alleged sexual abuse on a 15-year-old Bangladeshi boy for about a year.

Sub-Inspector Kefayet Ullah of Kotwali Police Station, also the investigation officer of the case, said chief judicial magistrate of Sylhet granted a three-day remand on September 8.

They are waiting to consult police high-ups before interrogating the arrested Peter Ellison, 55, hailing from Bow area of Mile End in London of the United Kingdom, he said.

It may be done today or tomorrow, he added.

There is no specific time frame as to when the remand should actually start, said Deputy Commissioner of Sylhet Metropolitan Police Rezaul Karim.

LOOTING OF GOLD JEWELLERY

Court sends three minors to juvenile dev centre

Three children landed in National Juvenile Development Centre in Gazipur yesterday after police produced them before a Juvenile Court in connection with looting 80 tola gold jewellery from a house in the city's Lalbagh area.

They are Pakhi, 10, her brother Barek, 11, and cousin Mirajul, 10.

Pakhi has been a domestic help at the house of garments businessman Mahbubur Rahman at Nawabganj in Lalbagh.

On September 3, unidentified persons made Mahbub's daughter Nitu, 22, unconscious and looted the jewellery, officer-in-charge of Lalbagh Police Station said.

The kids admitted that Mirajul gave some powder-like substance to Pakhi and told her to mix it with juice prepared for Nitu, claimed law enforcers.

Nitu received treatment at Dhaka Medical College Hospital, sources at the

hospital noted.

Police on the following day picked up the minors, Pakhi's uncle Moksed and his wife Sajeda for interrogation.

Pakhi was detained from her master's house at Nawabganj and the rest four were picked up from their house at Kamrangirchar just outside the capital, Pakhi's another uncle Mofazzal

Gharami told The Daily Star.

He alleged police detained the minors at the police station since September 4. Defence lawyer Lokman Hossain

said he noticed torture marks in different parts of the kids' bodies. Police produced Moksed and Sajeda before a Dhaka court on September 4 and prayed for taking them on a sevenday remand. But the court placed them

on a day's remand, he added. The court granted bail to Sajeda and sent Moksed to jail on Wednesday, mentioned the lawyer.

The two did not confess to the crime but police suspected them to be involved in the offence.

Another domestic help Samiran has been absconding from the house since the looting incident, noted the lawyer quoting the children.

A case was filed with Lalbagh Police Station in this regard on September 3 but the law enforcers are yet to recover the loot.

Bangladeshi shot by Indian Khasias STAFF CORRESPONDENT, Sylhet

A man was injured in the district yesterday as Khasias from India opened fire at him when he was bringing his cows back from near Protappur-Padua border. The Khasias fired at Tera Miah, 20, of Pantumai village

around 11:30am when he went close to the border, said locals. He was first rushed to Gowainghat Upazila Health

Complex and then shifted to Sylhet MAG Osmani Medical College and Hospital where he is now recovering.

Lt Col Shafiul Azam, commander of Sylhet 5 Border Guard Bangladesh battalion, told The Daily Star that they protested against the firing.

"I have already talked to a BSF [Border Security Force commanding officer over the phone," he said. The BSF of India also assured us of taking action, added Azam.

Meanwhile, some 200 inhabitants of the bordering villages like Pantumai and Hajipur brought out a procession, chanting slogans against Indians' firing on Bangladeshis in the border area.

Former CJ showed lack of competence: SCBA chief

Supreme Court Bar Association (SCBA) President Khandker Mahbub Hossain yesterday brought allegation of misconduct against former chief justice ABM Khairul Haque for not yet publishing the full text of the Supreme Court verdict which nullified the caretaker government system. Khairul showed a lack of competence by

not publishing the full text, which is misconduct, and the Supreme Judicial Council will look into it, he said. He made the remark while addressing a

press conference organised by SCBA at its South Hall, where Bar Secretary Bodruddoza

Badal was present. On May 10 this year, a seven-member bench of the Appellate Division of Supreme Court (SC) headed by Khairul, by majority, delivered a brief verdict declaring the care-

taker government system illegal and unconstitutional. Mahbub yesterday said Khairul has to

the full text as he was the chief justice during delivery of the verdict.

Asked whether there is any specific time limit for publishing the written copy of any SC verdict, Mahbub, also an adviser to BNP Chairperson Khaleda Zia, replied in the negative. Mahbub said Khairul is a controversial

judge as he delivered some controversial verdicts and tarnished image of the judiciary by taking Tk 10 lakh from the prime minister's relief fund. He said Khaleda Zia made a political

comment about Khairul, which may be left to the court to see whether it was contemptuous or not.

A former chief justice, requesting anonymity, told The Daily Star that any judge of the SC, after his or her retirement, has no obligation to write judgements although the judges normally write verdicts after retirement.
