Floods bring chaos to India and Pakistan

More than a million people have been displaced and at least 16 killed as floods in India's Orissa state submerged entire villages, officials said yesterday.

Heavy monsoon rains submerged about 2,600 villages across 19 districts. Meanwhile more rain has been

forecast in Pakistan's southern Sindh province where, officials say, 199 people have died over the last two weeks.

Millions have been affected by floods there and the UN has begun relief work.

The United Nations Children's Fund, Unicef, said up to 2.5 million children had also been affected by the rains.

One official said children and families, many of them still recovering from last year's devastating floods, are in urgent need of help before the situation worsens. Almost one million houses have

been destroyed or damaged and floods ing. have affected nearly 4.2m acres of land, the UN says.

Some areas had been cut off due to breaches in river banks and embankments and helicopters were the only way to reach food and water to people stranded there, Mr Mohapatra said.

Orissa's Chief Minister Naveen Patnaik took an aerial survey of the flooded areas.

"We are taking all measures to mitigate the sufferings of the people affected by flood," Mr Patnaik was quoted by television channel CNN-IBN as saying.

"After damage assessment we will also seek help from the central government," he said.

Many of those affected said they were still awaiting relief.

"There is no electricity, no cooking in our house for the last two days. No one has come to our rescue," the channel quoted Lata, a 62-year-old woman in Puri district, as saying.

The channel said she was staying with her grandchildren, refusing to

Gillard to pursue asylum deal

Australia yesterday revived plans to ship hundreds of asylum-seekers to Malaysia, saying it would alter legislation after the nation's highest court blocked the proposed refugee swap.

Prime Minister Julia Gillard, who is facing plunging support and speculation of a leadership challenge, said she would seek to amend Australia's migration law to enable the government to push through the troubled policy.

Rights activists have criticised the so-called Malaysia Solution, accusing Australia of offloading its obligations to refugees and sending vulnerable people to a country that is not a signatory to the UN conven-

tion for refugees. The politically divisive issue, as well as a backflip on the introduction of a pollution tax, have helped drive Gillard's disapproval rating to 62 percent, according to a Nielson poll published yesterday.

The High Court last month froze the deal before it could be implemented, saying the government could not send asylumseekers to countries not legally bound to adequately protect them.

"We are determined to pursue the arrangement we have made with Malaysia," Gillard told a press conference.

Under the plan, up to 800 boatpeople would be sent to Malaysia while Canberra would accept 4,000 of Kuala Lumpur's registered refugees for resettlement in Australia over four years.

PALESTINIAN UN BID CAMPAIGN Turkish PM, Abbas in Egypt

Turkish Prime Minister Recep Tayyip Erdogan yesterday kicks off an 'Arab Spring' tour in Egypt, where a diplomatic flurry is underway ahead of a Palestinian push to win UN statehood and as Israel's regional ties hit a new low.

Palestinian president Mahmud Abbas is also visiting Cairo to attend an Arab League meeting later yesterday and for talks with EU foreign policy chief Catherine Ashton who stopped in Egypt on her way to Israel.

Erdogan will also visit Tunisia and Libya, where popular uprisings such as that in Egypt have toppled long-standing autocratic regimes, as he bids to forge stronger ties with Arab nations as Ankara's relations with Israel sour.

Turkey has expelled the Israeli ambassador over the storming by Israeli naval commandos last year of a convoy of ships trying to reach Gaza in defiance of the blockade, killing nine Turks.

Egypt's relations with Israel also worsened, with protesters ransacking the Jewish state's embassy in Cairo on the weekend forcing the ambassador to flee after the killing of six Egyptian policemen on their

common border last month as Israel hunted militants after a deadly attack.

The Palestinians' determination to push for UN membership has triggered wide concerns in Israel, where Defence Minister Ehud Barak on Sunday called for the 15member inner security cabinet to convene for a debate on Israel's complex regional relations. A strong supporter of the Palestinian

cause, Erdogan arrives late yesterday in Cairo and the next day he will address a ministerial meeting of the Arab League and hold talks with top Egyptian officials aimed at boosting ties. State television said Abbas and Ashton

arrived separately in Cairo and quoted top Palestinian official Nabil Shaath saying that the diplomatic flurry was a "positive" sign for the UN membership bid. Yesterday evening Abbas will attend a

special Arab League committee meeting devoted to the Palestinian-Israeli crisis, just days before heading to New York to seek UN membership for Palestine.

Abbas is expected to submit a formal request on September 20 for the United Nations to accept Palestine as its 194th

Ulfa denies reports on Paresh Barua

"Our leaders and cadres are safe and secure. News about our leaders being injured is not only false but also a campaign to mislead the people of Assam, Arunodoy Dohotiya, publicity in-charge of Ulfa, said in an email to the media houses.

On Saturday, media reported that Paresh Barua, a fugitive Ulfa leader who is wanted by a Bangladesh court for his alleged involvement in the smuggling of 10 truckloads of arms in 2004, had been shot at in the jungles of northwest Myanmar.

Of the accused, Aminur Rahman is the president of Kalipur union BNP and chairman of Kalipur union. He is cousin of BNP lawmaker Jafrul Islam Chowdhury, also former state minister for environment and forest.

The court yesterday fixed October 17 for taking deposition of witnesses, said Public Prosecutor Abul Hashem.

On January 9 this year, Hla Ching Pru of the Criminal Investigation Department (CID), investigation officer in the case, submitted a supplementary charge sheet against 39 people including eight new accused.

The court later dropped charges against accused Nurul Islam, said PP Hashem.

There was an allegation that Aminur had been involved in the incident. But the then investigation officer ASP Clarence Gomez did not include Aminur in the charge sheet he submitted against 31 people on

December 14, 2005. The plaintiff later filed a petition challenging the charge sheet and appealed for further investigation.

A Chittagong court on March 20, 2007 ordered further probe into the case and the then ASP Shafiqur Rahman was appointed the new IO. He submitted a charge sheet against the same 31 accused on November 27, 2007.

When the plaintiff again filed a petition challenging the charge sheet, the case was transferred to the CID and ASP Khurshid Jamil of the CID was made the new IO. Four more CID officials conducted probe into the case and submitted charge sheets thrice without men-

tioning the name of Aminur. Hla Pru, who had been appointed the eighth IO, submitted a charge sheet against 39 people including Aminur on January 9. Aminur surrendered to the

in India 7 killed

Seven people were killed on Sunday after police in India's Tamil Nadu state opened fire on a crowd of angry Dalit (formerly untouchables) protesters.

The incident occurred at Paramakudi town, some 530km (330 miles) from the capital, Chennai, on Sunday.

Protesters had blocked roads and set a number of government vehicles on fire. Tamil Nadu's chief minister said the police acted in self defence.

The protesters were demanding the release of their leader, John Pandian.

Party workers had gathered in the town to observe the death anniversary of a Dalit leader, Immanuel Sekaran.

The police opened fire on the crowd, killing five people on the spot. Two others died of their injuries in hospital late on Sunday.
