# A project for landless about to make an FF's family landless

A martyred freedom fighter's family has lost most of their 2.5-acre government allocated land at Char Ganga in Galachipa upazila of Patuakhali district as the upazila administration has occupied it for a rehabilitation project.

Under the project on 10 acres of land, the upazila administration illegally occupied the land of the freedom fighter's family, ignoring a status quo order issued by the court, says a probe report of Patuakhali district administration.

Abdul Khaleq, then working as a signalman in the then East Pakistan Rifles, was killed by Pakistan occupation army during the Liberation War and the gazette issued by the Ministry of Liberation War



After Khaleq's death, his wife Sajeda Begum with her son and two daughters took shelter at his father's house as Khaleqwas a landless man.

After independence, the then government gave 2.50 acres of land to Shamim, son

of late Khaleq at Char Ganga under Galachipa upazila and it was recorded in 19978-79 fiscal year with kabuliat deed No 445. Crops produced on the land served as earning source of the poor family.

Meanwhile, Galachipa upazila administration undertook a project to rehabilitate landless families on 10 acres of land in 2006-07 fiscal year and 1.50 acres of land belonging to the martyred freedom fighter's family was occupied for the purpose.

Protesting the matter, Shamim on January 14 in 2007 submitted a written allegation to Patuakhali deputy commissioner (DC) who asked Galachipa upazila nirbahi officer (UNO) to take necessary action after investigation.

As no step was taken, the

victim submitted another allegation to the Patuakhali DC on April 24 in 2009 with recommendation of ASM Feroz, whip of Jatiya Sangsad, also lawmaker from Patuakhali-2 (Baufal). The DC again instructed

the Galachipa UNO for necessary action but to no

Following a case filed by Shamim, the Assistant Judge's Court in Galachipa declared illegal occupation of his land for the project and issued a permanent status quo in this regard.

Neglecting the court order, the upazila administration completed the project and built eight barracks to rehabilitate 80 landless families there.

After getting the court's judgment, the DC asked additional deputy commissioner (ADC) Md Shah Alam Sarder to investigate the matter. The ADC submitted his report to the DC on July 28 this year, saying that the demand of the martyred freedom fighter's family is valid.

"We want to get back the land that the government allocated for us. We also demand legal steps against the people responsible for occupying our land," said the martyred freedom fighter's wife Sajeda Begum, now living at her son-inlaw's (daughter's husband) house at Boga Bazar under Baufal upazila.

The victim family has sought the prime minister's intervention to get solution in the matter.

When contacted, ADC Shah Alam Sarder said, "We have already asked the Galachipa UNO to take steps to solve the problem."

## Novel way of cheating hilsa lovers

Marbles being inserted in the fish to increase weight

A hilsa supplier in Barisal has been sued for hoodwinking customers by inserting marbles through the gills to increase weight of the popular fish that is selling for high prices in the market now.

Mosharraf Hossain, owner of fish exporting firm Sayem Traders on Port Road in Barisal city, filed the case with Barisal Kotwali police station on Tuesday against hilsa fish supplier

Zakir Hossain, said Shaheduzzaman, officer in-charge of Barisal Kotwali police station.

The novel way of cheating came to light as Dr Sayem, a city resident, purchased five hilsa from Port Road wholesale market on Tuesday and found some marbles weighing nearly 500 grams inside three of the fishes after cutting those at his house, said Anwar Hossain Babu, assistant fishery officer of Barisal.

Following the allegation, police

and officials of the fisheries department rushed to the spot and seized two more hilsa with marbles inside.

They also detained two fish traders from the spot. But they were released after the case was filed against Zakir, Anwar added.

Preliminary investigation revealed that a section of unscrupulous suppliers have been using the unfair means to artificially increase the weight of hilsa fish to make exorbitant profit.

### JFCL resumes production

Jamuna Fertiliser Company Limited (JFCL), the country's largest urea producing factory, resumed its production yesterday after five and a half months of closure. The stateowned company with a daily production capacity of 1,700 tonnes was shut on March 26 for an indefinite period due to gas crisis. After getting gas supply on September 5, the factory resumed urea production on September 12. But production was again suspended at around 10:30am on Tuesday due to low gas pressure, company sources said.

### Fire kills woman, daughter

A female worker and her minor daughter were burnt to death as a fire broke out at a hut at Rubdia Bazar in Kotwali PS Tuesday night. The deceased were identified as Sufia, 35, a worker at an yard for processing paddy and her three and half month old daughter Koyely. Police said the fire originated from the ashes of an oven at about 11:30pm at the yard, owned by rice trader Satyan Raha. Sufia and her daughter, who were asleep at the adjacent hut, were burnt alive.

### Farmer hacked to death

Criminals hacked a farmer to death in Dighinala upazila of the district Tuesday night. On information, police recovered the body of Bimol Chakma, 45, son of late Nagorak Chakma, from Jamini Karbaripara in the upazila around 9:30pm, said Sahadat Hossaion, officer-in-charge of Dighinala police station. Quoting family members, police said a gang of at least six criminals called Bimol out of his Jamini Karbaripara residence around 8:30pm and hacked him to death.

### Man killed over land dispute

A man, who was critically injured by his rivals over land dispute Tuesday night at Kashiarchar village in Gouripur upazila, died at Mymensingh Medical College Hospital (MMCH) yesterday morning. The deceased was identified as farmer Majibur Mia, 40, of the village. Police quoting locals said, there was a long standing dispute between Majibur and neighbour Bachchu Mia over the ownership of a piece of land. On Tuesday, Bachchu Mia along with his supporters attacked Majibur and his men when they went to take possession of the disputed land, leaving Majibur and two others critically injured. The injured were rushed to the MMCH where Majibur succumbed to his injuries at about 6am.

Nasima Akter finally succumbed to her burn injuries at the burn unit of Dhaka Medical College and Hospital (DMCH) on Tuesday night.

A couple allegedly set their neigbour Nasima on fire after pouring kerosene on Sunday night at Joypura village under Sombhag union in Dhamrai upazila.

Police arrested Shafiqul Islam, 30, son of Abul Hossain of Joypura village and Shafiqul's wife Rawshan Ara, 25, from their house on Monday for alleged bid to kill

the girl. Police said, Shafiqul developed an illicit relation with his colleague Nasima about one and a half years ago. The couple tried to kill her as she became pregnant by Shafiqul.

Severely injured Nasima,25, was admitted to the burn unit of Dhaka Medical College and Hospital on Sunday.
