# Barua calls for paying tax in time

Industries Minister Dilip Barua yesterday called upon the business community to pay taxes properly for boosting the country's internal resources.

"There is no alternative to mobilising internal resources if we want to cut dependency on foreign loans and aid in implementing the development scheme," Barua said at a programme on National Income Tax Day 2011 in Chittagong.

Ramendra Chandra Boshak, a tax commissioner in Chittagong, presided over the function. Later, a rally led by NBR member Mohammad Shahajan was brought out in the port city.

The government also honoured 35 taxpayers of Barisal City Corporation and six districts of the division at a programme in

This is the second time after

2004-05 that the tax office in Barisal crossed its income tax collection target after its launch in 2002. It collected Tk 8.23 crore more than the target in 2004-05.

Income tax receipts in the division mainly depend on the collection of advance income taxes from development works, as the region has no major businesses or industrial infrastructure, said a tax official.

"Corporate head offices of the many regional major business houses are registered with Dhaka taxation office. If those offices pay tax in Barisal region, the amount of tax collection will cross the Tk 500 crore mark in the region," the official added.

The number of enlisted taxpayers in the region was 56,840 in 2009-10 where over 6,000 new taxpayers were included in 2010-11, said Md Abdur Razzak, deputy commissioner of taxes for Barisal tax region.

"The number is increasing by the year. To scrutinise and monitor so many files, only 126 officials, including other employees, are sanctioned under the official organogram. Even 25 percent of the posts have been vacant for years," Razzak added.

### Doel laptop to hit market by Oct 15

Bangladesh's first-ever manufactured laptop will hit the markets by October 15, the chief of a parliamentary body said yesterday.

With advice of Bangladesh University of Engineering and Technology and technical support from Malaysia's state-owned Telephone Shilpo Sangstha (Tesis) is manufacturing the low-priced laptop, Doel.

Telecoms Minister Rajiuddin Ahmed Raju informed the parliamentary standing committee on the telecoms ministry that Prime Minister Sheikh Hasina is expected to unveil the laptop.

The committee chief, Hasanul Haq Inu, told reporters that four types of the laptop would be priced at Tk 10,000, Tk 12,000, Tk 21,000 and Tk 25,000.

The government organisations, including educational institutions, will be the first to buy the laptops, Inu said.

### Investors may get more time to adjust stock exposure

The central bank will increase the adjustment period of the single-party exposure limit, if it is necessary for the stockmarket, SK Sur Chowdhury, an executive director of Bangladesh Bank, said yesterday.

"Considering the market situation and discussing the matter with market stakeholders, the central bank will increase the adjustment period if the government wills," said Chowdhury.

The assurance came at a meeting between the Securities and Exchange Commission and the SEC coordination committee that comprises representatives from the finance ministry, BB, Dhaka and Chittagong bourses and the regulator.

The meeting was called to discuss ways to increase the flow of liquidity to the bruised stockmarket and rebuild investor confidence. It was the last of a series of meetings SEC held in the face of a continuous downtrend in the market.

The regulator sat with Bangladesh Merchant Bankers Association on Tuesday and the asset management companies on Wednesday.

Chowdhury said the central bank extended the adjustment period twice -- first, from July to September, and then from September to December this year. "We will observe the situation until December."

"Bangladesh Bank always considers development of the stockmarket and it will not take any decision or step that will hurt the market and investors," he added.

## Saarc ministers pledge energy security

Saarc energy ministers yesterday agreed to put into practice a number of activities and programmes on electricity and energy at regional and sub-regional levels to ensure energy security for the region.

They also discussed the draft 'Saarc (South Asia Association for Regional Cooperation) Intra-Governmental Framework Agreement on Energy Cooperation in Electricity', which will be finalised at an expert level meeting soon.

The ministers also adopted the 'Saarc Regional Energy Trade Study' that Asia Development Bank conducted for the last couple of years. The study guides member countries on how to act in the production and trading of power and energy.

The decisions came on the last day of the fourth meeting of the Saarc energy ministers at Ruposhi Bangla Hotel in Dhaka. Prime Minister Sheikh Hasina inaugurated the event yesterday.

Forty-five delegates, including five energy ministers from Bhutan, India, Nepal, Sri

Lanka and Bangladesh, took part in it. The meeting also decided to launch a comprehensive study on the exchange of inter-grid power among the member countries. The final roadmap of the study will be discussed at the next expert group meeting.

The report of the meeting will be presented at the 17th Saarc Summit in November, said Muhammad Enamul Huq, state minister for energy, at a press briefing.

He said every member country has agreed that there should be regional cooperation to meet the region's challenges in the energy and power. "We have also discussed our common interests."

The minister said the member countries have agreed that they should form unity like that of the Asean countries to reap benefits.

Md Abul Kalam Azad, power secretary, said the meeting aimed to discuss how member countries could cooperate in the areas of energy, power and renewable

"They also discussed how cooperation can be strengthened in the areas of research and knowledge and information sharing."

Azad said all member countries will give their opinions on the intergovernmental framework agreement by October. "We hope the agreement will be finalised by the middle of next year."

India will organise the next meeting of the Saarc energy and power ministers.
