Talks today to start bus service between Dahagram, mainland

Officials of Border Guard Bangladesh (BGB) and Indian Security Force (BSF) will hold a meeting at Tin Bigha Corridor today to discuss introduction of passenger bus service between Dahagram-Angorpota enclave and the mainland.

Commanding Officer (CO) of 31 BGB Battalion Lieutenant Colonel Aslam Hossain yesterday told this correspondent that some enclave issues including introduction of bus service would come up for discussion at today's sector commander level meeting.

"We have already exchanged views with BSF officials on the issue. I hope the people of Dahagram-Angorpota enclave will soon get bus service facility to travel to and from the mainland through Tin Bigha Corridor," the BGB official said.

The enclave people go to the mainland, 14 kilometres off the enclave, in autorickshaw or rickshaw-van.

They need bus service for safe journey. "We want regular bus service between the enclave and the mainland to reduce transport cost as we have to pay Tk 30




Parishad Chairman Ruhul Amin Babul said the restriction on running bus through Tin Bigha Corridor will go after talks between bus service facility in a couple of days.

A young man, beaten unconscious over a trivial matter, regained his sense after 36 hours at Patgram upazila health complex in Lalmonirhat district yesterday morning.

The victim, Firoz Miah, 27, son of Azizul Islam of Khanpara village in Patgram upazila, said three people beat him mercilessly following a brawl over a mobile memory card on Friday night.

"I begged to them to spare my life, but they continued torturing me, saying that they would kill me," Firoz told family members and police.

Thinking him dead, the culprits threw Firoz Miah, with his hands and feet tied, into a paddy field at Khanpara

village, police said. Finding him unconscious at around 10:30pm on Friday night, locals admitted him to Patgram upazila health complex.

"After regaining consciousness, Firoz told police that he purchased a second hand 3GB mobile memory card for Tk 200 from a neighbour three days ago. Another local wanted the memory card for a few minutes but Firoz declined. The trivial matter led to the tragic incident after a few hours," Patgram police station OC Murshidul Karim said.

Temple vandalised as rival groups clash for control: 4 hurt

Clashes over control of a temple committee at Borua village in Lalmonirhat Sadar upazila on Saturday night and Sunday morning left four people injured and the temple vandalised.

The clashes occurred as a sequel to feud between Khitin Chandro Roy, chief of the committee of Sree Sree Visnu temple at Borua village, and his opponent Surjo Chandro Roy, Lalmonirhat Sadar police station officer in charge Jamir Uddin quoted locals as saying.

Khitin Chandro Roy said "I am president of the temple committee and have been running the temple for the last five years but Surjo Chandro Roy and his supporters are trying to take its control forcibly. They attacked us when we were at a discussion in the temple."

Surjo Chandro Roy, on the other hand, said," Khitin Chandro Roy misappropriated funds of the temple. His committee did not do any developmentworkin last five years. As I and other villagers protested it, Khitin and his supporters attacked us in the temple."
