PSTU seismograph fails to read Sunday's earthquake

The lone seismograph in the country's southern region, set up at Patuakhali Science and Technology University (PSTU) campus, failed to provide information about the earthquake that rocked the country on Sunday evening, due to 'system complexity' in the computer connected to it.

Many people including local journalists approached there to have information and clear picture about the Sunday's earthquake but the persons concerned failed to deliver it.

The seismograph was set up on PSTU campus on May 27 in 2006 under an agreement with Lamont Doherty Earth Observatory of Columbia University in USA for measurement of earthquakes in the southern region of Bangladesh, PSTU sources said.

Owon Eyong Kin, professor of Columbia University and an international expert on earthquake, formally opened the instrument. During the inauguration, a computer taken from the computer laboratory of PSTU was connected with the seismograph to have the reading from it.

But shortly after the inaugural session, the computer was shifted to the laboratory and the device remained inactive for long.

Later on January 10 in 2010, PSTU authority set up the tool in an underground compartment and connected a computer to make it functional.

Md Monibur Rahman, monitoring officer of the device, said a couple of teachers of the university received relevant training from the geology department of Dhaka University (DU) in this regard and they are monitoring

the instrument by rotation.

"We are operating it as per directives from Dr Syed Humayun Akhter, chief superintendent of earthquake research under geology department of Dkaha University. But the machine could not display on the computer necessary data about Sunday's earthquake due to system complexity," he said.

"The tool runs with Linux system but the computer runs with XP system. And so, data that is collected in Linux system could not be displayed in XP system," he added.

Kamrul Hasan, assistant professor of computer science and engineering of PSTU, said, "This seismograph is linked with the mother seismograph at Dhaka University that delivers data collected from the machine. We are our trying our best to solve the system complexity problem to make the machine operative."

Complaint stalls appointments of staffs as per FFs' quota

A Nilphamari court has issued an interim injunction upon the civil surgeon of Nilphamari, assistant director (Health) in Rangpur Division, additional district magistrate of Nilphamari and the representative of Public Service Commission in Rajshahi to refrain from appointing to some posts of office assistant cum computer typist according to a list supplied by the district command of Bangladesh Muktijoddha Sangsad.

Senior Assistant Judge in Nilphamari, who issued the injunction on September 6, also asked the four persons to show cause within seven commander of Bangladesh days why temporary Muktijoddha Sangsad, injunction would not be director general, Health issued regarding the peti- Directorate, Dhaka, secre-

Human chains demanding steps to stop river erosion

Two human chains were formed separately in Noarpara union under Islampur upazila of the district yesterday demanding steps to stop erosion by Jamuna river.

A human chain was formed at village Ulia at 12 noon while the other was formed at village Kadomtoli at 1:00 pm in the upazila.

A large number of villagers took part in the human chain programmes held to realise the demand for protecting their homesteads and croplands from Jamuna.

People of 10 villages of Noarpara union joined the human chain on the bank of the river at village Ulia while people of 2 villages of the union gathered to form another human chain at village Kadomtoli.

The villagers of Ulia, Kadomtoli, Hargila and Guthail of Noarpara union have been facing serious river erosion for long.

During the recent years the Jamuna turned so violent that many of the villagers of those areas became shelterless and landless. Our sufferings know no bounds, the erosion victims said.

After the human chains the erosion victims also held a rally.

Speakers at the rally said many families of the riverside villages were affected badly by Jamuna erosion. Many of the victims lost their croplands and became landless and homeless in the last few years.

They demanded urgent steps to thwart the river erosion and threatened further agitation of their demand was not met.


