Speakers urge govt

Speakers at a seminar yesterday threatened to go for a movement against the draft national broadcasting policy if it is not canceled.

They, at a seminar held at Jatiya Press Club, said if the draft broadcasting policy comes into effect, the freedom of the press will not exist.

President of Bangladesh Federal Union of Journalists (BFUJ) Ruhul Amin Gazi said they have taken the issue seriously to go for a movement against it.

"We will announce programmes like blocked or laying siege to the information ministry against it [the broadcasting policy] to realise our demand," he said.

It is not correct to restrict broadcasting media making a 'bureaucratic policy" as the media can be restricted through the conventional laws, said Dr Akbar Ali Khan, former advisor to a caretaker government.

Jatiya Press Club organised the seminar on broadcasting policy and right to information to observe its 57th founding anniversary.

Stipulating 44 pre-conditions for broadcasting programmes and 63 pre-conditions for broadcasting advertisement, the draft policy says the government will have the power to cancel licence for radio and TV if any of the conditions is violated.

The policy bars private television channels and radios from broadcasting any programmes making derogatory comments about the national figures.

Akbar Ali, at the seminar, said accountability is necessary for everyone, including journalists, but it has to be done under the conventional laws but not through a bureaucratic control.

Demanding autonomy of the state-run BTV and Bangladesh Betar, Akbar Ali said though it was the election pledge of the government to give autonomy of the stateowned broadcasting media but they did not implement it rather they are making a policy to restrict the broadcast media.

Veteran journalist ABM Musa said when a government becomes nervous, they then impose restriction on mass media. No government could survive restricting the mass media, he observes.

New laser technology for treating Melasma

Doctors in Bangladesh found a new laser technology more effective to treat melasma, a skin discoloration that appears on sunexposed areas of the face.

"The new laser, known as dual yellow laser, has a proven record of more effectiveness to treat the skin disease than any other drugs and available treatments in Bangladesh," Dr Jahanara Khan, a leading dermatologist of the country told the news

There is no specific data available about how many people of this country are suffering from this skin disease, but many people are coming to doctors regularly for treatment, prompting them find an effective way

of its treatment. Dr Jahanara, who has been practicing in the country for seven years, said she alone so far treated big number of people with the

latest technology. Recently, she participated in the Asia's largest international conference in Singapore on melasma treatment titled "Aesthetic Asia 2011 Conference" where dermatologists from different countries shared their experience about the technique, importance, effectiveness and the benefits of the new way of treatment.

Speaking about the prospect of the new concept of melasma treatment, Dr Jahanara, the lone participant from Bangladesh, said the duel yellow laser had already become the most popular treatment in the western countries.

She said the new laser tech blasts away broken capillaries, skin discoloration, sun damaged skin, facial redness or rosacea, acne and even melasma without any periphery damage or pain.

Jica's support for Worker dies at dyeing factory

5 others sick; reason unknown STAFF CORRESPONDENT

A factory worker died and another five fell unconscious after inhaling toxic fumes at a dyeing factory in the capital's Shyampur yesterday.

The dead is Abu Sayeed, 22, while the others are Hazrat Ali, 23, Ziaul Haque, 19, Mohidul, 18, Feroze, 15 and Billal, 15, all workers of Chamak Dyeing and Printing Mills at Shyampur.

Of those survived, Hazrat Ali is taking treatment at Dhaka Medical College

Hospital (DMCH) while the others were released after they regained consciousness.

The factory is situated on the ground floor of a four-storey residential building while the upper floors are used as residential flats for tenants and workers.

The exhaust pipe runs parallel to the building and ends at the rooftop where it Giasuddin. The incident occurred Tuesday

night when the workers were sleeping on the top floor, he said. Nannu Miah, acting manager of the

factory, rushed the six workers to DMCH around 5:45am. Sayeed was declared dead at DMCH.

The employees refused to speak to reporters at the hospital.

Nannu quoted the workers as saying that they "panicked after seeing a ghost".

Factory supervisor Giasuddin, however, did not rule out the possibility of inhaling toxic fumes by the employees.

Police visited the spot and is probing into the incident, said Shafiqul Islam, officer-in-charge of Kadamtoli Police

Station. According to morgue sources, no mark of injury was detected on the body of the victim. His blood and viscera would be releases fumes, said factory supervisor

examined to ascertain the cause of death.
