More than a dozen suspected Muslim insurgents attacked a school in southern Thailand yesterday, killing four soldiers and seriously wounding one child, police said.

About 18 gunmen dressed as paramilitaries opened fire on soldiers waiting to escort teachers home in Narathiwat, one of three southern provinces near the border with Malaysia that have suffered nearly eight years of conflict.

Police said one Muslim student, believed to be aged seven, was hit by a stray bullet in the incident, the latest in a series of increasingly brazen attacks by the shadowy militants.

More than 140 teachers have been killed in near daily attacks since insurgents launched an uprising in early 2004, claiming the lives of more than 4,800 people, both Muslims and Buddhists.

The margin of her victory is much higher than by what her party and cabinet colleague Subrata Bakshi had won from the same constituency in April-May when the state had voted for all the 294 assembly seats. The election brought Mamata-led Trinamool Congress Congress party alliance to power ending 34 years of Left Front rule. This was the first time

that Mamata had contested for and won an assembly seat since making her debut in electoral politics in 1984 when she had pulled off the giant-killing act of defeating former Marxist veteran Somnath Chatterjee from Jadavpur.

then met the chairmen of 28 departments when the decision to close the university was made. There will be no classes or exams from today but offices will remain open.

During the four-day movement, students clashed with law enforcers and vandalised around 50 vehicles in the capital. A faction of the journalists' association yesterday formed a human chain and held a rally on campus demanding that the names of those 15 journalists, who are also students of Jagannath University, be dropped from the case.

Police, however, say that they have evidence of their involvement in vandalism.

Mohsin Bepari, president of the executive committee of the faction and the Jagannath University correspondent of BSS, told The Daily Star that their rival faction of the association influenced police into implicating the 15 journal-

ists. He denied the allegation of journalists taking part in vandalism and said they were there as journalists doing their jobs.

Kotwali Police Station Officer-in-Charge Mohammad Salauddin told The Daily Star that the journalists and leaders of Chhatra Dal and Shibir were implicated based on evidence and proof. "We have photographs and footage in our hands which show them vandalising properties," the OC said.

However, Jagannath University Proctor Ashok Kumer Saha said yesterday, "We would talk to the police high-ups about withdrawing the cases filed in connection with the violence during the students' movement."

Kotwali OC said, "Legally we have no right to withdraw any case. After investigation, we can submit a charge sheet against people involved or a final report if they are found innocent."

He, however, said they would consider the initiative of the Jagannath University considering the overall situation.

Ashraf, also the LGRD minister, said Opposition slayed in the name of Leader Khaleda tried to mislead people through her speech. He claimed that the rally was organised to protect the two corrupt sons of Khaleda and to foil the trials of war criminals. The navy entered into a contract with RUAG Aerospace Services of Germany on June 23 to procure the Dornier 228NG planes, which will be delivered in two years' time.

The jet is a modernised version of old Dornier used in Germany, Japan and Norway and is suited to detect oil slicks and carry out environmental research with sophisticated sensors. Officials requesting ano-

nymity said as per the deal the bodies of the aircraft would be manufactured by RUAG in Germany. However, the engines, surveillance radar and other major equipment would be produced in the USA. According to the RUAG

website, the deal includes comprehensive training of pilots and ground crew and aircraft maintenance on location. The manufacturer will also ensure supply of spare parts and maintenance for 15 years.

Highly placed sources said the navy had to pick the third lowest bidder to procure the jets, as the two better bidders failed to produce an export guarantee (a government assurance for export) on time.

Earlier, the navy missed a procurement deadline in the last fiscal year due to a similar situation.

The naval force meanwhile purchased two maritime helicopters from Italy in mid-June for routine surveillance, search and rescue. The choppers are attached to BNS Bangabandhu--a frigate with helipad and hanger facilities.

Prime Minister Sheikh Hasina is expected to launch the naval aviation service by the end of this year.

Some legal experts said any detained accused must take permission from the jail authorities or the court before submitting any petition in connection with a

Advocate Syed Rezaur Rahman, chief prosecutor in the case, told The Daily Star that if any detained accused wants to submit any petition, he or she must submit it through the jail authorities. But Hannan's petition was submitted on his behalf

without any authorisation from the jail authorities, he added. He said Hannan could seek permission from the tribunal for submission of

the petition, but he did not

do that either. So the petition has no legal basis, he said. Hannan's counsel Lutfor Rahman Sheikh however said his client filed the petition properly. But, he did not give any satisfactory answer page application, the name to the question about whether Hannan signed the

> petition. Court sources confirmed vesterday that no legal procedure was followed in submitting the petition.

Hannan first gave a confessional statement on November 1, 2007 disclosing Huji's involvement in the grisly grenade attack on August 21, 2004 on an Awami League rally.

In 2008, during the caretaker rule, the Criminal Investigation Department submitted a charge sheet accusing 21 Huji men including Hannan, and also a BNP leader.

But the investigation was not completed as the investigators could not find the source of the grenades. Following prosecution's prayer, a Dhaka court gave an order for further investigation in 2009. During that further inves-

tigation, in April this year Hannan gave the additional confessional statement, after which the CID submitted a supplementary charge sheet accusing 30 others including BNP Chairperson Khaleda Zia's son Tarique, BNP's former state minister for home Babar, Khaleda's former political secretary Harris, Jammat leader Mojaheed, and some former top police and intelligence officials.

Although the unsigned papers submitted by Lutfor on Tuesday claimed that Hannan had to give the confessional statements under tremendous torture and pressure, the papers only sought to withdraw Hannan's additional statement where Tarique and other BNP leaders were implicated in the crime. The defence did not seek withdrawal of Hannan's first confessional statement.
