PIROJPUR MUNICIPAL POLLS

Contempt of court rule against CEC

The High Court yesterday issued a contempt of court rule against Chief Election Commissioner (CEC) ATM Shamsul Huda and five others for declaring a mayoral candidate of Pirojpur municipal polls as elected uncontested ignoring its order. In the rule, the court asked the CEC and others to explain in

two weeks why legal action should not be taken against them for violating its order. The rule came following a contempt of court petition filed

by Nasim Uddin Khan, another mayoral candidate of Pirojpur municipal polls. On January 2 this year, the HC issued a rule upon the

Election Commission (EC) and the government to explain why cancellation of nomination paper of Nasim Uddin Khan should not be declared illegal. It also directed the EC and the government to allow Nasim

to contest the municipality polls by allocating a symbol to him and not to declare anybody elected as mayor uncontested till disposal of the rule. The EC on January 20 issued a gazette notification declar-

ing mayoral candidate Md Habibur Rahman Malek elected as mayor uncontested, violating the HC order, said Sheikh Atiar Rahman, counsel for the petitioner, said. Nasim Uddin Khan on October 10 filed the contempt of

court petition against six persons, including the CEC for issuing the notification. The rule was also issued against Abu Hena Md Rahmatul Munim, divisional commissioner of Barisal; Ruhul Amin, deputy commissioner of Pirojpur; SK Md Moniruzzaman, additional deputy commissioner (general) of Pirojpur; and

Tarafder Sohail Rahman, deputy director of local government

of Pirojpur, and mayoral candidate Habibur Rahman Malek.

Maintain status quo HC asks govt

The High Court yesterday directed the government to maintain status quo for ten days on felling trees on both sides of the road from Jhanjail Bazar to Durgapur upazila in Netrakona.

The court passed the order following a writ petition filed by Liton Mrong, general secretary of Garo Baptist Convention Bangladesh (GBCB), seeking status quo order in respect of cutting down the trees.

Petitioner's counsel Khurshid Alam khan told The Daily Star that the government cannot cut down the trees from both side of the road till further order, following the HC order.

He said the district council on July 27 issued a tender notification for selling 249 trees, which were planted by Garo communities around 100 to 150 years ago, without informingthe Garo communities.

Liton filed the petition with the HC on Sunday also challenging the tender notification.

The HC bench of Justice Farid Ahmed and Justice Hassan Arif ordered the petitioner and the Netrakona district council authorities to inform the position of the tress and its land to this court within ten days.

During hearing of the petition, Khurshid Alam Khan told the court that the district council has illegally issued the tender notification for selling the trees.

The district council started cutting down the trees yesterday, he added.

CLASH OVER POWER CUT IN N'GANJ

UNO, cops among 30 hurt

At least 30 people, including local UNO and nine cops, were injured in a clash between police and power loom workers following protest over frequent load-shedding by the workers in Araihazar upazila on Monday night. The workers vandalised at least 10 vehi-

cles after blocking the Dhaka-Gopaldi road in the upazila. The law enforcers had to charge batons on the workers and also fired at least 40 bullets to bring the situation under control,
