#### Woman murdered

A housewife was murdered at Bolorampur village in Pabna Sadar upazila yesterday morning. She was identified as Halima Khatun, 35 wife of Jinnah of Raghabpur village. Officer-in-Charge of the police station Md Enayet Uddin said locals found the body of Halima on a land adjacent to their house at around 8:00am and informed the police who recovered the body and sent it to Sadar Hospital for autopsy. The body bore injury marks, the OC said, adding that they are trying to unearth clues to the murder.

#### Sec 144 in Benapole

Local administration imposed Section 144 at Benapole Bazar and its adjoining areas for 30 hours until Thursday midnight as Bangladesh Chhatra League (BCL) and BNP called separate meetings at the same venue and time. Benapole upazila unit of BNP convened a meeting at Benapole High School field at 3:00pm yesterday and local BCL unit also called a meeting at the same venue and time. Upazila Nirbahi Officer (UNO) Kamrul Arif said he banned public meetings in the areas for 30 hours until midnight on Thursday to avert any possible clash between the two rival parties.

#### Two die in boat capsize

A woman and her granddaughter died and two others went missing as a boat capsized in Kangsha River at Holash Khali in Dharmapasha upazila yesterday. The dead are Jaher Banu, 70, and her granddaughter Ima Akhter, 6, of Umedpur village in the upazila. Witnesses said the overloaded boat with 30 to 40 passengers aboard sank in the river when it was going to Mohanganj from Dharmapasha upazila at around 8:00am. Other passengers of the boat managed to swim ashore and a rescue operation was going on to trace the missing people as of filing of this report at 4:00pm yesterday.

#### Auto-rickshaw driver killed

The body of an auto-rickshaw driver was found under a railway bridge at Banashua in Sadar upazila yesterday. The victim was identified as Sadek Hossain of Kaliganj upazila in Lalmonirhat district. A patrol team of Chotrokhil police camp in sadar upazila found the body under the railway bridge in the morning. They recovered the body and sent it to hospital morgue for autopsy. The motive behind the murder could not be known as of 4:00pm yesterday. A case was filed with Kotwali Model Police Station in this connection.

#### Boy drowns in pond

A one and a half years old boy drowned in a pond at Gambujpara village in Gomostapur upazila of the district on Wednesday. Locals said Nasir, son of shopkeeper Abdul of the village, slipped into a nearby pond while he was on its bank at noon. The boy was rescued and rushed to the upazila health complex where the doctors declared him dead.

#### TORTURE FOR REFUSING TO PAY BRIBE ALLEGED

# 6 Bagerhat policemen sued

Six policemen of Bagerhat Sadar model police station have been sued on charge of extortion and physically torturing a man of Khardar area in Bagerhat town.

Monirul Islam Liton, son of Shamsu Sheikh, filed a petition case on Wednesday afternoon with the court of chief judicial magistrate, Bagerhat, accusing the six policemen of torturing him for refusing to pay bribe money. The accused are sub inspectors Harun-

ar-Rashid, Bisharul Islam, Shahidul Islam and Hedayetul Islam and constables Asad and Abdul Alim.

Chief Judicial Magistrate Sheikh Abu Taher of Bagerhat court recorded statement of the complainant. Later, he sent Monirul Islam Liton and Asad Mia to Bagerhat district jail as they were shown arrested in a case for motorbike lifting.

The complainant stated in his petition case that the accused while on routine patrol duty picked him and his relative Asad Mia from in front of Zaheda Hotel in Bagerhat Sadar at about 3:00 pm on Tuesday.

The accused took away Tk 60,000 from me and my relative Asad Mia threatening to kill

us in crossfire if we try to raise any hue and cry, the complainant said.

Later at 6:30 p m on the same day (Tuesday), the accused took us to police station. At about 9:00 pm, SI Harun-ar-Rashid demanded more Tk 50,000 for letting me and my relative off from the police station, he said.

SI Harun-ar-Rashid also abused my wife Mina Begum as she paid Tk 25,000 instead of Tk 50,000 as demanded, the complainant stated in his petition case.

At about 11:00 pm on the same day (Tuesday), all the six accused brutally tortured us branding as listed criminals and motorbike lifters. We sustained severe injuries due to beating right and left with sticks, he added in the case.

On Wednesday afternoon, police sent us to court in false case of motorbike lifting, he further said.


The chief judicial magistrate yesterday ordered a judicial inquiry into the allegation of complainant Monirul Islam Liton.

Magistrate Rafia Islam of the court of chief judicial magistrate has been asked to conduct the judicial inquiry and submit a report on findings by the first week of next month.

OC Moazzem Hossain of Bagerhat Sadar police station said stern action would be taken against the accused if they are found guilty.





### 50 injured as rival villagers lock in clash

UNB, Sylhet

At least 50 people were injured in a clash between two rival groups at Hasnabad bazaar in Chhatak upazila of Sunamganj district on Wednesday.

Locals said there was a long running conflict between Sadrul Islam and Mizanur Rahman over establishing supremacy at Hasnabad bazaar. The hostility between the two took a serious turn recently following firing of eight teachers of local Hasnabad Madrasa.

Local people said a noisy argument and scuffle took place between Sadrul and Mizanur over buying fish at the bazaar in the afternoon. Later, their supporters equipped with lethal weapons and sticks attacked each other leaving over 50 people injured from both sides.

Seriously injured, Sadrul Islam, 46, Nizam Uddin, 30, Maulana Tazul Islam, 30, Haji Kadrul Islam, 60, Azad Mia, 42, Mizanur Rahman Amru, 40, Rafiq, 40, Shamsu Mia, 18, Alim Uddin, 18, and Raisul Islam, 40, were admitted to Sylhet Osmani Medical College Hospital.

Among other injured Dudu Mia, 45, Samsu Mia, 58, Jasim Uddin, 17, Islam Uddin, 16, Azad Mia, 50, Zakir, 18, Khurshed, 37 and 4 others were admitted to Chhatak upazila health complex.

The identities of the fishermen abducted by notorious 'Gama Bahini' could not be known till filing this report. But they hailed from different villages of Rampal upazila in Bagerhat, reports our correspondent.

The move has been taken in the wake of an armed robbery committed on October 4 in clinker laden Indian ship MV Shohagpur at Talgachia under Sharankhola range of the Sundarbans, reports our staff correspondent in Khulna.

Recent rampant piracies in the Sundarbans, river and sea routes have created panic not only among fishermen but also among crew of sea going vessels of foreign countries.

The decision was taken on Tuesday following an appeal made by the assistant director of Khulna office of Bangladesh Inland Water Transport Authority (BIWTA) Md. Shahjahan Hossain to coastguards Mongla west zone.

On Tuesday, coastguards estorted 17 barges and coasters to Mongla Port which came from Sylhet goods, sources said.
