Promoting Democratic Institutions and practices (PRODIP), a five year project, will contribute to USAID/Bangladesh's development goal under the Governing Justly and Democratically Program Objective of the U.S. Foreign Assistance Framework. The Asia Foundation, in partnership with the State University of New York (SUNY), will implement the project.
