Seven shops gutted

At least seven shops were gutted in a fire at Ghagra Bazar in Kaukhali upazila early yesterday. Local people said the fire broke out at about 1:00am at a shop of the bazar and soon engulfed six other adjacent shops. On information, fire fighters from Sadar headquarters rushed to the spot and doused the blaze after two hours of frantic efforts. The affected shop owners claimed that the extent of loss from the fire could go up to Tk 50 lakh.

Tourist motel in Srimangal

Bangladesh Parjatan Corporation (BPC) is set to construct a luxurious motel in Srimangal upazila of Moulvibazar district involving Tk 7 crore with a view to attracting the tourists. The motel will be built on 3.23 acres of land in Kalighat area of the upazila headquarters. BPC Chairman Hamayetuddin Talukder and Deputy Commissioner M Mostafizur Rahman visited the project area on Thursday. Sources said two motels will be constructed-one in Jaflong of Sylhet and another in Srimangal. The motel will have all modern facilities including 16 air conditioned rooms, a restaurant and a conference room with 300 seats.

Mason murdered

Following the incident, Raza and his cohorts beat Mondol mercilessly, leaving him dead on the spot. A case was filed in this connection.

Later, Ali succumbed to his injuries at Shaheed Zia Medical College and Hospital at about 10:30am. Locals- Ripon, Sapu and Saheenmight have been involved in the killing, the OC added.

Sugarcane crushing begins

Sugarcane crushing at Thakurgaon and Panchagarh Sugar Mills began on Friday afternoon. Water Resources Minister Ramesh Chandra Sen inaugurated the crushing of sugarcane at the mills. Managing Director (MD) of Thakurgoan Sugar Mills Sibendranath Sarkar said the production target was fixed at 6,300 tonnes of sugar by crushing 90 thousand MT sugarcanes this fiscal (2011-12) while the recovery rate from the canes is seven percent. In Panchagarh Sugar Mills, the production target was fixed at 5,250 MT of sugar by crushing 70,000 MT sugarcanes while the recovery rate from the canes is 7:50 percent.

Allegation against Tariqul unfounded, says Khulna BNP

Leaders of BNP Khulna district and city units have demanded withdrawal of exminister Tariqul Islam's name from the Judicial probe commission report in which he and 24 other ministers and lawmakers of the four-party alliance government were named involved in post-polls persecution in 2001.

Lawmaker elected from Khulna-2 constituency and city BNP President Nazrul Islam Manju raised this demand at a press conference at the party office today noon.

Former minister Tariqul Islam, who is at present president of Jessore district BNP and member of party's standing committee, was never involved in any violence during his long political career, Lawmaker Manju claimed.

He said Tariqul is still an undisputed leader in the Southwestern region of the country. So, allegation of his involvement in the 2001 post-polls violence is absolutely unfounded, imaginary and politically motivated, Manju added.

The judicial commission report has been made public with political motive at a time when BNP has made grand success in different programmes including road march against misrule of the present government, Manju further said.

Warm clothes sellers are doing brisk business in Lalmonirhat town and other areas of the district as cold weather has been prevailing in the region for the last few days.

Chilly weather causes disturbance to people's day-to-day activities as the northern region sees early arrival of winter, like other years.

People living in the char (landmass emerging from riverbeds) areas are the worst sufferers.

Due to the situation, sale

of winter clothes has sharply increased, both in the roadside makeshift shops and different markets in the town.

People with low income

are crowding the makeshift shops to buy second-hand warm clothes like sweaters, jackets, cardigans, woollen caps and mufflers to protect themselves from the biting cold. "I have sold a number of

second-hand warm clothes. Demand for used warm clothes is much higher than the new ones," said Rajob Ali, owner of a shop at a roadside makeshift market near Mogholhat railway gate in the town.

He said low and fixed income group people including day labourers, rickshaw- pullers and ordinary employees of different government and private organisations are crowding his shop.

suffering due to severe cold for the last few days. So, I have come to the town to buy some second-hand warm clothes for my family members. But the prices are much higher than last year's," said rickshaw puller Mazibor Rahman, who lives in a makeshift house on the embankment of the Teesta River at Kalmati village in Lalmonirhat Sadar upazila.

Shamsul Haque, who sells second-hand warm clothes including jeans jackets, woollen blazers and sweaters at Puran Bazar in the town, said many well-off people, especially youths, are also buying the items from the market as their quality and designs are good.

have been thronging his

quality. They even look fresh and are comfortable to wear," he added.

Many shopkeepers at different hawkers' markets in the town said demand for different varieties of shawls and woollen blankets are also high this year. The prices, however, are

higher than the last year's, said several buyers.

Phulbari town was freed on this day in '71

On this day in 1971, the valiant freedom fighters freed Phulbari upazila town by defeating the occupation forces of Pakistan.

The commander of freedom fighters, Monsur Ali Sarker, hoisted the flag of independent Bangladeshat at the C&B Bungalow here on the very same day. Various programmes have been chalked

out to mark the occasion.

At the fag end of the liberation war, the freedom fighters conducted several successful raids on the camps of Pakistani occupation forces. Later, they intensified their attack forcing the occupation Pakistan forces to retreat giving way to entry of the freedom fighters.

As the news spread, people from the adjacent villages came to the upazila town and rejoiced liberation of their motherland by chanting slogans 'Joy Bangla' with the freedom fighters.

Just after the declaration of independence by Bangabandhu Sheikh Mujibur Rahman on March 7, the freedom-loving people of Phulbari formed a resistance committee.

Later, after the crackdown of Pakistani forces in Dhaka on the black night of March 25 in 1971, the people of the upazila town observed different programmes which moved forward the struggle for independence.

But on April 2 morning, the occupation forces heavily shelled Phulbari from different

points and entered the upazila town. Pakistani troops of Battalion-3 set up their headquarters here to cover five upazilas of Dinajpur district including Phulbari, Birampur, Nawabganj, Hakimpur and Ghoraghat.

The occupation forces, with the help of their collaborators, conducted house-tohouse raids and indiscriminately killed lots of people, raped scores of women and young girls and looted valuables.

Many innocent people fled to India leaving behind everything in Bangladesh and took shelter in refugee camps there.

Meanwhile, Thakurgaon Free Day was observed in the district town yesterday amidst due festivity and enthusiasm, reports our correspondent.

Different socio-political and cultural organisations organised different programmes to mark the day.

The organisers urged the government to expedite the trial of the war criminals for doing heinous crimes against humanity during the liberation war of Bangladesh. Earlier, former lawmaker and organiser of

the liberation war Fazlul Karim inaugurated the progrmme by hoisting national flag at the Martyrs' Memorial in the town. A colourful procession was brought out

from here that paraded the streets of the town and ended at Thakurgaon Bara Maath.
This was followed by a discussion in the

This was followed by a discussion in the afternoon. Water Resources Minister Ramesh Chandra Sen was present as chief guest.
