ENCROACHMENT ON SHITALAKKHYA

19 dockyards to withdraw

Around 19 dockyard owners gave a written undertaking to Narayanganj District Administration and Bangladesh Inland Water Transport Authority (BIWTA) yesterday to remove their establishments and the soil they dumped, encroaching on the Shitalakkhya river, in a month.

The dockyards had encroached on around 200 yards on an average past the recently set up demarcation pillars of the river along a one kilometre stretch, locally known as Purbogao Mouja, said BIWTA Deputy Director Alamgir Kabir.

The district administration served them an eviction notice last year and launched a drive on Sunday. They pledged to remove the soil in two weeks and the dockyards within a month, said Alamgir.

Md Mohabbat Hossain Khan, general secretary of Purbogaon Dockyard Owners Association, said they would relocate their dockyards, set up five years ago, on private land or on leased khas land.

"We will never conduct business by encroaching on the river," he said.

Meanwhile, a joint team of the district administration and BIWTA conducted a drive led by Executive Magistrate Afroza Akhtar yesterday and on Sunday and removed nearly 30 semi-concrete and makeshift structures in the area.

JCD leader

A joint convener of Shahjalal University of Science and Technology unit Jatiyatabadi Chhatra Dal (JCD) was hacked and severely beaten over the hands and legs allegedly by the unit's convener and activists yesterday.

Sylhet MAG Osmani Medical College and Hospital doctors said the left leg bone of the victim, Al-Mamun, was broken. Some bones on the right leg were fractured and there were lacerations on the hands and legs, they added.

A shopkeeper who witnessed the incident, requesting anonymity, said the unit's Convener SM Jahangir, joint conveners Jobayer, Mrittunjoy and Bayezid and around 16 JCD activists carried out the attack before Surma Hall around 2:00pm.

The victim was not in the physical condition to comment. On contact, Jahangir denied being involved but said the attack was presumably resulting from internal feuds.

Unite to establish rights Reduce control

HR activists ask Dalit communities

Human rights activists yesterday suggested Dalit communities to form a greater coalition to initiate stronger movements at national and regional levels to end all forms of discriminations they face.

Isolated movements will be of no help towards establishing equal opportunities, which are being denied just for being born in a certain community like that of Dalits, they observed.

The rights activists were speaking at the concluding session of a two-day "International Conference on Rights of Dalits" organised by Manusher Jonno Foundation (MJF) at Nabab Nawab Ali Chowdhury Senate Bhaban of Dhaka University.

The representatives of Dalit communities and human rights activists from Bangladesh, India, Nepal, Pakistan and Sri Lanka attended the conference.

"You (Dalits) have to be hard and conscious about your rights. Collective strategies are the best to protect your rights," said Irene Khan, an internationally renowned human rights activist.

There are around 50 lakh Dalits in Bangladesh and around 25 crore in Asia.

In Bangladesh, around 80 percent of the Dalits do not have their own houses, are considered low caste people and untouchables and thus face severe discrimination in society.

Though they are constitutionally entitled to enjoy the basic human rights just like any other Bangladeshi citizen, in reality, they face serious discrimination even in matters like access to

education, healthcare and jobs.

The biggest tragedy occurs when incidents of human rights violations and discrimination are overlooked. Accountability of the state and the people as a whole is imperative to ensure human rights for all, said Irene, also the former secretary general of Amnesty International.

National Human Rights Commission Chairman Prof Mizanur Rahman said, "A bigger coalition is needed involving the mainstream population" for Dalits to realise their rights.

"The leaders must be from within your community. Leadership must not be compromised if you want to win the battle," he said, assuring all forms of support from the commission. Prof Debi Chatterjee from India suggested creating an

alternative culture, which includes rejecting the ways of the Brahmins who maintain the caste system, for establishing the rights of the Dalits. Dhaka University Prof Abul Barakat said the Dalits must

under the population census so that affirmative actions are taken to promote their causes. He demanded a separate budgetary allocation and quotas

have constitutional recognition and be separately brought

in public jobs and educational institutions for the Dalits. MJF Executive Director Shaheen Anam said the objective of the conference is to help the Dalits form a greater platform.

"I hope the conference will help them." Research Initiatives, Bangladesh Chairman Dr Shamsul Bari chaired the session.

on local govts Speakers urge govt

Speakers at a discussion yesterday urged the government to reduce its control on local governments for strengthening and establishing the latter's autonomy.

They also recommended curbing the authoritativeness of the government officials over implementation of development activities by the local governments to ensure their accountability to the local government representatives.

The conference, "Strengthening democratic local governance: An investigation into the roles and authorities of local governments in Bangladesh", was jointly organised by Unnayan Shamannay and Centre for Urban Studies at a city hotel.

Though there are enough laws to strengthen the local governments, they are not implemented, preventing them from working independently, they said.

Advocate Sultana Kamal, former adviser to a caretaker government, said the government is duty-bound, as per the constitution, to establish the local government as an autonomous and effective administration to cater for the needs of people.

The government lacks the "political will" to strengthen the local government. Good governance will be ensured when the local governments are empowered through implementation

of the laws according to the constitution, she said. Lawmaker AKM Mozammel Haque said the government officials spend a lion's share of the small amount of the national budget, allocated by the government for the local governments,

without any consent from the local representatives. Each unit of the local governments should be allocated a specific amount of the national budget to carry out development activities which they deem necessary, said Mozammel, chairman of the Parliamentary Standing Committee on Land

Ministry. Fifty percent of what is collected, usually the taxes, by the local administration should be provided to the local government to extend their services to the people, he suggested.

Prof Sarwar Jahan of Bangladesh University of Engineering and Technology said the government must decentralise its administrative activities by strengthening the local govern-

ments to develop the country's economy. Dr Mahfuz Kabir, senior research fellow of Bangladesh Institute of International and Strategic Studies, presented a paper, "Leveraging the periphery: Effective decentralisation at upazila and union parishad".

Kabir said the local governments must be allowed to extend their capacity over development works out of the government's control otherwise they can not be autonomous and effective.

Former University Grants Commission chairman Nazrul Islam conducted the conference where Shamim Al Razi, general secretary of Municipal Association of Bangladesh, and Mahbubur Rahman Tulu, president of Bangladesh Union

Parishad Forum, spoke. Urban planner Salma A Shafi presented a paper on the

NEW DCC ADMINISTRATORS

Hearing on petition Thursday

A High Court bench yesterday heard a writ petition filed challenging the legality of appointing unelected persons as administrators for splitting Dhaka City Corporation (DCC).

The High Court bench of Justice Mirza Hussain Haider and Justice Md Khurshid Alam Sarker fixed next Thursday for further hearing. The government appointed two administrators for the

DCC on December 4. Ignoring widespread criticism and protests, the parliament hurriedly passed a bill to split DCC into two on November 29. It took only four minutes and a few seconds to pass the

bill, bringing about some major changes to the Local Government (City Corporation) Act, 2009. The writ petition filed by four persons, including two lawyers on Sunday with the authority concerned of the apex

court also was also sought stay order on the appointment. Petitioners also prayed for appointing elected persons as the interim administrator.

The local government secretary, the public administration secretary, law secretary and two administrators of DCC were made respondent of the writ petition.

BDR CARNAGE CASE

Court dissatisfied over facilities

As the metropolitan session judge's court, trying the 850 accused in a BDR carnage case, is not facilitated like other session judges' courts, the lawyers often face various problems, defence counsels told the court yesterday.

Echoing their claim, the court also expressed dissatisfaction over the facilities provided to the court set up temporarily at the playground of Alia Madrasa in the city's Bakshibazar.

They expressed their dissatisfaction following cross-examination of a witness by the defence counsel Aminul Islam at the first hour of the court proceeding.

"I have informed the president, the prime minister and the chief justice about the problems but no result is [yet to be] found. The court is run by Allah,"

said the judge. "I have conducted many session

judges' courts, but never faced prob-

lems like this," the judge added. He, however, did not elaborate the problems and requested the lawyers to carry on the court proceeding within the existing limitations.

Aminul claimed that in the name of security, on-duty police often misbehave with the lawyers.

"We couldn't park our cars on the playground next to the court. Besides, our juniors and clerks are not permitted to enter the court," he said adding it is a free court and lawyers should be allowed to work here in a regular way.

He said police should check their
