## Cameron defends EU veto

AFP, London

British Prime Minister David Cameron yesterday defended his decision to veto EU treaty change, telling lawmakers that European nations had snubbed "modest" demands for safeguards for his country.

Facing a rift within his coalition government and anger in Europe, Cameron said Britain's membership of the European Union was vital but that he had to look after the City of London financial services hub.

"I went to Brussels with one objective, to protect Britain's national interests, and that is what I did," Cameron said in a statement to the House of Commons to cheers from his Conservative party.

He said he had been seeking at last week's EU summnit a full deal involving all 27 member states for treaty change based on French and German proposals, "with the necessary safeguards for Britain".

"Those safeguards, on the single market and on financial services, were modest, reasonable and relevant. We were not trying to create an unfair



for Britain." continue to work with the other 26 EU nations, which after his veto

agree in principle to join a "new fiscal compact" aimed at saving the debt-hit euro.

He also took a softer line than British officials had over the weekend about whether Britain would allow the other EU nations to use the bloc's institutions to pursue their pact without the United Kingdom.

But the Conservative leader faced fierce criticism from opposition Labour leader Ed Miliband, who accused Cameron of coming back with a "bad deal for Britain" that had no safeguards for the City of London.

Miliband said Cameron was responsible for a "diplomatic disaster of 26 going ahead and one country, Britain,

advantage beingleft behind".

Cameron's position was weakened Cameron in October after a rebellion by 81 lawmakers calling for a parliamentary vote for a referendum on Britain's relationship with the EU.

> Deputy Prime Minister Nick Clegg was notably absent from Cameron's side in parliament, fuelling reports of tensions between the Conservatives and the Liberal Democrats, the junior partners in the governing coalition.

Clegg, the Lib Dem leader, on Sunday criticised the deal and said it could turn Britain into an international "pygmy".

Clegg's office said he did not turn up because he did not want to be a "distraction".

Shockwaves from Cameron's veto continued to reverberate through Europe, with EU Economic Affairs Commissioner Olli Rehn warning that the British veto would not protect the City of London.

"If this move was aimed at preventing bankers and financial corporations of the City (of London) from being regulated, that's not going to happen, Rehn stressed.

# Amazon's top seller

A biography of the late Apple co-founder Steve Jobs was Amazon's best-selling book this year despite hitting store shelves and electronic readers only in late October, Amazon said yesterday.

"Steve Jobs" by Walter Isaacson, which went on sale on October 24, less than three

weeks after Job's death, topped the list of Amazon top-selling books for 2011, print and Kindle editions combined, the Seattle-based company said.

"Even though it was published in October, the sales have been phenomenal in both formats," said Chris Schluep, Amazon's senior editor of books.

Next on the list was "Bossypants" by comedian Tina Fey and "A Stolen Life" by Jaycee Dugard, a California girl who was kidnapped as a child and held for nearly two decades.

Number four on the top 10 list was "The Mill River Recluse," a self-published Kindle novel by Darcie Chan.

"In the Garden of the Beasts" by Erik Larson was next, followed by "A Dance with Dragons" by George R.R. Martin, "The Paris Wife" by Paula McLain and "The Litigators" by John Grisham.

Another self-published Kindle book, "The Abbey" by Chris Culver, was number nine on the list while "Inheritance (The Inheritance Cycle)" by Christopher Paolini rounded out the top 10.

### Steve Jobs biography | China to open its first military | Seven dead in | Heavy fighting in base abroad in Indian Ocean

In a move that may cause unease in India, China yesterday announced that it will set up its first military base abroad in the Indian Ocean island of Seychelles to "seek supplies and recuperate" facilities for its Navy.

The naval fleet may seek supplies or recuperate at appropriate harbours in Seychelles or other countries as needed during escort missions, Chinese Defence Ministry announced here yesterday.

China has already cemented its foothold in the Indian Ocean by signing contract with the UN backed International Seabed Authority to gain rights to explore polymetallic sulphide ore deposit in Indian Ocean over the next 15 years.

The contract awarded this year to a Chinese association exclusive rights to explore a 10,000-square-km of international seabed in the southwest Indian Ocean.

The base in Seychelles is regarded significant by analysts as China is about to launch its first aircraft carrier. It is currently undergoing final trials.

Playing down its significance, Chinese Defence Ministry statement yesterday said it is international practice for naval fleets to resupply at the closest port of a nearby state during long-distance missions.

Apparently commenting on a recent report that China will establish a military base in Seychelles, it said Chinese naval fleets have re-supply facilities at harbours in Djibouti, Oman and Yemen since China sent its first convoy to the Gulf of Aden in

The decision to establish its first naval base abroad was taken during Chinese Defence Minister Gen Liang Guanglie's goodwill visit to Seychelles earlier this month.

During the visit, Seychelles Foreign Affairs Minister Jean-Paul Adam said his country has invited China to set up a military base on the archipelago to beef up the fight against piracy.

"We have invited the Chinese government to set up a military presence on Mahe to fight the pirate attacks that the Seychelles face on a regular basis," Adam was quoted as saying in the media reports.

"For the time being China is studying this possibility because she has economic interests in the region and Beijing is also involved in the fight against piracy," he said.

### steel factory explosion in Iran

Seven workers died and at least a dozen others were injured when a melting furnace in an Iranian steel factory exploded, officials told Iranian media yesterday.

"Several of those killed were foreign nationals,' Azizollah Seifi, the governor of the central Yazd region where the blast occurred late Sunday, told the ISNA news agency.

The explosion, which rocked the Ghadir-e Yazd Steel Factory, was being investigated.

Seifi was quoted as saying 12 workers were injured.

Yazd's chief coroner, Ali Suleimani, told the Fars news agency 14 were hurt.

# Sudan kills 19

Heavy fighting between the Sudanese army and southernaligned rebels in the embattled state of South Kordofan has killed at least 19 government troops, a rebel spokesman said yesterday.

"There was heavy fighting on Saturday in Warni, in the far east of Talodi locality. The SPLA repelled an attack by the army. They left 19 bodies on the ground," Arnu Ngutulu Lodi told AFP.

The Sudanese army spokesman could not immediately be reached for comment. Lodi said the clashes followed three days of fighting in the

northern Rashad locality, where the rebels managed to expel the army from the Abu al-Hassan area, and that the two sides were battling yesterday in the Taruje area, near the disputed southern border.

"The fighting now is going on in Taruje. There are heavy artillery bombardments. The SPLA has surround the SAF (Sudanese armed forces), who are under a lot of pressure. Any time now they will be driven out," he claimed.

The conflict erupted in South Kordofan in June between the army and militiamen who fought alongside the exsouthern rebels during their 22-year conflict with the north, as Khartoum moved to assert its authority within its borders ahead of South Sudan's independence in July.

A similar conflict broke out three months later in nearby Blue Nile state.

EU and the USA "volatile", she urged the government for lending policy supports to the garment exporters soon so that the sector remains unhurt. The BNP chief also said the banking sector is suffer-


Khaleda said to produce skilled manpower for the sector the government should provide technical support to BGMEA in establishing more training centres. She also urged the gov-
