OUTLAWS ACTIVE AGAIN IN GANGNI OF MEHERPUR

8 brick kiln owners held hostage for illegal tolls

Outlaws have become active again in Gangni upazila of Meherpur district and are putting pressure on brick kiln owners to pay them illegal tolls within the deadlines.

Cadres of outlawed of Purbo Banglar Communist Party (PBCP-Janajuddho) faction demanded Tk 18 lakh from eight brick kiln owners in the last four days from Sunday to Wednesday, said one of the owners, seeking anonymity.

The outlaws also gave the owners a 10-day deadline to pay the money. Otherwise, they threatened to kill them, he added.

One of the owners of Biswas Brick Kiln said, "We have two brick kilns---

The outlaws demanded Tk 3 lakh from Samata, Ekata and Satata brick kilns each and Tk 2 lakh from Joynal and Bamundi brick kilns each, said the

They said one Raju, identifying himself as regional leader of PBCP Janajuddho phoned the brick kiln owners and asked them to pay the money within the deadlines.

On Wednesday night, Janajuddho cadres came to Bamundi Brick Kiln and wanted to know the whereabouts of its owner Kamrul Islam.

Cross sections of people join a human chain standing in the knee-deep water of Rampal channel connecting Mongla-



Sadar police station SI Munir Hossain said, on Wednesday at around 7:30pm, some activists of Chhatra Shibir were holding a meeting at Beparipara mess.

On information, activists of Chhatra League attacked them, damaged furniture and kept them confined to the room.

Police went to the spot and arrested 13 Shibir activists and brought them to the Sadar police station.

Later they were arrested after Chhatra League activist Insar Joarder filed a case against them on charge of attacking BCL men.

District Chhatra League general secretary Biswasit Saha said, the Shibir activists of Arappur area on Tuesday afternoon attacked some KC College students including Chhatra League activist Insar Joarder.

Following the incident, the activists attacked the Shibir mess, police said.

Denying the allegation Shibir president Shahjalal Hossain said that the BCL men attacked them after a party meeting without any provocation. Five Shibir men were injured, he said.

Brick field near health complex, school

'Undisturbed' for last nine years

Believe it or not, a brick field, set up about 150 yards from the upazila health complex and a high school, has continued its operation for nine years.

Set up in 2003 beside Takimuddin High School at Jaigirmahal village in Amadi union under Koira upazila of Khulna district, the brick field named Messers Amir Ali Bricks poses health hazard to under treatment patients at the upazila health complex and students and teachers of the school.

Environment of the populous area is also affected.

The brick field owner, Amir Ali Gayeen, present chairman of Amadi Union Parisahd, claimed that he had set up the brick field on three acres of land after getting 'green signal' from the Department of Environment (DoE) office in Khulna.

"So, the question of health hazard and environment pollution due to running of my brick field does not arise here," said the brick field owner, also president of the union unit of ruling Awami League.

On the other hand, Medical Officer of

Koira Upazila Health Complex Dr Shujat Ahmed said the brick field should be shifted as soon as possible as its smoke and dirt cause health hazard to patients, especially those with cardiac problem and children.

"I applied in writing to the authorities concerned several times during the last one year for removing the brick field that is being run in defiance of relevant environment rules," Dr Shujat said. "Black smoke emitted from the chimney

of the brick kiln is creating respiratory problem both for teachers and students as they have to inhale it for hours during the class time," said Md Anwarul Huq, headmaster of Takimuddin High School.

The brick field has been running since 2003 in the populous area violating the relevant rules of environment department, he said.

"I never permitted the UP chairman to run the brick field violating rules. Legal action will be taken against brick field owner in case of violation of the relevant rules," Dr Tarun Kanti, director of the DoE, Khulna, told this correspondent a few days ago.

Son of Idris Ali from Muslimpara village at Dighinala, Sattar used to transport people on his motorcycle. He went missing Tuesday evening and his body was found near Duitila under Sourendra Nath Chakraborty and Baghaichhari the next morning.

In Wednesday's unrest, Chigonmila Chakma, 43, was beaten to death and her husband Jiten Chakma was injured by settlers while the two were going to Baghaichhari from Dighinalainthemorning.

All the injured were undergoing treatment at Khagrachhari Adhunik Hospital, adds our Khagrachhari correspondent.

According to sources, some five indigenous people have been killed, 100 injured and some 630 houses burnt down on several occasions after the Awami League-led grand alliance took office.

Following allegations made by some visitors, a mobile court led by Baralekha Upazila Nirbahi Officer (UNO) Syed Md Aminur Rahman launched a drive in Madhabkunda area at around 11:00am and arrested two staff of a digital colour lab while they were editing objectionable photos of some women visitors, reports our Moulvibazar corre-

spondent. The court sentenced the two staff of the lab to shots of such attempts.
