- The Power Grid Company of Bangladesh Ltd. ("the Employer") intends to construct two(2) new 132/33kV substation at Kulaora and Sherpur and also intends to extend two 132kV line bays at existing Jamalpur 123kV substation. The work is required to be completed within 18 (eighteen) months from the date of signing of the contract. Considering the time schedule, PGCB has decided to invite this bid by Single-Stage, Two-Envelope bidding procedure and is open to all bidders from eligible source countries.
- The Power Grid Company of Bangladesh Ltd. ("the Employer") invites sealed bid proposals for Design, Supply, Erection, Testing and Commissioning of two new 132/33 kV Air Insulated Switchgear (AIS) Substations at Kulaora and Sherpur and extension of two 132kV Line bays at existing Jamalpur 132kV substation on turnkey Basis as defined in the bidding document (hereinafter referred to as "the Works"). The Works include:
 - The scope of work under this turnkey Bid is design, supply, delivery, installation, testing & commissioning of complete two (2) new 132/33kV Air Insulated Switchgear (AIS) substation at Kulaora and Sherpur to connect 132kV overhead line bays(two new 132kV bays at Kulaora & two new 132kV bays at Sherpur), two new 132kV transformer bays to connect two sets of 3-phase, 132/33kV, 25/41MVA outdoor type transformer at Kulaora and two new 132kV transformer bays to connect two sets of 3-phase, 132/33kV, 35/50MVA outdoor type transformer at Sherpur; one 132kV buscoupler bay at each substation.
 - The scope of work includes design, supply, delivery, installation and testing & commissioning of two (2) sets of 3-phase, 132/33kV, 25/41MVA outdoor type transformer & two 33/0.4 kV outdoor type earthing/auxiliary transformers at Kulaora and two (2) sets of 3-phase, 132/33kV, 35/50MVA outdoor type transformer & two 33/0.4 kV outdoor type earthing/auxiliary transformers at Sherpur.
 - The scope of work includes associated control, protection, fiber optic multiplexer equipment for communication & protection, substation automation system and associated civil works for the above two new substations. The configuration of the 132kV busbar shall be double busbar(U type) scheme.
 - The scope of work includes design, supply, delivery, installation and testing & commissioning for extension of two (2) new 132kV line bays and shifting & renovation of existing bus tie bay at existing Jamalpur 132kV substation with associated control, protection, fiber optic multiplexer equipment for communication & protection, and associated civil works.
- International Competitive Bidding will be conducted in Single-Stage Two-Envelope bidding procedure and is open to all bidders from eligible source countries.
- Bidders shall meet, the following minimum requirements along with other requirements as mentioned in the bidding documents:
 - In-case of Single Entity, the Bidder must have experience for successful completion of at least two (2) substation contracts as Contractor for Design, supply, delivery, installation, testing & commissioning of extension/new substations of minimum two bays of 132 kV or higher voltage substation with Power Transformer in each substation contract on turnkey basis within the last fifteen (15) years as on the date of opening of technical proposals of which at least one installation shall be in successful operation for minimum of three (3) years.
 - In case of Joint Venture, only the experience of the partner(s), who have at least 20% share in their Joint Venture, shall be considered for evaluation against the requirements mentioned below:
"Any one of the partners of the Joint Venture who have at least 20% share in their Joint Venture must have successfully completed at least two (02) Contracts as Contractor for Design, supply, delivery, installation, testing & commissioning of extension/new substations of minimum two bays of 132 kV or higher voltage substation with Power Transformer on turnkey basis within the last fifteen (15) years as on the date of opening of technical proposals, of which at least one installation shall be in successful operation for minimum of three (3) years."
Joint Venture bidders are required to declare their respective percentage of share in their Joint Venture Agreement in the format of "Joint Venture Agreement Form" given in the Bidding Document.
