fined, owners jailed

A mobile court has awarded sentences to four persons including three brick kiln owners on charge of preparing bricks by burning wood in their illegally setup kilns in Sadar upazila of Bagerhat yesterday, reports our Bagerhat correspondent.

The convicted are-- brick kiln owners Delwar Sheikh, 35, Humayun Kabir, 25, Mosharrof Hossain, 35, and Jabbar Sheikh, 55, a worker of another brick kiln.

The mobile court raided eight brick kilns, closed those and seized 2620 maunds of fuel wood and about 50 thousand bricks from there.

A mobile court led by Executive Magistrate Mehedi Hassan raided the brick kilns at Pashchimbhag village of Sadar upazila.

Mehedi said that the convicted have been given jail sentences of different terms and fined as per article 7 of Brick Burning Control Act

There are more that 300 brick kilns in Sadar and Morelganj upazilas of Bagerhat and they will continue their drive, he added. Meanwhile, in another

drive Department of Environment (DoE) yesterday destroyed four illegal brickfields in Mymensingh and fined them a total of Tk 13.5 lakh for polluting the environment.

DoE also seized seven lakh bricks and about one metric ton firewood from them, said a press release.

The drive, led by DoE Director Mohammad Munir Chowdhury, continued for around six hours from 9:00am.

The brickfields are Ratan Brick, Siyan Bricks, Nur Bricks and HRB Bricks, all situated in Barera under Mymensingh upazila.

These brickfields, between 5-20 years old, caused serious damage to agricultural land, biodiversity and nearby resi-

Demands of locals went unheard, as the brickfield owners were influential, the release said.

Talking to The Daily Star, Abdul Kader, father of the victim, said first the abductors demanded Tk 30 lakh; but later they claimed Tk 20 lakh. They told Kader to go to Binodia Park at Jessore with he ransom.

But as he told them that he could at best pay Tk 30,000, the abductors did not phone him again. Kader also informed the police and Rab about the abduction but they could not find Shahed.

Jhenidah Superintendent of Police Rezaul Karim claimed that it was not a matter of abduction. "It might have happened for three reasons -- land conflict, quarrel with his friends or love affair."

Police have arrested two suspects in this regard. They are Partho and Tarun of the same area, he said.

On December 19, the body of a ten-year-old girl, Shrabanti, was found tied in a sack under the bridge of Jhenidah town. She was also reportedly abducted for ransom.

Brick fields flout

Many brick-fields still collect wood from forests but whenever they get caught they say the wood is meant only for lighting kilns.

Mohammad Joinul Bari, deputy commissioner of Cox's Bazar, told The Daily Star that they have been monitoring all brick-fields in the area. If any of those is found using wood illegally, its licence will be cancelled.

"We are not renewing or issuing licences for brickfields as the government has decided to shut all conventional brick-fields by 2013," he said in his office last week. Brick business boomed in

the tourist destination with a rise in construction of hotels, cottages and apartments near the beach and in the town.

There are at least 49 kilns, including 29 in Ramu upazila, in Cox's Bazar.

According to a UNDP survey, these brick-fields produced nearly 14.70 crore bricks in 2010-11, causing air pollution, land degradation and deforestation in the district.

Some of the brick-fields have been using the topsoil for producing bricks turning vast tracts of land infertile. Once topsoil is taken away from a land, no crop can be grown there for several years, said farmers.

People living close to brickfields complained of health hazards. "Children are the worst sufferers from harmful black fumes emitted by kilns," said Neyamot Ali, an elderly resident in Rupulia village.

According to Bangladesh Brick Makers Owners' Association, nearly 8,000 brick-fields -- over half of them illegal -- are in operation in the country. They produce about 8.66 billion bricks with an estimated value of \$450 million a year.

The United Nations Development Programme (UNDP) says these brickfields still use 150-year-old method, which causes huge carbon emission and is highly

energy intensive. About 33 percent of the fuel used for the kilns comes from trees. The ratio is 100 percent in some areas in Cox's Bazar that face serious environmental and health hazards, and destruction of farmland and forest.

The UNDP launched a \$14 million project in August last year to find an energyefficient technology for the brick industry, help update laws and rules on brick production, and create awareness among people about the adverse impact of conventional brick kilns.

Global Environment Facility is contributing \$3 million to the project and the rest will come from the private

As part of the project, the UNDP on December 13 organised a views-exchange meeting on brick-fields and their impact in Cox's Bazar. Amanullah bin Mahmud, monitoring official of Green Brick Project, presented a keynote paper. Fifteen demonstration

projects will be implemented across the country with the use of energy-efficient Hybrid Hoffman Kiln method, Project Manager Khondker Neaz Rahman said in his introductory speech. "Apart from creating

financial institutions to fund energy-efficient brick-fields, said Amanullah. He said an institution will be set up under the project for giving technical assistance to

workers to make them familiar with the new technology. Students, teachers, environmentalists and brick-field owners were also present

"We will adopt the new technology for producing bricks but we need financial incentives for that," said Gias Uddin, a brick-field owner.

"For the first time in the country's history, the president made such a move," he said.

Asked about BNP's possible boycott, Hanif, also special assistant to the prime minister, said, "They [BNP] will lose the opportunity to make their opinion on the formation of the new Election Commission count, if they boycott the talks." The Bangabhaban

announced on December 18 that the president will begin the talks with political parties from December 22. It followed by sending invitations to Jatiya Party and Jatiya Samajtantrik Dal. On Tuesday it also sent invitation letters to six other political parties for talks in the coming week.

"We will send invitations

to other political parties gradually in the next week, president's Press Secretary AKM Nesar Uddin Bhuiyan told The Daily Star yesterday. According to him, the ruling Awami League and main opposition BNP will get invitations in the next

propose so," he said. After the talks, the president, on the advice of the prime minister, will appoint a new commission chief and other commissioners to form the new Election Commission that will conduct the all important next parliamentary election slated to be held anytime in January, 2014.

However, the invitation letters signed by secretary to the public division of Bangabhaban, Mohammad Shafiul Alam, said the president himself wants to make the final decision after talking to the political parties.

Zillur's predecessor Iajuddin Ahmed in October, 2006, opened a series of talks with political parties in the wake of a political stalemate over the appointment of the chief adviser to the caretaker government.

days later. After the sentencing, victim's brother Mohammad Shoaib, also complainant of the case, said he was satisfied with the verdict and called on the government to execute it immediately.

The men awarded death penalty are Abdur Rahim Sarder, Kazi Baezid, Ikram alias Masud and Murad Hossain. Mohammad Nazimuddin was sentenced to a life term in jail.

Masud and Murad remain absconding while the others are in jail.

Judge Motahar Hossain of the Speedy Trial Tribunal-4 handed down the verdict in a packed courtroom yesterday.

He said the sentences of the fugitives will be effective from the day of their arrest or surrender. The death penalty convicts have 30 days from the day of receipt of the judgment copy in which to appeal to the High Court.

The verdict followed the cross-examination of 22 prosecution witnesses. It was found that Abdur Rahim had a dispute with Imam Ishaque over a salt factory. He along with Kazi Baezid sent Masud and Murad, residents in Malaysia, to Bangladesh to kill the imam. Maulana Ishaque went

missing after Zohr prayers on December 20. His hands and legs were in shackles and mouth sealed with scotch tape when police recovered his body on Dec 30.

During the investigation, Kazi Baezid confessed to the murder and disclosed the names of the others involved.

In Barisal, nine children died after being attacked by pneumonia, diarrhoea, skin and other cold-related diseases in the last five days all at Sher-e-Bangla Medical College Hospital (SBMCH).

Of the deceased, four died on December 16, one each on December 17 and 18 and 20, two on December 19 at the hospital's children ward. More than 150 children have been admitted to the hospital with the fall in temperature, SBMCH and district civil surgeon office sources said.

Biting cold, excessive dust and pollen are the main reasons behind the spread of the diseases, said Dr Abdur Rashid, director of SBMCH.

The air is carrying much dust due to lack of rain and increasing pollen in the air this season. For this, people are facing general respiratory problems and allergic infections, said medical officers at Barisal Tuberculosis Hospital.

Prof Dr Zahid Hossain child specialist and former principal of SBMCH, said many mothers these days refrain from bathing their children for several days, which is unhygienic and may cause various skin

About the asthma patients, physicians observed that most of them do not continue the full course of medicine which causes serious infection and breathing problem with the change in season and in winter they suffer most, said Dr ANM Khairul Anam divisional health director.

In Jessore, at least 22 people -- including 10 children, five women and seven men -- died from coldrelated diseases in a week, our Benapole correspondent reported. Captain Zubayer

Hossain, in charge of Jessore Airport Weather office, said the cold is intensified by the almost-invisible sun amid dense fog. The temperature continued 9-12 degree Celsius on an average in the district.

The situation forces people to stay indoors disrupting normal life and businesses in the district.

Later the then communications minister Syed Abul Hossain announced that the company's joint venture documents with Chinese HRBC were forged and that he was going to take actions against the firm.

He sent the ministry's Deputy Secretary Nurul Amin and Tec chief Aminur Rahman Laskar to China to verify the joint venture docu-

ments. On return, the duo confirmed that the documents were not genuine.
