Ban on Jamaat demanded Paper mill sealed, fined Tk 31 lakh STAFF CORRESPONDENT

A few student bodies yesterday demanded setting up of international crimes tribunals at district level to speed up the war crimes trial and banning Jamaat-e-Islami claiming that the party conducted crimes against humanity during the Liberation War in 1971.

They placed the demands at a press conference under the banner of Chhatra Sangram Parishad, a platform of seven student bodies, at Madhur Canteen on Dhaka University (DU) campus.

The Parishad includes Bangladesh Chhatra League (BCL), Bangladesh Chhatra Moitri,

pro-JSD Bangladesh Chhatra League,

Bangladesh Chhatra Andolan, Jatiya Chhatra Oikya, Bangladesh Chhatra Samity and Jatiya Chhatra Forum.

Main opposition BNP and its alliance partner Jamaat are conspiring to foil the trial of war criminals through creating anarchy in the country, said the parishad coordinator HM Badiuzzaman Sohag, also the BCL president. He also announced to bring out a proces-

sion today on the campus to press home their demands. BCL General Secretary Siddique Nazmul Alam, Bangladesh Chhatra Moitri President

Bappaditya Basu, and pro-JSD Bangladesh Chhatra League President Hossain Ahmed Tafsir also spoke at the conference.

GRENADE ATTACK CASE DEC 18 VIOLENCE 168 BNP men get bail

The High Court yesterday granted bail to 168 BNP leaders and workers for two months in eight cases filed in connection with the violence in the capital and Sirajganj on December 18.

All the accused, including Jatiyatabadi Jubo Dal President Syed Moazzem Hossain Alal, Jatiyatabadi Swechchhasebak Dal President Habib-un-Nabi Khan Sohel and Jatiyatabadi Chhatra Dal President Sultan Salauddin Tuku, appeared before an HC vacation bench to seek bail.

Police filed the cases against them with different police stations in Dhaka and Sirajganj on charges of arson, damaging vehicles, halting traffic movement, anarchy and preventing policemen from discharging their duties on December 18. The HC bench of Justice Salma Masud Chowdhury and

Justice Md Anwarul Haque passed the orders after hearing five bail petitions filed by the accused. At dawn on December 18, several homemade bombs

went off in downtown Dhaka as hundreds of BNP and Jamaat-e-Islami activists clashed with police, vandalised more than a dozen vehicles and set some of those on fire.

Lina Paper Mills Ltd has been running its activities for the last 11 years without clearance certificate from DoE and effluent treatment plant (ETP), said a statement of DoE



Three former officials of the Criminal Investigation Department (CID) yesterday appealed to a Dhaka court to discharge them from the August 21 grenade attack case filed under the explosive substances act.

Earlier counsel for the three officials had submitted discharge petition for relieving them from the case of the grenade attack in 2004 that killed 24 people and injured around 200 others.

The counsel for them continued yesterday his submissions for the third day in support of discharging his clients.

The petitioners are former ASPs Munshi Atiqur Rahman and Abdur Rashid, and former special SP Ruhul Amin, who also investigated the grenade attack cases.

The CID officials submitted the discharge petition before the Speedy Trial Tribunal-1 when it resumed the hearing on charge framing against the accused, including BNP senior vicechairman Tarique Rahman.

Judge Shahed Nuruddin fixed January 4, 2012 for the next hearing.
