# SAYEDEE'S TRIAL Tribunal told of brutal torture

## Witness also recounts killing by Pak soldiers

Witness Mofizuddin Posbari yesterday told the International Crimes Tribunal that Jamaat-e-Islami leader Delawar Hossain Sayeede along with other collaborators had tortured him in a collaborators' camp at Parerhaat of Pirojpur in 1971.

The collaborators broke his finger, injured him on his legs, pelvis, and slammed him on the cement floor which left him with bloody lips and broken teeth, Mofizuddin said.

Mofizuddin Posbari, 72, made his deposition before the three-member tribunal led by its Chairman Justice Md Nizamul Huq. He is the seventh of the 68 prosecution witnesses scheduled to testify in a case against Sayeede regarding crimes against humanity committed during the Liberation War of 1971.

He also narrated how Pakistani soldiers shot Ibrahim Kutti on the Parerhaat Bridge after consulting with Sayeede. Mofiz's cousin, sixth prosecution witness Manik Posbari, had also narrated to the tribunal how Mofiz and Kutti were captured and how Kutti was killed.

"I heard a gunshot and Kutti screaming out 'maa' [mother] behind me. I looked back and saw that they had shot Kutti," he told the tribunal, "I was shivering in fear."

"I looked back again and saw the Pakistani soldiers kicking Kutti's body towards the canal."

Sayeede's counsels began cross-examining Mofiz yesterday. They will resume the cross-examination on Sunday.

## Congress fails to get anti-graft bill passed

### Rajya Sabha adjourned after heated debate; bill's future now uncertain

India's government and ruling Congress party failed to pass its proposed flagship anti-corruption law yesterday as the legislation stalled in the upper house of parliament.

The future of the bill is now uncertain, but will most likely have to be revised and again presented to lawmakers.

But yesterday's failure to pass it deals a bitter blow to Prime Minister Manmohan Singh's administration, which had to withdraw another major reform earlier this month allowing foreign supermarkets to operate in India.

"We are trying to our best to get the bill passed," claimed Parliamentary Affairs Minister Pawan Bansal in the final minutes of the debate, shortly before the speaker called an end to proceedings.

Opposition members in the upper

shouting and disorder after 14 hours of debate -- an ignominious end to an extended session of parliament called especially to pass the legislation.

### REMOVAL FROM GB Yunus seeks review of SC order

## Final report on transit by Jan 15

The government core committee on transit and transhipment will submit its final report within January 15, the committee chairman has said.

The committee, headed by Bangladesh Tariff Commission Chairman Mozibur Rahman, held a meeting at his office in the capital with other members and stakeholders to finalise the report yesterday.

After the meeting, Mozibur told journalists the committee held the meeting after the government sought 36 clarifications from it.

In the revised report, the committee kept both the options -- transit and transhipment -- open for the participating countries, he added.

"We can submit the report to the commerce ministry by January 15 as we are at the final stage now."

The tariff commission chief also said Bangladesh and India would both be benefited if transit and transhipment are allowed, because the Indian vehicles would have to pay fees and charges to Bangladesh for using the facility.

On the other hand, both the distance and cost in cargo carriage will reduce significantly if the Indian trucks,
