for comments, this correspondent could not get through Ghulam Arieff's mobile phone. However, BBC Bangla service reports that Arieff refused to comment on the matter.

Law Minister Shafique Ahmed, however, termed "illogical" the demand for Arieff's resignation.

"Those who are demanding the resignation of the chief prosecutor must have knowledge about the trial of crimes against humanity and the relevant laws. Such a call is not acceptable," he told The Daily

The call for his resignation comes just days after the International Crimes Tribunal sent the charges of crimes against humanity against former Jamaat-e-Islami Ameer Ghulam Azam and two other top Jamaat leaders back to the prosecution due to 'classification flaws".

On December 26, the ribunal refused to accept the charges against Ghulam Azam and ordered the prosecution to re-submit those in proper manner by January 5. Just two days later, it refused to consider charges against Muhammad Kamaruzzaman and Ali Ahsan Mohammad Mojaheed on the same ground and ordered the prosecution to re-submit those in orderly fashion by January 12 and 16 respectively. However, addressing the

discussion, Kabir yesterday said the government would have to take the responsibility if any of the war criminals escape punishment due to the "incompleteness and inexperience" of the tribunal. Projonmo '71, an organisa-

tion of the children of martyrs of the 1971 war, organised the discussion titled "Trial of war criminals and present perspective," marking the 40th anniversary of the independence of Bangladesh at Liberation War Museum in the capital. "Losing this case would

mean losing the Liberation War...a defeat for the entire nation and losing the meaning of independence just because of the callousness of a few lawyers.

"We cannot let this happen," said Kabir, a war veteran and an eminent writer.

The government has set up the tribunal but did not provide necessary logistic support to it, he said, adding that the tribunal cannot deliver without required support. He also urged the govern-

ment to set up more tribunals for trying the top war criminals within its tenure, which ends in early 2014.

"For now, three tribunals are needed in Dhaka and at divisional level if the government wants to complete trial of at least the top war criminals within 2013," he said.

Kabir said the statements of Ghulam Azam printed in the daily Sangram in 1971 are enough to try and punish him. The case of Ghulam Azam is easier than that of other Jamaat leaders, he added.

Captain (retd) AB Tajul Islam, state minister for Liberation War Affairs Ministry, said he himself was a victim of war crimes, his sister being violated on the night of March 25, 1971, in his presence.

He, however, said the government was working to expedite the trial and Prime Minister Sheikh Hasina herself is involved in it.

He said in a democratic society the lead drivers of change must be the elected political leadership.

The Centre for Policy Dialogue (CPD), Prothom Alo, The Daily Star, and Ain o Salish Kendra (ASK) jointly organised the event in the National Museum auditorium on the occasion of the 40th anniversary of Bangladesh's independence, with Sultana Kamal, executive director of ASK, in the chair.

Planning Minister Air Vice-marshal (retd) AK Khandker, and Nobel Laureate Amartya Sen spoke at the programme as chief and special guests respectively. Editor and Publisher of The Daily Star Mahfuz Anam, and Editor of Prothom Alo Matiur Rahman also spoke.

Prof Sobhan, also CPD chairman said, "We will need to invest in upgrading the skills and productivity of our farmers, artisans, our rural industries, our garment workers. We will need to give the deprived majority an investment state and price regime, which enables them to capture more of the gains from their labours and improved productiv-

He stressed the need for democratisation of the economic opportunities by providing resources to the deprived for acquiring productive assets like land, water, and technology -- so they may compete more equitably in the market place.

"Five million acres of khas assets, mostly under illicit occupation, needs to be recovered and distributed to the land poor," he

The noted economist pointed out that Bangladesh gained a lot in the last 40 years for which the people of the country should feel proud. "We have established a globally competitive garment industry moved ahead of India in particular areas of human development and gender parity.'

He said today Bangladesh is much less aid dependent with aid accounting for around 2 percent of the GDP. In the last decade Bangladesh moved from being an aid dependent to a trade dependent country, he said adding, at the time of liberation in 1971, Bangladesh's export volume was around \$500 million which is apparently \$25 billion

today, a fifty fold increase. Speaking about India-Bangladesh relations, Prof Sobhan, who was a close aide to Bangabandhu Sheikh Mujibur Rahman, said the country needs to develop a strategic vision for defining relations with India. "This relationship is too important to be kept hostage to the shifting sands of our party politics. Designing such a strategy demands a process of pub-

On the war crimes trials he said the trials should be held through due legal process so that the collaborators of the Pakistani occupation forces cannot claim political victimisation.

He also pointed out the people's unfulfilled expectations since the liberation of the country.

He said contrary to public aspirations, mass poverty has been perpetuated at an unacceptably high level over the 40 years since the independence, even though its percentage level has been reduced.

Politics of confrontation and intolerance appear to be once again permeating the country's political culture, he added.

"Our administration has become ineffective where both recruitment and advancement have been politicised and divorced from performance. Virtually all public services as well as law enforcement have become partisan and commoditised to a point where the machinery of government has lost virtually all capacity for functioning as an instrument of public service."

Even the last bastion of the rule of law, the judiciary is now under threat, said Prof Sobhan adding, the history of electoral politics in Bangladesh, going back to the period of Pakistani rule, indicates that in the absence of non-partisan caretaker government no incumbent government has ever vacated office through defeat at the polls.

The CPD chairman urged conscious citizens to join political parties to struggle for democratising the parties and establish accountability.

"If we wait upon our leaders to voluntarily make themselves more accountable we may wait for ever...many more citizens must seek this accountability more directly by joining political parties and participating in the struggle to democratise our political parities," he said.

"In the vacuum left by a non-performing parliament and a casualised civil society, full time terrorists and commercialised mastaans will continue to undermine the sustainability of the democratic process," Rehman Sobhan warned.

Salim, however, said the price could still be increased without a hearing as Berc has the power to do so through an interim order.

transport owners yesterday to discuss the matter, said the ministry's costing committee would prepare a list of hiked fare in the morning. "At 3:00pm, I will convey the decision on increased fares,' he said. Yet again, the govern-

ment on Thursday raised the prices of all fuel oils by Tk 5 per litre, the second time in less than two months and the third in less than four months. The energy ministry in an order increased diesel and

kerosene prices from Tk 56 to Tk 61 a litre, petrol from Tk 86 to Tk 91, octane from Tk 89 to Tk 94 and furnace oil from Tk 55 to Tk 60 a litre. It came into effect from Thursday midnight.

On November 10, the government raised the prices by Tk 5 a litre. Earlier in September, the price of furnace oil went up by Tk 8 a litre while the prices of kerosene, diesel, petrol and

octane by Tk 5 per litre. Quader, also a presidium member of the ruling Awami League, said the energy ministry did not notify the ministries of communications and commerce till Thursday evening about the

price hike decision. "If we were informed earlier, we could have coordinated well with the stakeholders," the minister added.
