Police Superintendent Sajjadur Rahman said on secret information, a patrol team of police arrested the duo while a gang of criminals with illegal arms were going to Pangsha upazila crossing the Gorai River at around 11 pm. Later, the law enforcers recovered two shutter guns from their possession.

BID TO OCCUPY GOVT EMPLOYEES' LAND

30 hurt as locals clash with cops in Rangpur town

At least 30 people were injured as locals clashed with police in Parjatan area of the district town yesterday afternoon.

Witnesses said about 300 people in the area have been using around one acre of land belonging to a housing society of class iii and class iv government employees as

playground and eidgah for six years.

Locals locked in an altercation with police and members of the housing society as they went to Parjatan area to take control of the land. At one stage, they swooped on police and the government employees.

Police clubbed the agita-

tors, fired 15 rounds of tear gas shells and eight rounds of rubber bullets, leaving at least 30 people injured.

"We went to take possession of our land on several occasions, but locals created obstacles in our way and drove us out from there, said Mostafa Kamal, a member of the housing society.

Class iii and class iv employees purchased the land from the government for a housing project six years ago, but locals have been using the land illegally, he added.

Of the injured, Joynal Hossain, 25, Abdus Sattar, 28, Sabuj Miah, 25, Firoj Ahmed, 30, and Akbar Ali, 29, were admitted to private clinics and hospitals while the rest given first aid.

Later, victim's brother filed a case against 14 people, including Posts and On December 29, the Telecommunications Minister Rajiuddin Ahmed Raju's brother Salauddin surrendered to the district Ahmed, as prime accused.

Affected people start 72-hr fast demanding full compensation

The land subsidence victims of 10 villages around Barapukuria Coal Mine Company Ltd (BCMCL) started a threeday fast yesterday demanding quick disbursement of the full amount of money granted under the authorities' compensation package.

"If our demands are not met within the three days, we will start a fast unto death on Thursday in front of the coal mine entrance," said Ibrahim Khalil, convener of Jibon O Shampad Rakkha Committee, an organisation of the affected people who enforced the programme.

Hundreds of land subsidence victims including a good number of women gathered in front of the BCMCL entrance and started their fasting programme at around 1:00am yesterday to realise their 10-point demand including early disbursement of the compensation money.

The victims said Dinajpur deputy commissioner's office received Tk 190 crore in April last year and started disbursement of cheques among the land subsidence victims on September 22 the same year.

But cheques worth only 40 percent of the money have been given to them so far while most of the people who received the cheques as compensation failed to collect the money from the respective banks as the cheques were returned, they victims alleged.

Other demands of the victims include preparation of a correct list of landless people of the affected area and giving every landless people their due money granted by the government. According to the compensation plan, each of the landless people is to get Tk 2 lakh as compensation.

The previous figure shows 318 landless people in the area but the affected villagers alleged harassment and commitment of faults by the surveyors while preparing the list. They demanded completion of

correct processing of papers in the affected area and administrative action against the surveyors who prepared 'faulty' survey list.

The villagers also warned that the deputy commissioner's office will be responsible if any unwanted accident occurs at the surrounding villages as due to non-payment of the compensation money the people have been living at their ancestral homes and working at the arable lands in the area that developed cracks due to land subsidence.

The land subsidence was first detected in May 2006.

The affected people also demanded the nine months' bank interest estimated Tk 15 crore as Tk 190 crore compensation has not been fully paid although the amount was sent to the DC office in April last year.

Md Belal Hossain, general secretary of Jibon O Shampad Rakkha Committee, demanded immediate disbursement of their remaining 60 per cent money and early payment of all compensations for damaged infrastructure including mosques, temple, graveyard, schools, colleges and madrasas. Commissioner's office. December 5 last year, they gave an ultimatum to meet their demands within December 25, but they are yet to get their compensation, said the affected people who have been agitat-

ing since 2009. When this correspondent contacted with Dinajpur Deputy Commissioner (DC) Md Jamal Uddin Ahmed at his office on November 16 last year, he said that the money would be disbursed within December 31. But the villagers have so far got cheques for only 40 per cent of the money.

DC Md Jamal Uddin Ahmed could not be contacted as he did not receive this correspondent's phone calls despite several attempts.

Scrutiny turns results upside down for dowry

Frustrated children accompanied by their guardians surrounded the Barisal deputy commissioner's office yesterday after revised admission test results of class-III (morning shift) of Barisal Government Girls' School showed 35 earlier allowed children as failed and 35 earlier failed ones as allowed.

The district administration declared the fresh admission test results yesterday, after scrutiny following serious complaints of irregularities regarding the admission test results announced on December 27.

After the revised result sheets were put up at Barisal Government Zila School campus at 11:00am under police and Rab protection, the 35 'frustrated' children

broke into tears, while their guardians became agitated.

They brought out a procession on city roads and later besieged Barisal DC office demanding a fresh admission test or maintaining the earlier declared results.

However the law enforcers moved them away from the spot.

Talking to journalists, the aggrieved guardians claimed that the district

administration and school managing committee in the name of re-scrutiny did more irregularities and victimised 35 children and their guardians.

They vowed to go to court against the decision of the district administration.

Barisal Deputy Commissioner SM Arifur Rahman said the problem was created due to fault during data entry of the result in the computer.

Following complaints of irregularities from many guardians, the district administration decided to rescrutinise the examination papers of class-III (morning shift) admission test of Barisal Government Girls' School and found that 35 children scoring 83-96 marks were declared as failed while 35 others scoring 5-20 declared as passed in the test.

"We decided to revise the result as there was mistake due to technical faults during data entry in computer," the DC said, adding, "We are transparent. Guardians are also allowed to check the examination papers by paying a fee of Tk 100 within seven days of publication of the result."

Woman murdered

Husband arrested

A woman was allegedly stabbed to death by her husband for dowry at Dhanua Kamalpur village under Bakshiganj upazila on Sunday night.

The deceased, Khuku Moni, 28, was wife of Noor-e- Alam at the village.

According to victim's sister Lovely Begum, Alam was a drug addict and he used to torture Khuku off and on for dowry. Although her parents gave Alam Tk 5 lakh as dowry by selling 4 bighas of land about a year ago, he put pressure on her for more money.

Khuku along with three daughters, came about a week ago, e-Alam.

Lovely said. On Saturday, Alam

somehow managed his wife and took back her to his house.

On the fateful night, the couple locked in an altercation over dowry. At one stage, Alam stabbed Khuku with a sharp knife, neighbours said, adding that they took Khuku to the upazila health complex where doctors declared her dead.

Neighbours caught Alam and handed him over to police.

Contacted, Bakshiganj police station officer in-charge (OC) Fazlul Karim said they recovered the body and sent it to Jamalpur Being disgusted, General Hospital morgue for autopsy.
