Call to ban coaching business

The system of coaching should be banned to help children develop the creative knack and to put an end to commercialisation of education, said academics.

The call comes as the education ministry is due to hold a crucial meeting on the "coaching business" of schoolteachers today.

The country's education system seems to have become inextricably intertwined with the practice of private coaching and tutorials, they said.

A section of teachers of prominent schools and colleges in Dhaka are making easy money out of this practice by shirking their classroom duties and creating situations where the students are forced to take tuitions beyond school hours, they added.

"Coaching becomes necessary because the teachers do not give proper attention and best output in the classroom, prompting the guardians to send their children to coaching centres in order to get good results," said noted educationist Prof Serajul Islam Choudhury.

"Coaching should be banned," he told The Daily Star.

Since the teachers earn huge money from coaching, they give extra care to the students here unlike in a classroom setting.

Private coaching makes the children much dependent on teachers, hampering their (children) creative faculty from flourishing, and creates a line of discrimination among the students coaching, said the ministry sources. as those coming from poor families cannot afford

A walk through the city found many walls covered with posters that claim of coaching service with guaranteed GPA-5 or A+ results for the students.

But, such guarantee is rarely shown by a teacher in classroom teaching.

Though the education ministry recognised this practice as a problem, it only responded formally by issuing a circular last August that stated that teachers can take an hour-long extra class for the weak students in exchange of Tk 175 per class.

lowed, said the teachers.

Later on September 14 last year, President Ziaul Kabir Dulu of Obhibhabok Oikya Forum, a platform of guardians, filed a writ petition with the High Court (HC) on the grave matter.

The HC, on October 17, issued a rule asking the government to explain why it should not be directed to stop the teachers working at coaching centres and why it should not be directed to enact a law in this regard.

Against this backdrop, the education ministry convenes a meeting to find out a way to stop

Representatives of the Cabinet Division, Prime

Minister's Office, Jatiya Sangsad Bhaban Secretariat, law ministry, home ministry, different directorates of education ministry and heads of 14 prominent schools in the capital will be attending the meeting today.

"We will take a decision about coaching after consulting with all stakeholders," said Education Secretary Dr Kamal Abdul Naser Chowdhury.

Prof Serajul said teachers try to substitute their poor remuneration at the schools by giving private tuitions.

The educationist suggested increasing teachers' salary and strengthening school monitoring mechanism to check whether teachers are delivering class lectures properly.

The petitioner Dulu said, "Additional classes can be taken for the weak students, but what we want is to stop the coaching business of teachers that are mushrooming the country." Manju Ara Begum, acting principal of

Viqarunnisa Noon School and College, said,

"Coaching should be stopped and, if the government formulates an act in this regard, we will follow that," she told The Daily Star yesterday. "Awareness of the guardians is a must. Without

solely depending on teachers, they will also have to monitor what their kids are learning from the classes," she said. Mohammad Azizul Islam, president of

Bangladesh Teachers Association, said the government must strive for improving classroom teaching and brining down the teacher student

Gallantry award for trying to save Bangabandhu

Assistant sub-inspector of police Siddiqur Rahman, who sacrificed his life for trying to save Bangabandhu Sheikh Mujibur Rahman on August 15, 1975, has been awarded the Bangladesh Police Medal for his outstanding act of bravery 36 years ago.

The recognition came at the annual PoliceWeek 2012, 36 years after the massacre at Dhanmondi house No. 32.

Siddiqur's son Mostafizur Rahman received the medal from Prime Minister Sheikh Hasina at the inaugural ceremony of the programme at Rajarbagh Police Lines.

Siddiqur Rahman, who was an ASI of Special Branch of police at that time, was discharging his duties as security in-charge at the entrance to Bangabandhu's house on the fateful night when some disgruntled army personnel killed Bangabandhu and 16 of his family members.

Apart from ASI Siddiqur Rahman, Colonel Jamil Uddin Ahmed and sepoy Shamsul Huq also sacrificed their lives trying to resist the assassins and save the Father of the Nation

Siddiqur remained deployed at the main gate of Bangabandhu's house.

and his family members.

Resisted, the killers sprayed bullets on Siddiqur to clear their way before raising hell inside the house. Bangabandhu's wife and three sons,

including eight-year-old Russell, were

among the victims. His daughters Sheikh

Hasina and Sheikh Rehana escaped the attack as they were abroad at the time. According to police sources, Siddiqur joined the police department as a constable

in 1971. His wife died in 1990 due to old age complications, leaving behind her two sons. Apart from ASI Siddiqur Rahman, 58 other personnel from police and Rapid

Action Battalion (Rab) were also awarded the Bangladesh Police Medal (BPM) and President Police Medal (PPM). Of the 59 personnel, 11 were awarded the

BPM and 48 the PPM. Among them, 20 personnel were awarded for their acts of bravery while the remaining 49 being honoured for their outstanding performance in combating crime.

66 BNP men get bail | Woman takes her life

Sixty-six BNP leaders and workers, including former lawmaker Ilias Ali, were granted two months' anticipatory bail yesterday in six separate cases in connection with the violence in Sylhet and Sirajganj on December 18.

All the accused, including Ilias Ali, appeared before a High Court bench seeking bail in the cases. The HC bench of Justice Salma Masud Chowdhury and

Justice Shahidul Karim granted the bail after hearing 10 separate bail petitions moved by the accused on January 1. The police filed five cases with different police stations in

Sylhet and another with a Sirajganj Police Station against them on December 18 last year following the incident of violence in the respective areas.

Barrister Mahbubuddin Khokon and some other pro-BNP lawyers appeared for the accused, while Deputy Attorney General Khandaker Diliruzzaman represented the government.

A housewife allegedly committed suicide in the city's Maniknagar Sabujbagh yesterday afternoon after her husband married for the second time.

Shimu Akhter, 27, wife of Ataur Rahman, owner of a rickshaw garage in the area, took poison at around 3.30pm.

Her brother Mohammad Ibrahim and neighbours took her to Dhaka Medical College Hospital (DMCH) where doctors declared her dead.

Ibrahim told reporters at DMCH that Shimu had a quarrel with Ataur after she recently came to know that her husband had married another woman about one year ago. They often were locked in squabbles after Shimu came

to know of her husband's second marriage. Ataur left the house yesterday afternoon after the quar-

rel and Shimu took poison. Ibrahim said Shimu hailed from Kaliakoir in Gazipur and he had come to Dhaka to solve the problem.


