# Usable bridge turns risky

Railings, girder walls broken down for new ones but further work remains suspended for 6 months due to 'non-allocation' of fund

People and vehicles cross the old bridge at Dhoail on Magura-Mohammadpur road, the only link between Mohammadpur upazila with the district headquarters, amid high risk as the railing and guard walls of the bridge were broken down about six months ago as preparation to construct a new one.

Meanwhile, works for the new bridge measuring 18 metres in length and 5.5 metres in width is yet to begin.

"Before breaking down of the railings and guard walls of the bridge, I did not feel any difficulty to run vehicles over it, but at present panic of accident seizes me whenever I cross it," said Shahabuddin, a truck driver.

guard walls, the bridge starts swinging whenever a vehicle crosses it," said Shahidul Islam, a government official who regularly travels to his working place at Magura from Mohammadpur upazila headquarters.

On May 25 this year, the

Roads and Highways Department (RHD) in Magura appointed Harunar-Rashid, a listed contractor in Magura, for constructing eight bridges including that at Dhoail on roads covering 58 kilometres from Magura Sadar upazila to Lohagara upazila in Narail district via Mohammadpur upazila headquarters, RHD sources said.

The cost for the eight bridges were estimated at Tk 4 crore 83 lakh 85 thousand and those were scheduled to be completed in 18 months from the work orders given, the sources added.

At first the contractor initiated work for the bridge at Dhoail and before start of the rainy season early June, workers appointed by him made a diversion road and broke down the railings and guard walls of the bridge as preparation to construct a new bridge there, said sources in RHD and locals.

But with the arrival of rains the diversion road was washed away by the strong current of the canal water under the bridge and the construction workers left the site, they said. The work has remained

halted since then.

Admitting the vulnerable condition of the bridge, Fayez Ahmed, subdivisional engineer (SDE) of RHD in Magura, said they would arrange 'decking system' on the bridge till construction of the diversion road there to facilitate

struction, the SDE requested this correspondent to talk to the contractor.

When contacted, contractor Harun-ar-Rashid said, "I had to stop the construction work due to unavailability of fund. Starting construction of the new bridge remains uncertain as the RHD is yet to allocate fund for it." He however assured repair of the diversion road within a couple of days.

Contacted over cell phone, Executive Engineer of Magura RHD Mohammad Shahjahan said, "We have already ordered the contractor to start the construction work of the bridge and it will begin within the shortest possible time."

#### Six NSTU students suspended

Six students of Noakhali Science and Technology University (NSTU) were yesterday suspended on charge of vandalising the administration building.

The university authorities took the decision on Monday night with Vice-Chancellor AKM Syedul Chowdhury in the chair.

The suspended students are Monjur Alam Mohsin and Tripati Chakma of computer science and telecommunications department, Anisul Islam Mahmud and Binoy Roy of fisheries and marine science department, and Mahmudur Rahman and Ameer Hamza Didar of applied chemistry and chemical engineering department.

The authorities served notices on the students yesterday morning.

On the night of January 1 Mohsin, one of the suspended students, requested the university authorities for the teacher's microbus to bring a student to the campus from the hospital. But the authorities could not provide him with the vehicle due to absence of its driver at that time.

A few minutes later, a group of students led by Mohsin ransacked some rooms at the administrative building and the microbus. They also misbehaved with some teachers of the university.

Police have been deployed on the campus to avert any untoward incident.

## UP chairmen lock UZ chairman's office

Eleven of the 14 union parishad (UP) chairmen in Shailkupa upazila under the district locked the upazila chairman's office yesterday following a conflict in distribution of wheat under Test Relief (TR) meant for development of rural infrastructure.

As upazila Chairman Nayeb Ali Joarder did not sign the official file of TR, the aggrieved UP chairmen locked his office at noon when he was not present there.

The chairmen alleged that Nayeb Ali Joarder claimed 3/4 tonnes from the wheat allotted for each union over mobile phone and threatened not to sign the TR file in case of failure.

"We failed to make upazila Chairman Nayeb Ali Joarder agree to sign the TR file even after making him aware that we had ensured different sections about the TR. Consequently, we got united and locked his office," said Mostafa Arif Reza Munnu, chairman of 9 No Monoharpur UP.

"In last October, TR wheat was allotted for the development of rural areas in the uapzila and a resolution regarding it was passed in a

monthly meeting of the upazila parishad on December 27. Later, the relevant file was sent to the upazila chairman's table but instead of signing it, he forwarded it to the office of project implementation officer of the upazila," said Tozammel Haq, chairman of 3 No Dignagar union parishad under Shailkupa upazila. Sabdar Hossain Mollah, chairman of 12

No Umedpur union parishad and president of Shailkupa upazila union parishad chairmen's association, said the upazila chairman's office will remain locked until the TR issue is solved. When contacted, upazila Chairman Nayeb Ali Joarder said, "I am an honest man.

People of Shailkupa know about me. I don't take any rice and wheat illegally." Asked why he did not sign the TR file, he said, "All the union parishad chairmen do not

implement the TR in village areas. They loot the allotment. So, I could not sign the file." Shailkupa Upazila Nirbahi Officer Azmal Haque said, "Nayeb Ali Joarder was present

at the December 27 meeting on TR. He knows very well why he did not sign the file."

## Two Jubo Dal men killed in Benapole, Bogra

Suspected killer of Natore Jubo Dal activist beaten to death

Two Jubo Dal men--one in Benapole and another in Bogra--were murdered yesterday and the day before. Our Benapole correspon-

dent reported that Patkahali union Jubo Dal general secretary Abdul Khalek, 46, was shot dead by his rivals in Dighirpar area under Benapole Port Police Station yesterday. Hasan Hafijur Rahman,

officer in-charge of Benapole Port Police Station, said Khalek was gunned down by his rivals while going to Benapole Bazar at noon. Police recovered the body

from the spot and sent it to Jessore Medical College Hospital morgue for autopsy. In Bogra, Jubo Dal activist

AKM Khalequzzaman, officer in-charge of Bogra Sadar Police Station, said the Jubo Dal activist was killed by his rivals as he had a feud with them over illegal sand business.

Jobo Dal Bogra district unit President Sefar Al Bakhtiar condemned the killing and demanded immediate arrest of the killers

According to our Natore

correspondent, a suspected killer Jubo Dal activist Shafiqul Islam Sabuj was beaten to death by a mob at Bingram Bazar in Singra upazila on Monday night.

The deceased, Ruhul Amin, 38, of Bingram village, was an accused in three murder cases, police said.

Faizur Rahman, officer in-charge of Singra Police Station, said a mob caught Amin and Babul Hossain, 50, two suspected killers of Sabuj, at the bazar at around 7:00pm. They beat them up mercilessly and later handed them over to the police.

Police took the seriously injured Amin and Babul Rajshahi Medical College and Hospital where Amin died at around 10:00pm.

Jubo Dal activist Sabuj was stabbed to death by a gang at Bingram Bottala village in Singra upazila on Saturday night.

### Over 300 illegal structures demolished in Satkhira
