US wants Grameen Bank to flourish

The United States wants Grameen Bank to continue to thrive in every possible way, as the Nobelwinning microfinance organisation is an example of extraordinary development work happening in Bangladesh, a visiting senior US official said yesterday.

"Many officials in our government have said that we hoped that it will continue to flourish in every possible way because the work that it does is very critically important", said Melanne Verveer, the US Ambassador-at-Large for Global Women's Issues.

"It is an example of the extraordinary development work that has been happening in Bangladesh", she said.

She was talking to reporters women, health, and education. during her visit to a Grameen Bank

centre at Singair, Manikganj along with US Congresswoman Betty McCollum and US Ambassador to Dhaka Dan Mozena.

During the nearly three-hour visit, the US diplomats talked to several Grameen Bank borrowers and listened how they are using the collateral-free loans to better their economic conditions. They also asked them how loans are given and repaid. They also visited their homes.

Both McCollum and Verveer, who arrived in Dhaka on Wednesday, are now in Bangladesh to meet with the representatives of the government, civil society, and community-based organisation involved in advancing the rights and well being of women and girls, and to promote US policy on

Extremist leader killed in gunfight

A leader of extremist outfit Gonomukti Fauj was killed during a "gunfight" between his team and the Rapid Action Battalion in Kushtia yesterday around 10:30pm.

The deceased, Motaleb Hossain, 45, son of Kutub Ali of Khoksha upazila, was accused in a number of cases, including five for murder. He was dodging a 10 years' jail sentence imposed by a Rajbari court.

Yesterday, two Rab teams went to Mokhlurchar area on information that Motaleb and his associates were preparing for a robbery, said Major Asad of Rab-12 in Kushtia.

Sensing their presence, the Gonomukti Fauj activists opened fire, prompting the elite force members to shoot back. After a short gunbattle, Rab found Motaleb lying dead. Other members of the outfit, however, had left the scene.

Rab recovered five light guns, a pistol, a revolver, 12 bullets, two hand bombs and two swords from the spot, Maj Asad told The Daily Star.

Timescale restored for pvt educational insts

The government yesterday restored timescales of teachers and employees and monthly pay order (MPO) of index-holders of private educational institutions which are entitled to get them.

Last year, the education ministry declared resuming timescale which was suspended for seven years. But, the ministry could not implement this announcement due to lack of fund, said ministry sources.

The government's stance on announcing the timescale and then snapping it sparked widespread resentment among teachers and employees. Finally the ministry yesterday restored the timescale

and MPOs to the private schools, colleges, madrasas and technical institutions, said a handout. Teachers and employees of a private secondary

school, college, madrasa and technical institution, which are getting MPO facilities, get timescale, a special scale, on completion of his eight years in teaching profession with fulfilling all professional eligibility.

According to the education ministry statistics, about 49,280 teachers and employees and 3,578 index-holding teachers are entitled to receive the MPO and timescale money.
