Attacking BJP, Rahul Gandhi yesterday said the opposition party is taking corrupt ministers thrown out by others and was running the "most corrupt" governments in states ruled

"Ministers are being removed and the BJP is taking them. They took

Babu Singh Kushwaha, who is the most corrupt minister. He is amongst the most corrupt ministers. BJP took a trip across India against corruption," he said in an apparent reference to LK Advani's rath yatra.

"But they run the most corrupt governments in Karnataka, Uttarakhand, Gujarat and Jharkhand and here (in UP) they have taken Babu Singh Kushwaha," he

On Saturday, Rahul had claimed that Kushwaha had approached Congress first after being sacked by Chief Minister Mayawati but his plea to join the party fold was turned down.

He also attacked Mayawati alleging that thousands of crores for MNREGA sent to Uttar Pradesh was eaten by the "magical elephant" sitting in Lucknow, in an obvious reference to BSP's election symbol.

"The magical elephant built by Mayawati is eating peo-



ple's money," he said.

BJP runs 'most corrupt' Journo killed as bus hits his bike turned left and came in front

Amader Shomoy. He quit the daily two months ago. He entered the profession in 1985 and worked in several daily and weekly publications before joining Amader Shomoy seven years ago, family members said.

His death comes just days after Nikhil Bhadra, a journalist of the Bangla daily Kaler Kantha, was badly injured when a BRTC bus ran him over in front of the Jatiya Press Club. Doctors had to amputate his right leg from the knee.

As news of Dinesh's death spread, more than 100 journalists took to the streets and blocked roads in the Press Club area, disrupting traffic on the Paltan to Kadam Phoara intersection for four hours from 1:30pm.

Bangladesh Federal Union of Journalists (BFUJ) and Dhaka Union of Journalists (DUJ) demanded punishment of the killer driver and compensation for the family of Dinesh.

Saiful Islam, a traffic constable who witnessed the accident, said the bus picked up high speed to pass

the intersection to avoid a red signal.

"Hit from behind, he [Dinesh] skidded around six yards with his bike. As he was trying to stand up, the rear wheels of the bus crushed his head, leaving him dead on the spot," Saiful told The Daily Star.

The traffic constable signalled for the bus to stop but it sped away. He then ran after it and managed to arrest the driver and one of his assistants and also seize the bus as it stopped at another signal a few yards away from the scene.

The bus was coming from Narayanganj carrying government staff.

Saiful said he was unsure if Dinesh was wearing the helmet, which was found on the spot intact.

Ramna police took driver Badsha Mia, 26, and his assistant Mahmudul Hasan, 16, into custody.

At the police station, Badsha told this correspondent he had tried to cross the Kakrail intersection to avoid a red signal. The bike was on his right then, but after crossing the signal the bike suddenly

of him. It happened so quickly that he could not control the steering, he claimed. Rafiqul Islam, officer-in-

charge of Ramna Police

Station, said Badsha initially denied that he was driving the bus when the accident happened but later admitted to doing so. All the passengers of the bus were staff of Trading Corporation of Bangladesh

(TCB). They did not cooperate with the police in identifying the bus driver, Rafigul added. Dinesh's body was first taken to Dhaka Reporters' Unity (DRU) where members of different organisations, including Crime Reporters' Association of Bangladesh

and Communist Party of

Bangladesh (CPB), observed

one minute's silence. Later, the body was taken to the Jatiya Press Club and then to his village home in Naogaon for cremation.

BFUJ, DUJ and DRU will form a human chain in front of the Press Club at around 11:00am today to protest the death and demand safer roads.

RIFT IN TIES

Congress reaches out to Mamata

A day after Pachimbanga Chief Minister Mamata Banerjee's attack, Congress yesterday reached out to its ally saying there was need for "better communication" with Trinamool Congress and the two could re-build trust by ironing out "disagreements" within closed doors.

Discounting the possibility of Mamata parting ways with Congress, senior party leader and Union Minister Salman Khurshid said there was no need to read too much into Mamata's statement that Congress was free to walk out of the ruling alliance in West Bengal. "I don't think we should read too much into these

things. I would certainly imagine if we can avoid them, good. Even if our disagreement we can put them across in closed doors.... I hope something like this will be worked out," he said.

He said there will be sometimes a mismatch in her expectations and mismatch in the Congress' responses "and sometimes a mismatch in answering to our constituencies." "I am sure that Mamataji also has expectations from people

who voted for her to change the ruling establishment in Bengal after such a long time. But again we are a national party and we have a lot of expectations that go beyond the concerns of only one state," he said. Khurshid asserted, "We all understand her concerns and I

am sure that she also understands our compulsions. I think its just need for better communications and there isn't lack of ability on both sides to be able to communicate. I am not going to believe that they can tempt her, any person like her into their fold," he said.

Congress-Trinamool Congress ties have been strained with the Congress' state unit vociferously protesting against Mamata's party. The latest issue involves the state government's move to rename Indira Bhavan in Kolkata which has been strongly opposed by the Congress leading to a confrontation between the two allies.

Hazare won't campaign against Congress

Amid talks of the Jan Lokpal movement being directionless, anti-corruption activist Anna Hazare yesterday stated that he will not be undertaking the tour to campaign against the Congress in the five poll bound states because of his weak health.

Addressing reporters after being discharged from Pune's Sancheti Hospital yesterday morning, Hazare reiterated, however, that his fight against graft will continue. Self-immolation

"I will not be going on the tour of the five states, as the doctors have advised me against it," he said. The development could cloud the anti-corruption movement, even as the core committee is meeting in New Delhi over the weekend to chalk out the future strategy.

Asked about the future of the movement, Hazare said, "It is not a fight that will last just for a couple of months; it will go on for years. I have been fighting against corruption for twenty five years. The struggle will continue once I get better."

Sayedee ordered torching houses

Savedee's order, said Bashudeb Mistri, the tenth witness. The collaborators then torched the houses of Manik Poshari, a fish trader of Pirojpur's Chithalia village.

The three-member tribunal finished recording the deposition and crossexamination of Bashudeb yesterday.

Bashudeb is the 10th out of 68 prosecution witnesses in the case filed against Delawar Hossain Sayedee in connection with crimes against humanity during the 1971 war.

Sayedee, nayeb-e-ameer of Jamaat-e-Islami, is among five Jamaat and two BNP leaders who are facing war crimes charges at the tribunal.

Bashudeb Mistri, who was 13-14 years old during the war, began his testimony around 10:50am. He said he used to work as an assistant to his

carpenter father and they were working at Manik Poshari's houseduring the war.

the Pakistani soldiers reached Parerhaat some two or three months after the war began. They set up a camp in Parerhaat and they used to patrol the area. Shanti Committee

(Peace Committee) and Razakar Bahini (collaborators) were set up with Dilu Shikdar (now known as Delawar Hossain Sayedee), Sekander Sikder, Danesh Mollah and Moslem Moulana along with other Razakars in the Parerhaat area, he said.

On May 8, 1971, the collaborators and the Pakistani soldiers went to Manik Poshari's house. Sensing their arrival, family members of Manik Poshari fled.

Bashar, 21, is the finance wing chief and also a Majlish-e-Sura member of the JMB, and his accomplice is identified as Mohammad Abdul Alim, 23, who is an Ehsar member of the banned Islamist outfit, Rab said.

Hailing from Khojargaon village under Bahubal upazila in Habiganj, Bashar and Alim of Ashulia Barapara village in Dhamrai of Manikganj were arrested from their hideout in Achintola Bahrampur village under Rajpara Police Station in Rajshahi in the early hours.

According to Rab officials, Bashar is a fugitive accused in an explosives case with the capital's Sabujbagh Police Station in 2009 while Alim is a fugitive convict in another explosives case with Manikganj Rab intelligence officials police in 2005.

JMB chief Saidur Rahman was arrested along with one of his wives and three other top leaders of the JMB on May 25 last year in the capital. Saidur's another son, KHM Shamim, who was the chief of JMB's IT wing and elder brother of Bashar, was arrested in 2006.

Saidur took over as the JMB chief in February 2006, shortly after the arrest of Shaekh Abdur Rahman, the then JMB supremo.

After their arrest in Rajshahi, both Bashar and Alim were brought to Dhaka and a press briefing was held at the Rab headquarters in Uttara. Rab's Legal Wing Director Commander M Sohail said all the family members of Saidur were active leaders of the banned organisation.
