33 fishermen abducted from Sundarbans in two days

Law enforcers rescue 7 after gunfight with robbers

Seven of the 33 fishermen, abducted from the Sundarbans on Friday and Saturday, were rescued after a gunfight between law enforcers and robbers yesterday.

However, there was no report of casualty in the gunfight, which lasted one and a half hours.

M Saidur Rahman, commander of Coastguards (Mongla West Zone), told UNB that a joint team of Rab and coastguards raided different points of the Sundarbans yesterday to rescue kidnapped fishermen.

Sensing the presence of Rab and coastguard members at Chandershar at noon, the robbers opened fire on them, prompting the law enforcers to retaliate. At one stage, the robbers

fled the scene. Later, the elite force and coastguards rescued the fishermen from the den of infamous 'Jihad Bahini'. They also detected five dens of the gang in the

On Friday, Shohag 'Bahini' of the Sundarbans picked up eight fishermen at gunpoint from Harmal Canal in the eastern part of the mangrove forest under Sharankhola upazila of Bagerhat district, reports our staff are going on. correspondent.

The gang looted valuables, including fishing nets, fish and crabs worth about Tk 50,000, from the fishermen and demanded a ransom of Tk 50,000 for each of the fishermen, he added.

The deputy ranger further said the kidnappers threatened to kill all the eight fishermen in case of their failure to pay ransom by Wednesday.

On Saturday, robbers belonging to infamous 'Jihad Bahini' kidnapped 25 fishermen for ransom from Gangrain around 7:30 pm. area near the Bay of Bengal.

They also took away fishing nets, fish and money from fishermen of 50 trawlers during the attack.

Mihir Kumar, divisional forest officer (DFO east) of the Sundarban Forest Division, said 'Jihad Bahini' have demanded a ransom of Tk one lakh for each of the 25 fishermen who names could not be known, hail all hail from Rayenda and Mohipur guards of Kadamtala and Dobeki forest from different areas of Bagerhat under Sharankhola upazila of stations rushed to Klairchar area and

Contacted, Md Hasanuzzaman, Operation Officer of Coastgaurds Mongla West Zone, said drives to rescue the kidnapped fisherman and arrest the members of the two gangs

Meanwhile, a forest officer was injured in an attack by a gang of robbers in Kalirchar area of the Sundarbans on Saturday night.

The injured officer, Abdur Rashid of Dobeki forest outpost, was admitted to Khulna 250-bed hospital in a critical condition.

Forest department sources said Abdur Rashid and two forest guards--BM Zaman and Md Asadwere patrolling the forest area in an engine boat at

As they reached Kalirchar area at around 8:00pm, the robbers attacked the boat. Sensing the presence of the robbers, BM Zaman and Md Asad left the scene, leaving Abdur Rashid there.

The pirates dragged Rashid into the forest, hit him with sharp weapons and left the scene.

Being informed, forest officers and rescued Rashid in a critical condition.

Rivals set 7 houses afire in Natore

Criminals set fire to seven houses on a disputed land at Palohara village in Lalpur upazila under Natore on Saturday night.

At around 11:pm, a group of people led by Abdul Alim of the village and his 10 to 12 accomplices, set fire to the houses and beat up the members, leaving at least 12 people injured, witnesses said, adding that at one stage people from nearby areas chased the gang away. Three of the injured were

admitted to Rajshahi Medical College and Hospital while the rest were admitted to different local clinics and hospitals.

Locals said, there was a

previous enmity between Abu Bakkar and Abdul Alim as Alim demanded Tk 1.5 lakh as illegal toll from Bakkar.

Additional Superintendent of Police in Natore Saifuzzaman Faruki said members of both the groups are accused in several arms cases.

Asked about the incident, Abdul Alim said, "I never demanded any illegal toll from Abu Bakkar. Bakkar and his men made an attack on Friday night and injured me and my bother Moslem Uddin. After hearing the incident my supporters became agitated and attacked Abu Bakkar but they did not set fire to their houses."

Robbers kill ex-PTI superintendent

Robbers strangled former superintendent of Thakurgoan Primary Training Institute (PTI) while committing robbery at her Asrampara house in the district town yesterday, police said.

The deceased, Umme Kulsum,60, was wife of former president of Thakurgaon Bar Association advocate Bodiuzzaman Badal.

Thakurgaon Police Station officer in-charge (OC) Gopal Chakraborty, quoting Kulsum's husband, said advocate Badal left the house at about 10:00am keeping his wife alone. At about 11:00 am he repeatedly made phone calls to her wife through his cellphone, but she did not respond. He visited the house.

hurriedly rushed to the house and found his wife lying on the floor.

Badal along with his neighbours rushed Kulsum to Thakurgoan Sadar Hospital where the on-duty doctor declared her dead. Robbers looted valuables

COLLEGE TEACHER MIZANUR MURDER CASE

Two more PWs give deposition in court

The Speedy Trial Tribunal, Rajshahi, yesterday recorded statements of two more prosecution witnesses (PWs) in Natore college teacher Mizanur Rashid murder case.

According to their statements, two accused--Abdul Awal Rajon and Mamunur Rashid Asiframmed their motorbike into Mizanur Rashid, a chemistry teacher of Lokmanpur College in Bagatipara upazila under Natore district, and beat him up with iron rods on October 12 in 2010.

The PWs are Prodip Biswas, a lecturer of DMCH, and Sub-Inspector (SI)

Abdur Rahim of Bagatipara Police Station.

Mizanur succumbed to his injuries at Dhaka Medical College and Hospital (DMCH) on October 24 the same year.

The attack was a sequel to protest by Mizanur for stalking two female students of the college Bobita and Lip--by the accused, the PWs said in their statements.

The tribunal has sa far recorded statements of 20 out of a total 30 prosecution witnesses in the case.

The tribunal Judge **Ekramul Haque Chowdhury** fixed January 15 for hearing statements of the two accused in the case.

Easy bike driver murdered

Police recovered the body of an easy bike driver from a roadside ditch beside Jessore-Narail highway yesterday, two days after he went missing. Kidnappers might have strangled Sumon Karmakar, 16, son of Sonaton Karmakar of Mohiskhola village in Narail municipality area, as his hands and legs were tied, said police. Family members said Sumon came out with the easy bike on Friday and did not return home. Locals found the body floating on the ditch at about 4:00pm and informed the police. Later, the law enforcers recovered the body and sent it to Narail Sadar Hospital morgue for autopsy. Ataur Rahman, subinspector of Narail Sadar Police Station, suspected that the gang killed the victim to take away his vehicle.

3 Jatra artistes jailed

A mobile court sentenced three female Jatra artistes to three months' imprisonment for performing obscene dance at a fair at Ranihati in Shibganj upazila early Saturday. The convicts are Miniara, 23, Ruma, 20, and Mukta, 21, of Jatra group, Challenger. On secret information, the court led by Executive Magistrate Subrata Paul raided the fair at about 12:10am, arrested the trio while performing obscene dance in the name of Jatra (open air drama) and penalised them.

Convicted prisoner dies

A convicted prisoner of the district jail died of cardiac arrest at Khulna Medical College Hospital yesterday morning. The deceased was identified as Abdul Aziz, 55, son of late Azhar Howlader of Bharaiya in Rajapur upazila of Jhalakati district, says a press release signed by the jail authority. Aziz was admitted to the hospital on Saturday evening after he complained of chest pain. He was awarded life imprisonment in a murder case on August 29, 1996. Aziz was shifted to the district jail from Barisal Central Jail in 2009. The body was handed over to his family members after autopsy.

Woman found dead

Police recovered the body of a woman, Momena, 55, from her house at Falia Dighar village in Saghata upazila yesterday morning. District Police Superintendent Basu Deb Banik said victim's grand-daughter saw her body at the house and called neighbours. Later, local people informed the police. The law enforcers recovered the body and sent it to Gaibandha Adhunik Hospital morgue for autopsy. Police said that criminals might have stabbed her dead following a previous enmity.

Man held with fake notes

Police arrested a man along with some fake Bangladeshi and Indian currency notes from Kathaldangi Bazar in Horipur upazila early yesterday. The arrestee is Dobir Uddin, 52, son of Abdul Gafur of Kathaldangi village. Abdus Salam Mia, officer in-charge of Horipur Police Station, said Dobir after purchasing some goods from a grocery shop gave a note of Tk 1,000 to the shop owner. Finding the note fake the shop owner informed the police who rushed to the spot and arrested Dobir. After searching his body, the law enforcers recovered 12 Indian fake notes and 16 Bangladeshi notes of Tk 1000.

Drug peddler jailed

A mobile court here yesterday sentenced a drug peddler to one month imprisonment for possessing a huge quantity of hemps. The convict is Md Shariful Hasan, 25, son of Azgar Ali of Ghasipara in Dinajpur municipality area. Police said the court led by Executive Magistrate Md Abdur Rahman raided the area, arrested Shariful along with the hemp and handed down the verdict. Meanwhile, members of Rapid Action Battalion (Rab) arrested two people along with 98 pieces of Yaba tablets from a residential hotel in Hilly port area under Hakimpur upazila of the district yesterday. The arrestees are Atwar Hossain and Ahad Ali of Sadar upazila. Police said acting on a tip-off, a team of Rab-5 in Rangpur raided the hotel and arrested the duo along with the tablets.

17 injured in clash

Supporters of Hye and Fazlur equipped with lethal weapons attacked each other, leaving at least 17 from both sides injured yesterday morning.
