# Ctg commuters bear the brunt

Road march leads to transport crisis in city

Normality in Chittagong city was disrupted yesterday during the opposition's rally followed by a road march when commuters had to suffer due to lack of public transport.

People having tasks outside were seen stranded for hours and walking helplessly since there were only a few public buses on the roads. The number of rickshaws was also

Meanwhile, fearing trouble, many guardians did not let their children go to schools.

Talking to The Daily Star, Abul Kalam Azad, adviser of District Public Transport Owners' Group, said over 200 city buses were hired for the BNP rally. So there were very few buses on the streets.

Chittagong Metropolitan Rickshaw Malik-Chalak Oikya Parishad President MA Quader said, "May be the drivers and the owners had kept their rickshaws off the roads for safety reasons."

He, however, said no instructions were given to stop plying of rickshaws.

Supporters of the main opposition, Jamaat-e-Islami and Islami Chhatra Shibir started flocking to Polo Ground in Tiger Pass area since morning. Traffic movement was barred on the streets around the ground for the rally that began around 3:30pm and continued till 6:00pm.

Second year student of Chittagong Metropolitan Commerce College Shabab Bin Jahangir along with his friends was wait-

ing for rickshaw for over an hour and a half at around 2:30 pm after the college hours in Jamal Khan area to go to his residence at Nasirabad.

Like Shabab, most of the city dwellers who came out for daily work, faced immense sufferings as there were very few rickshaws and other public transport due to the BNP's programme.

"I came to college though my father forbade me," Shabab said adding that only 10 students were present in his class while around 60 to 70 students usually remain present.

Safa, another student of the college, said their institute was declared closed for the day one hour earlier as many teachers remained absent. Hasmat Jahan, headmistress of Khastagir

Govt Girls High School, told The Daily Star that the students' presence was poor in her institution due to the road march. "In the morning-shift, around 600 stu-

dents were present and 450 in the day-shift whereas about 800 to 900 students attend classes every day in each shift," she said.

"Perhaps, guardians forced them to stay at home in fear of unpleasant occurrence, the head teacher said.

Prof Shekhar Dastidar, principal of Chittagong College, said admission and other administrative and academic activities were normal, though attendance of students was slightly low.

He said Imtiaz is under going treatment at a hospital for injuries to his leg and would be produced before a court after recovery.

Contacted over phone, former vice-chancellor of the university Anwara Begum, also the wife of former president and mother of Imtiaz, refuted the allegations against her son.

STUDENT ABUSE CASE Arrest orders

#### against two VNS teachers examinations.

A Dhaka court yesterday issued arrest warrants against Husne Ara Begum, former principal of Vigarunnisa Noon School and College and the institution's Bashundhara branchin-charge Lutfur Rahman in connection with violation of a female student last year.

Judge Mohammad Arifur Rahman of the Fourth Special Tribunal for Prevention of Women and Children Repression passed the order and asked officersin-charge of Ramna and Badda police stations to submit reports before the court by February 9 after complying with the order.

On July 5 last year, the victim's father filed the case against the two and Porimol Joydhor, a sacked teacher of the school's branch on Bashundhara campus.

According to case statement, Porimol was accused of violating the student twice at his coaching centre in Badda, on May 28 and on June 17.

Husne Ara and Lutfur were accused of trying to cover up the incident and delaying to take action against Porimol.

On August 11 last year, Shahadat Hossain, officer-incharge (investigation) of Badda Police Station, submitted a charge sheet of the case before the court accusing only Porimol and dropped the names of other two, as their involvement with the case was not found.

Later the case was shifted to the Detective Branch (DB) of police following a noconfidence (naraji) petition and on November 11, DB submitted another probe report again accusing only Porimol. However, the court yester-

day accepted the charges against Husne Ara and Lutfur as it found allegations against them were authentic. Porimol, who was detained

earlier, was produced before the court during the hearing.

Porimol was arrested on July 6 and five days later he confessed before a court to violating his student.

On the country's economy, he said, "We cannot but admit that economy is now under pressure. Taka is being devalued day by day discouraging investment in the country. The government has to take out loans from the central bank to tackle the pressure.

"In this condition, the committee asked the government to stop all sorts of unnecessary expenditure and collect money from international sources instead of local banks."

Mostafa, also a ruling Awami League lawmaker, said they had advised the government to reduce inflation.

"We had invited noted economists in the country to the meeting and they have advised the government to stop unnecessary expenditures," he added.

Mostafa also said the committee had asked the government to enhance foreign funded development projects to increase the flow of foreign

currency in the country. "There is around \$12 billion foreign aid in the pipeline for disbursement. The government should take necessary steps to get the foreign

He said the country's imports were growing faster than exports, putting pressures on the exchange rate.

Talking to The Daily Star, AB Mirza M Azizul Islam said the government must increase its revenue income to cut the budget deficit as well as unnecessary expenditure.

Akbar Ali Khan said, "The government will have to take firm steps right now to control inflation. Otherwise it would be hard for the government to control inflation after six months."

Debapriya Bhattacharya of CPD said, "The country needs a stronger macroeconomic management system. We need to cut down on expenditures and attract more foreign funds."

The economists called upon the government to take unpopular decisions if necessary for the sake of the country's economy.

to Dhaka after the Chittagong rally.

Earlier, Khaleda led three road marches towards Sylhet, Chapainawabganj and Khulna to draw public support for her party's demand for reinstating the caretaker government system.

The government scrapped the system last year through the fifteenth amendment to the constitution, allowing an elected government to hold parliamentary polls.

BNP and its allies had opposed the amendment, and now maintain they will not go to polls unless held under a non-party caretaker government.

months' confinement in a Pakistan jail. The political icon termed his homecoming "a journey from the darkness to light".

The Pakistan occupation forces arrested the architect of the country's independence on March 25, 1971 at his Dhanmondi residence during the late-night crackdown on the people of Bangladesh (then East Pakistan) and sent him to then West Pakistan.

Bangabandhu had become the undisputed leader of the then Pakistan through a landslide victory of his party Awami League in the 1970 general elections.

The Pakistani junta was compelled to free Bangabandhu after Bangladesh earned independence on December 16, 1971 through a nine-monthlong war.

Awami League (AL) and different organisations have chalked out elaborate programmes marking the day. The programmes include hoisting of the national and party flags at all AL offices across the country, milad mehfil (prayers) and discussions. A discussion on the glori-

ous political life o Bangabandhu and a milad mehfil will be held in Bangabandhu International Conference Centre at 3:00 pm. Prime Minister Sheikh Hasina will address the discussion as the chief guest.

Leaders of AL and its associate organisations will lay wreaths at Sheikh Mujibur Rahman's portrait in Bangabandhu Memorial Museum on Road-32 in Dhanmondi at 7:00am.

AL leaders will also place wreaths at the grave of the Father of the Nation in Tungipara, Gopalganj. A milad mehfil will also be held there.
